NEWS - four issues

QFHSA 61st ANNUAL GENERAL MEETING, APRIL 23, 2005 BUSINESS MEETING PROCEDURE

- The Annual General Meeting [AGM] is conducted in accordance with our Constitution, By-Laws and Standing Rules. In the case of any procedural dispute reference shall be made to Robert's Rules of Order Revised.
- 2. Each official voting delegate of each Member Association shall have one vote on any question which comes before the meeting, except for associations more than 250 kilometers from Montreal. Such Associations will still be entitled to three votes, expressed either as an identical or divided vote. Application for such privilege is to be presented in writing to the Executive Secretary prior to the start of the business portion of the Annual General Meeting.
- 3. The quorum for transaction of business at the Annual General Meeting shall be twenty-five percent [25%] of Member Associations in good standing, represented by their official representatives or accredited alternates.
- 4. Voting shall be by ballot or show of hands. All questions shall be decided by a majority of those present and entitled to vote, except those which require a two-thirds [2/3] majority. On ballot votes, the votes of each association shall be handed in by the voting delegates of each association individually but at the same time. Counting of the votes shall be done by non-voting participants.
- 5. A delegate may not speak for more than two [2] minutes on any question under discussion, nor more than twice on any particular motion or resolution. Any person wishing to speak needs to stand and come to the microphone (if we have one).
- 6. Amendments to the Constitution and By-Laws require a two-thirds [2/3] vote of the delegates present and entitled to vote. Notice of the proposed amendments must have been mailed to all Member Associations at least ten [10] weeks prior to the meeting. Modifications to these proposed amendments received two [2] weeks before the AGM will be considered, but no modification may be made from the floor.
- 7. Resolutions to the Annual General Meeting must have been circulated to the Member Associations eight [8] weeks prior to the Annual General Meeting. Resolutions received after the date specified will be presented as Emergency Resolutions only after consideration by the Chairman of the meeting and the Resolutions Committee. Delegates presenting resolutions are reminded that they must be present at the time designated on the agenda for the presentation of their resolution. The presenting party may speak to the resolution, or amendments thereto, for not more than FIVE [5] minutes. In addition to amendments received two weeks before the AGM there may be amendments emanating from the caucus session held earlier, but no further amendments may be made from the floor.

PARLIAMENTARY PROCEDURE

PRINCIPLES

- Justice and Courtesy for all
- One thing at a time
- Recognition of the will of the majority
- Protection of the rights of the minority

PURPOSE

✓ To conduct business in an orderly and democratic manner by one or more of the following ways: ✓ communications

✓ committee reports

✓ motions or resolutions

To participate effectively in the proceedings of meetings, each person needs to know the fundamentals of parliamentary procedure.

THE MAIN MOTION

WHAT IS A MOTION?

A main motion introduces a new item of business; it is a proposal that the group take a certain action. It is the basis of all discussion and states the bounds of discussion. All remarks pertain directly to the contents of the motion on the floor. The making of the motion comes first, discussion follows. A subsidiary motion qualifies the main motion or proposes an alternate timetable for consideration.

WHEN IS A MOTION NEEDED?

- It forms a basis for discussion on all major decisions of the group.
- When in doubt, ask for a motion to be proposed.
- Motions must be made on all matters involving <u>finances</u> not already included in the budget as approved.
- On minor matters, a question may be resolved by the chairman 'taking the sense of the meeting'.
- The decision must be clearly stated for the secretary to report in the minutes as well as for the benefit of the members.

THE STEPS TO PRESENTING A MOTION ARE:

- member stands or raises a hand and says:
 - "Madame Chairman/Mr. Chairman."

The chairman recognizes the speaker by name.

- 2. The member says, "I move that . . . ", stating or reading a motion.
- 3. Another raises a hand to be identified by the chairman, then says:
 - "I second the motion." The seconder believes the motion should be discussed, but may not necessarily be in favour of it.
- The mover usually speaks first, giving the reasons for the motion. The opportunity to speak to the motion must be given to anyone who wishes to speak to or oppose the motion. Discussion should be addressed to the chairman.
- 6. At the end of the discussion, the chairman says:
 - "If there is no further discussion " or "Are you ready for the question?" Then:
 - "The motion is that "
 - "All in favour?" (pause while the count is taken by the secretary)
 - "Opposed?" (pause while the count is taken by the secretary)

- "Abstentions?" (pause while the count is taken by the secretary)
 "The motion is carried" (or is defeated).
- 7. If anyone calls "Division" (questions the voice vote), the chair calls for a show of hands or a standing vote: "All in favour raise your hand. All opposed..." If a majority request it, the vote may be taken by ballot. A "ballot vote" is the recommended procedure for election of officers and for resolving a contentious issue.

SUBSIDIARY MOTIONS

AMENDMENTS CHANGE MOTIONS: To qualify the idea of a motion, but not to change the subject or the intent of the main motion.

1. "I move to amend the motion by ":

Inserting or adding a word, phrase or sentence.

Striking out a word, phrase or sentence.

Striking out and inserting a word or phrase or substituting a sentence or paragraph.

- 2. "I second the motion to amend."
- 3. "It has been proposed to amend the motion to read as follows "

 The chairman states the main motion and the amendment so the group will understand how the amendment changes the motion. Amendment is handled in the same way as a motion with:

Discussion: "Is there any discussion?"

Question: "If there is no further discussion, the amendment is "

Vote: "All in favour of the amendment "

Chairman announces the outcome:

"The amendment is carried (or defeated)."
"The motion now before the meeting is "

(states the motion plus the amendment(s) if it carried)

In dealing with motions, the vote is taken first on the amendment. If passed, the amended motion is voted on. If the amendment is defeated, the main motion in its original form is voted on.

TO REFER: A question is referred to committee for further study and to submit a recommendation to the group at a later time.

TO TABLE: To set the matter aside until someone moves to reconsider it.

TO POSTPONE DEFINITELY: Postpone discussion until more facts are available. **TO POSTPONE INDEFINITELY:** The motion may not be considered again that year.

Susan Tweddell, President, chaired the meeting. She welcomed everyone and introduced those at the Head Table: Anne MacWhirter, Executive Vice-President, Time Keeper; Sylvia Adams, Past-President of QFHSA and of Canadian Home & School Federation, serving as Parliamentarian; Carol Ohlin, Recording Secretary; Brian Rock, Vice-President, Speakers List.

The remaining Directors were also presented to the delegates: Michelle Armstrong, Connie De Giorgio, Olav Kappert, Donna Norris, Brenda McGill, and Norma Stirling. [Directors Margaret Funnell, Ron D'Souza and Helen Koeppe were not present.] Donna Sauriol, Executive Secretary and the 2004 recipient of the Leslie N. Buzzell Award, was recognized. The President welcomed guest Bradley Bos, Advisor, Official Languages Support Programs, Canadian Heritage. The greetings message from Sylvia Dyck, President of Canadian Home and School Federation, was read.

Newsletter Prizes were presented by Diane Radu, Editor of QFHSA NEWS Focus on the Locals section. Membership prizes were presented by Donna Norris, Membership Chair. Terry Gagnon, a teacher and a voting delegate from Westwood High School (Junior Campus), was presented with the special Teacher Draw prize.

The President briefly explained the contents of the delegates' kits. She called special attention to Emergency Resolution 2004/05E; the AGM Evaluation & Volunteer Form; the Reaffirmation of Membership and Executive Committee List 2004/05for local associations; the notice to all associations to submit an Activity Report and a Financial Report to QFHSA by July 1.

5. LIABILITY INSURANCE & STUDENT ACCIDENT INSURANCE REPORTS

Anne MacWhirter, Executive Vice-President, chaired the meeting while the President spoke to the Liability Insurance Report. Jim Stirling, Vice-President of B.F. Lorenzetti, was present as a resource person. The Liability Insurance policy has been a major concern this year. The coverage for Directors and Officers and Commercial General Liability is usually adequate for most Home and School activities. Other activities such as day care programs and extracurricular activities require additional coverage. All sports activities are excluded from coverage. In addition, the cost increased significantly for the policy renewal from

December 1, 2003 to November 30, 2004. This has necessitated a proposed increased family membership fee from \$15 to \$16.

The coverage provided by our insurance broker, B.F. Lorenzetti, is adequate for most local associations. Those who wish to pursue activities excluded from our policy should seek additional coverage to meet their needs.

Highlights of 2004

1. At out 2004 Annual General Meeting we started our yearlong celebration of our 60th year as the Quebec Federation of the Home and School Associations. Many special guests attended the Awards Dinner on April 22nd. Her Excellency, the Lieutenant Governor of Quebec, The Honourable Lise Thibault gave a lovely speech and presented QFHSA with a recognition award. The Minister of Education, Pierre Reid, spoke of the importance of the role of parents and volunteers in the schools. Assistant Deputy Minister, Noel Burke; Martin Murphy, President of the Quebec Community Groups Network and many past Presidents of QFHSA attended as well. It was a memorable evening for all.

AUDITORS' REPORT

To the Members of QUEBEC FEDERATION OF HOME AND SCHOOL ASSOCIATIONS

In common with many charitable organizations, the Association derives revenues and contributions from various sources, the completeness of the non-government revenue and contributions are not susceptible to complete audit verification. Accordingly, our verification of these revenues was limited to the amounts recorded in the records of the Association and we were not able to determine whether any adjustments might be necessary to revenues and net assets.

In our opinion, except for the effect of adjustments, if any, which we might have determined to be necessary had we been able to satisfy ourselves concerning the completeness of the non-government revenues and contributions referred to in the preceding paragraph, these financial statements present fairly, in all material respects, the financial position of the Association as at December 31, 2004, and the results of its operations and its cash flow for the year then ended in accordance with Canadian generally accepted accounting principles.

NOTES TO FINANCIAL STATEMENTS

AS AT DECEMBER 31, 2004

1. NATURE AND PURPOSE OF THE ASSOCIATION

The Quebec Federation of Home and School Associations is an incorporated, independent, notfor-profit volunteer organization dedicated to enhancing the education and general well being of children and youth. It promotes the involvement of parents, students, educators and the community at large in the advancement of learning and acts as a voice for parents.

2. ACCOUNTING POLICIES

a) Revenue Recognition

The Quebec Federation of Home and School Associations follows the deferral method of accounting for program and history and archive grant and membership fees.

Membership fees are received mostly in the fall of each year and are taken in revenue over the period from September to the following August.

Program funding and grants are received from Federal and Provincial agencies for various donor fiscal years and are taken into revenue over each donor's fiscal year.

History and archive grant revenue is recognized to the cost which is expensed in any given year.

b) Expensing Capital Purchases

The Association expenses all purchases of a capital nature.

c) Contributed Services

Volunteers at the Federation level contribute approximately 14,700 hours per year to assist the Federation in carrying out its activities. Because of the difficulty in determining their fair value, contributed services are not recognized in the financial statements.

3. FUNDS HELD IN TRUST

The Association has funds in trust amounting to \$5,000 which represents the original contributions made by three donors, who requested that the interest earned on the funds in trust be used to pay for awards given out at the annual general meeting. A committee is appointed to consider all submissions for the awards, and to choose the ones, they consider best, meet the guidelines.

To kick off the 2004-2005 school year, the committee put forth two initiatives to the locals:


- 1. <u>Community Involvement</u>. Each local was encouraged to make a donation in their local association's name to a worthy cause in their community.

1. Grants: The grants received this year were \$52,500 from the Department of Canadian Heritage; \$20,000 from MEQ. In addition we received a grant of \$19,500 from the Department of Canadian Heritage for Family Literacy; \$4,000 non-government grants for other Literacy Projects.

- 2. Purchases: Beyond the normal expenditures for the office supplies and equipment maintenance.
- 3. Budget: The budget for 2005 was revised to reflect change in the operation of QFHSA. The 2006 budget was developed for presentation at the 2005 AGM.
- 4. Reporting Statements: We are attempting to develop a financial statement for internal use that will meet the mandate of the committee and reflect the operation of QFHSA and all its committees. This new statement will be transparent and fluid enough to be easily organized into the Department of Canadian Heritage categories for financial reporting.
- 5. Fiscal Year: There has been ongoing discussion on when would be the best fiscal year end: options are calendar (current); Membership (September August) or funding (April May). Changing the fiscal year requires approval from Industry Canada, Revenue Canada and Revenu Quebec and could affect the Annual General Meeting date.

COMMUNITIES AND SCHOOLS FOR HEALTH

At the request of Canadian Home & School Federation, this committee represented both QFHSA and CHSF in November 2004 at this conference in Ottawa that was attended by representatives from health and education sectors across Canada. It was based on the Canadian Consensus Statement for Comprehensive School Health that has been endorsed by CSBA (Canadian School Boards Association), CTF (Canadian Teachers Association), CHSF and many more. The goals are to promote health and wellness, prevent specific diseases, disorders and injury, intervene to assist children and youth who are in need or at risk and to help support those who are already experiencing poor health. Several workshops were dedicated to research and methodology but others were shared success stories such as the Tobacco Free Initiative already published in the NEWS by this committee.

- May 27, 2004 <u>Our Children and Literacy in the 21st Century</u>
 A workshop for the Canadian Home and School Federation Annual Meeting was held at the QFHSA offices. A particular priority was placed on the crisis re school libraries across the country.
- 2. 2004 Building Family Literacy Raise a Reader Funding from Literacy Partners of Quebec

A \$2500 grant provided books and magazine subscriptions to advance family literacy in Kegaska, Temiscaming (P.A.C.E.), Grenville, Edgewater (Pincourt) and Baie Comeau. Each community group / school engaged in a wide variety of activities.

- 3. <u>2004 Hopetown Adult / Family Literacy Project</u>
 This \$1500 grant was spent to support literacy activities at the joint Hopetown Library and Professional Education Center. This grant is from the P.G. Invitational Tournament sponsored by LPQ.
- 4. <u>Carol Hart Book Drive for Family Literacy</u> sponsored by the Royal Bank of Canada, Pointe Claire. Over 8000 books were donated by individuals, sorted and packed by Carol Hart and Marion Daigle. Boxes of books were distributed throughout the province to support families with newborns, preschoolers and school age children. Very successful.

 QFHSA deeply appreciates this financial assistance in support of literacy for children,

A grant of \$19,500 from Heritage Canada will provide a rich resource guide to assist families, community groups, schools etc. in advancing literacy for children and youth in English minority language communities. Dorothy Nixon, writer and co-ordinator has done a tremendous job. The Guide will be completed in the Spring of 2005 and launched at the Fall Conference.

The response has been overwhelming and will require time to digest. Two book draws were held. Winners were John Rennie High, Cookshire Elementary, St Willibrord Elementary (Chateauguay) and St. Theresa (Blanc Sablon).

- 11. November 10, 2004 Building Family Literacy at Grenville Elementary

 Marion Daigle and Dorothy Nixon met with the principal, teachers and parents to help co-ordinate activities related to their project.
- 12. November 26, 2004 John Abbott College Information and Library Technologies

 My annual workshop to students in their publicity program. An honorarium of \$100 was donated to Beverley Graham, an EMSB library technician.
- 13. February 6, 2005 Born to Read Launch Edgewater Elementary School, Pincourt Twelve Edgewater families with newborns and their siblings were welcomed in the school library on a Sunday afternoon. Each family received a sturdy red bag filled with books for babies, the siblings chose books for their home library; stories for babies and siblings by Myrna Guy, retired teacher, and Susan Singer, school librarian delighted everyone. This was part of their Building Family Literacy.

 The principal, Hans Bulow, was clear: Make plans now for next year! Edgewater Home and School Association was an enthusiastic supporter.

Come Read With Me Literacy Contest 2003/2004 was sponsored by Literacy Partners of Quebec, the Office of the Commissioner of Official Languages, and Quebec Federation of Home and School Associations. The mandate for this initiative is to promote reading Canadian authors.

Thanks to Home and Schoolers Michelle Armstrong, Bev Bishundayal, Helen Koeppe, Lallie MacKenzie, Anne MacWhirter, Anna Marrett, Ron D'Souza, Sheila Splane and Susan Tweddell for judging some of the 439 entries.

On October 5th, the Awards Ceremony was held at Sinclair Laird School in Montreal. Thirty students from 40 English elementary schools across the province were awarded a \$75 gift certificate and their respective schools a \$500 voucher from Babar Bookstore in Pointe-Claire. Marie Louise Gay, award winning children's author, addressed those present and read from her new book *Stella Princess of the Sky*.

Although this contest had proven very successful, QFHSA will not co-sponsor the 2005 event due to increased costs involved.

Summary of Activities:

A. The Quebec/Montreal chapter of C.A.C.E. has met once since the last AGM. On Tuesday, February 2nd, 2005, the Quebec/Montreal chapter of CACE met with representatives of <u>The Montreal Gazette</u> including: George Kalogerakis (city editor), Richard Tye (sales – education sector), Nancy Diggins (community relations), Allison Lampert (education reporter), Karen Seidman (West Island education reporter), and Peggy Curran (university reporter).

The three education reporters explained what they look for in a story. Seidman is always open to suggestions. Curran prefers human interest stories or stories that involve research. Lampert prefers to take the issue-related angle on stories. The panel also gave some advice on how organizations can get better coverage from the news media:

- E-mail is the best way to communicate with reporters; cell phone numbers are also important so that reporters can easily contact you.
- Having reliable contacts is very important; reporters will get frustrated if they cannot reach you before their deadline.
- When major news events occur, it is a good idea to send out a press release saying "we have
 experts available for an interview on x subject". McGill University did this after the tsunami
 disaster.
- Press releases sent to the education reporters can also be sent to the city editor.
- When a press release arrives in the newsroom, the "so-what" factor of the story idea is considered what is the relevance of the story idea or story angle? It is a good idea to link your story idea to major or yearly events, such as Christmas.
- 11:00 am is the best time to hold a press conference.

The annual CACE Conference will be held this year in Ottawa, at the Chateau Laurier Hotel, from November 5th -7th, 2005.

B. QFHSA Publicity

Media releases were sent out in mid-April regarding the winners of the awards at the AGM Awards Dinner and the QFHSA's 60th Anniversary celebration. Media releases were sent to: <u>CFCF News</u>, <u>Global News</u>, <u>This Morning Live</u>, <u>CBC News/Canada Now</u>, and <u>The Montreal Gazette</u>. Allison Lampert, education reporter for <u>The Montreal Gazette</u>, attended the AGM in the afternoon. The article, "Marking 60 years of home and school – Volunteers reminisce about good old days", was featured in the April 25, 2004 edition of <u>The Gazette</u>. The article touched on how school-related issues where the QFHSA is involved have changed over the years, such as bullying and library funding.

MEMBERSHIP REPORT

The kits given to the executives contain materials to facilitate the work of the local association. For membership, the kits include some samples which have been contributed by schools with successful campaigns. Workshops are also usually offered at the Fall Conference. Everyone is encouraged to attend these workshops.

Membership Page in the QFHSA NEWS

Each issue of the NEWS has a membership page with ideas, up-dates, articles about schools and a message from the membership chairperson. The December 2004 issue included a column addressing the liability insurance coverage of sports activities sponsored by Home and Schools.

MEMBERSHIP DEVELOPMENT & OUTREACH

Report to the Annual General Meeting - April 23, 2005 Submitted by Margaret Funnell - Director, Membership Development

Mandate: To prepare the application for the Department of Canadian Heritage [CANHER]

Program funding; to participate at meetings of and communicate with the Quebec Community Groups Network [QCGN]; to prepare programs and outreach for offisland communities; to apply for other projects that may from time to time be funded by CANHER; to produce new or revised promotional materials linked to membership development; in addition a member sits on the Finance Committee.

QFHSA is a member of the QCGN which has had a five-year agreement with the Federal Government for the disbursement of the Official Languages Communities Support Program funds. This agreement was renewed in April 2004. QCGN's members sign a contract [called a Contribution Agreement] with the Department of Canadian Heritage. Glenna Uline, the Executive Director, has represented QFHSA at the QCGN meetings usually held two to three times a year and taking place in venues across the Province. This February she also attended a research conference on the English-speaking Communities of Quebec sponsored by QCGN/Heritage Canada.

In mid-2004 QFHSA again received CANHER Program Funding. As a result of the due diligence requirements with all such federal funding, 'grants' continue to be based on results-based management. Funding was given in installments [50 (including 25 interim), 40 and 10%] with detailed reports on results required twice a year. QFHSA has applied this year for increased CANHER Program Funding for 2005/2006. In addition, QFHSA [Marion Daigle with Glenna Uline] has received CANHER Project Funding for renewal of the Literacy Resource Handbook.

The CANHER Program Funding plus membership revenue and a MEQ grant are QFHSA's main sources of revenue. Regular Program Funding from CANHER allowed QFHSA to bring parent members from off-island Home and School Associations in more remote areas to its workshops, Fall Conference and Annual General Meeting [AGM]. It helped subsidize important Regional Council meetings off-island. Western Quebec especially has met frequently - in addition to meetings held in Montreal at the time of the Fall Conference and AGM. Funding allowed QFHSA to visit off-island Home and School Associations, both new and potential.

CANHER funding helped QFHSA to produce important materials both for the Fall Conference and the 60th Anniversary AGM Program and to print membership/parenting pamphlets on *Putting an End to Bullying, It's About Us,* and *Children Learn What They Live. Why a Home and School is Important* has been completely revised, translated and printed.

Funding helps QFHSA to publish four issues per year of the Quebec Home & School NEWS. It helps QFHSA representatives to attend the Network Lunches held on Montreal West Island which bring together volunteers, social and health professionals, educators, local police Community Officers and others interested in the concerns of youth. In February, a psychologist from the Jewish General Hospital spoke to 145 people on *Boys at Risk-What Do They Really Need?* The previous program was on the *Obsession to Thinness* [mostly girls].

Home & School NEWS

Report to the Annual General Meeting - April 23, 2005 Submitted by the office

Mandate: The Editorial Board is meant to oversee content of our newspaper and the website.

There were four regular issues put out last year, of 16 pages each. Circulation has remained steady and the average paid distribution is 5,900; average total distribution of a single issue is 7,300. Local associations are welcome to have extra copies of our newspaper at no extra cost.

The Education Committee did not produce an updated, bilingual insert of *MEQanics*, which dealt with questions parents have about the workings of the Ministry of Education, in 2004. This was originally compiled and translated in 2002 by our Education Committee and updated in 2003. They are considering updating it for 2005.

The locals are asked to send in their own school newsletters for inclusion in their section of the paper, Focus on the Locals. Even if you don't have a writer on your team, your newsletter will enable us to let other parents know what exciting things are happening at your school and to "steal" any ideas that appeal to them. Diane Radu is Editor of Focus.

The NEWS is grateful to our regular contributors: AMCAL Family Services, Shirley Straughton (Health Issues), Don Smith (Safety Issues), Connie De Giorgio (Membership), Canadian Home & School Federation, Glenna Uline, QFHSA Executive Director, and Donna Norris, QFHSA President. And, this past year, Michelle Armstrong, Chair of our 60th Anniversary Committee for informing all of us of their plans.

QUEBEC COMMUNITY GROUPS NETWORK [QCGN]

Report to the Annual General Meeting, April 23, 2005 Submitted by Glenna Uline, Executive Director

Mandate QFHSA participates in this forum to keep informed of and participate responsibly

in issues affecting the minority English language community and the government,

services and funding available to support our objectives.

<u>Participation</u> QFHSA Executive Director Glenna Uline is the official representative to the

QCGN meetings. The 23 member organizations, all English language non-profit sector and regional groups that receive funding from Canadian Heritage, convened June 4-6 in Orford and October 26-28 in Gatineau. Donna Norris,

QFHSA President, also attended both these meetings.

Highlights Orford Meeting

- 1. The Global Development Plan (GDP), Phase III, will start with a \$150,000 grant. This project aims to revitalize the English language minority communities of Quebec 2004-2009. Main strategies will encompass research capacity (empowering through knowledge), integrated infrastructure of networks at all levels, integral role of education and training, cultural identity (renewed sense of belonging), visibility and participation in Quebec society, English-speaking youth see a future in Quebec. Consultant Susan Grundy was hired to organize a series of Town Hall meetings throughout Quebec during September and October 2004 to confer with the general public regarding the direction this process should take. Updated information is available on the website, www.englishspeakingquebec.ca.
- 2. Canadian Heritage and the Quebec Anglophone Community Coordination Committee met for the first time last November 28th. Co-chaired by the Deputy Minister of Canadian Heritage and Sharon McCully of the Quebec Anglophone Heritage Network with participation from the Privy Council Office, the purpose is for the government and the English community to better know one another's needs and resources. The discussions centered on our youths' need for a stronger support infrastructure to curb the high rate at which they are leaving the province, regional issues such as out migration, arts and culture. There was also concern voiced at the inequitable division of federal government funding between the French (\$16 million) and the English (\$5 million) over 5 years.
- 3. The QCGN has formally requested a permanent seat at the National Table, a group comprised of representatives from community organizations and government departments that meets to discuss economic development and employability in the English community.
- 4. The QCGN President, Martin Murphy, and all 4 members of the Executive were elected for another term (one year). As well, 3 new member organizations were welcomed to QCGN: Youth Employment Services, Black Community Resource Center and Neighbours of Rouyn-Noranda.

5. At the Joint Committee Meeting (includes QCGN members and representatives from national government departments), Mathieu Brennan of the Canadian Heritage National Office discussed the Official Languages Program. The third 5-year cycle of the Canada Community Agreement will begin next year. How can the federal government be responsive with support to minority official language communities? What are the key issues in the English community? How are we dealing with them? What is being accomplished with the \$3 billion total available between now and the end of the 2008 fiscal year? A Voluntary Sector Initiative – Accord Between the Volunteer Sector and the Government of Canada is looking to establish principles and broad guidelines to strengthen the ability of both to better serve Canadians.

Gatineau Meeting

- 1. Global Development Plan The current consultation sessions to identify strategies for development in 8 priority sectors: Arts and Culture, Employment, Heritage, Education and Training, Health and Social Services, Media, Visibility and Leadership and Youth are going well, although some fine-tuning is required to define who the community includes. Although several QFHSA Board members participated, community involvement has not been as strong as hoped and the lack of youth participation is of concern. Information is available on the website www.englishspeakingquebec.ca.
- 2. Sussex Circle Inc. has been awarded a contract to facilitate the process to arrive at a QCGN strategic plan 2005-08. The project leader, Kevin Saville, presented his company's proposal to those present. It was decided to proceed with the endeavour with a QCGN sub-committee on which Donna Norris will participate. Norma Stirling, QFHSA Executive Vice-President, and Glenna Uline, Executive Director participated with Donna Norris in a telephone consultation with Kevin Saville to offer our input for the sub-committee's consideration.
- 3. Kevin Saville reported his contract to manage the Health and Social Services Network Partnership Initiative (HSSNPI) is on time and on budget. He reviewed that his company began in March 2004 by establishing a strategic plan and pilot project in the Eastern Townships. Soon thereafter, they established the funding process, publicized the program, received and assessed applications and recruited a volunteer committee to govern the program on behalf of QCGN. One hundred fifty organizations enquired about the program, 28 made official applications of which 10 were selected to share the \$619,850 available. Crucial to giving funding was the applicant demonstrating how they would sustain the capacity to produce desired benefits in the future.
- 4. At the Joint Committee Meeting, (includes QCGN members and representatives from national government departments), Ginette Grenier, Director, Canadian Heritage Program Management emphasized the importance of the imminent consultations "Cooperation with the Community Sector" (October 29 and November 4 attended by Donna Norris and Glenna Uline respectively) to draft the renewal of the Canada Community Agreement, a 5-year plan focused on support to official language minority communities. She was appreciative of the concerns expressed in the resolution, but cited difficulties in the scheduling and logistics of consulting Grade 6, Secondary I and II parents for Cycle I religion options.

The Canada Minister of Health, Ujjal Dosanjh, replied that "I fully support your Association's resolution to institute a comprehensive non-smoking policy in all schools, however, this request falls outside of federal jurisdiction.... The restriction of smoking in schools falls under provincial authority."

A resolution workshop was held with representatives from Mothers Against Drunk Driving (MADD) to draft a resolution to be presented at the 2005 AGM.

Theme - 18th national consecutive year

The theme for the 2005 National Teacher/Staff Appreciation Week was *Touching Minds, Shaping Futures*." CHSF Idea Files (which included Order Sheets, 2005 Participation Report Sheet, Poster and Publicity Ideas, etc.) were sent to Home & School Associations in December.

Materials

In order to encourage contact with the national organization, schools were asked to order their T/SAW materials from the Saskatchewan provincial office which supplies the items. QFHSA did not place an order for additional new stock. Schools were advised to place their orders to allow time for delivery and limited supplies. Date

Once again, the Quebec Ministry of Education scheduled its provincial Teacher Appreciation Week for the first week of February, causing the usual confusion and concern with some schools as to which was the "official" week to celebrate. Teacher Appreciation Week originated with CHSF in 1988. The second week of February was chosen to coincide with Valentine's Day. A few years later, after consulting with QFHSA, the MEQ adopted the idea and the Canadian program was acknowledged in its promotional materials. However, this is no longer the case and the MEQ has since changed the provincial date to accommodate the Quebec Arts celebration week.

This year Executive Director Glenna Uline approached Noel Burke, Assistant Deputy Minister, Anglophone Services, MEQ and Michael Cohen, English Montreal School Board spokesperson, to discuss the possibility of agreement on the week of celebration. However, it is unlikely that the MEQ will change its schedule. Therefore, schools should be aware that they may choose either week or at any time convenient to them.
