

# LETTER TO THE GAZETTE BY THE TOWNSHIPPERS ASSOCIATION

These are very challenging times for minority language rights groups such as Alliance Quebec and Townshipper's Association to name only two. There is constant pressure to jump into the unnerving yet captivating daily political debate. For many groups like Townshippers Association, our mandate is to promote and protect English-language rights, not to take partisan sides in the debate of the day.

We take exception to the part of your editorial which reads "There is only one voice - that of Alliance- when it comes to the concerns of minority-language rights." This is far from the truth. There are Townshippers' Association, the Gaspe's Committee for Anglophone Social Action, Outaouais Alliance, the Voice of English Quebec in Quebec City, The Chateauguay Valley English-Speaking Association, the Coasters Association on the Lower North Shore and the Council for Anglophone Magdalen Islanders to name other federally-funded minority language rights groups in Quebec.

That is the beauty of Quebec: it is not simply one English-speaking community and one French-speaking community. Alliance Quebe's mandate does not cover the Eastern Townships specifically because ours, like other regions, is a diverse area that has chosen to create its own grassroots association which serves the rights and needs of its own English-speaking community.

Spread across the province, each in our own region and collaborating when appropriate, we continue to promote and protect the needs and rights of English-speaking Quebecers.

#### MESSAGE FROM LINA ROY

As you know, the mandate of the ZIP Committee is to gather the population around the river, the St-Lawrence's Gulf, to mobilize the community and give some information on environmental needs all along the St-Lawrence regarding its protection, rehabilitation, and improvement.

Our wish is that the people from the Lower North Shore will take part in the different projects that will be carried out by the Committee. We believe that your Association is the organization that could make the link between all the municipalities of the Lower North Shore.

Among our projects for the coming summer, our Committee would like to see the creation of a team in each municipality on the Lower North Shore where all members would meet to discuss how to get the population to participate and get involved in the organization by having an event such as a "Special Day" to clean up beaches near the river. #### **Paie**



# **Quebec Farmers Association**

The QFA has received project funds to get the Network "up and running" on the Internet. The immediate objective is to make sure that each group is capable of using and has access to the Internet so that the system can be used as a communication and information delivery tool among the Network. The second phase is to examine and implement one or more of the several community development options available via the Internet. The third phase is to look at long-term options particularily in light of the rapid evolution of the Internet. The OFA's primary focus has been to determine what each group needs in order to get started on the Internet. This will be followed by a program of steps to bring all groups to a minimum level of Internet Functioning, and they are as follows:

Awareness: presentation to staff,

Training: group training session in

Montreal,

Access: connect each group to the

internet,

Utilization: examine and implement uses

of the Internet.

# Voice of English Quebec

We received a copy of a project entitled "Lancement de l'Operation Fraternite sur Internet" for young people between 14 to 17 years of age. It intends to provide a means which will enable francophones, anglophones,

and allophones to define over a 10 year period, the type of society in which they would like to live. The gentleman who is organizing the project has done so through his own time and means. He is doing it in hope that his grandchildren will not have to live with the socio-linguistic tension that currently exists.

# Citizenship and Immigration Canada



#### Tourism

# **Quebec Community Groups Network**



- Focus on what is planned and what is rumored:
- sections 41-45 were enacted to further basic principal of the linguistic duality of this country;

The H & SS report is where the Executive Director of the CSBCN retrieved his information on the population for his bulliten. As for the number of anglophone and francophone persons on the coast, there are only estimations made by the municipalities. The statistics researched by the Secretary showed that there were 38% Anglophone population, and 62% Bilingual for the Lower North Shore.

# **Board Handbook Updates**

The General Secretary distributed the Board Handbook updates on May 14. The inserts/replacements were of the following: Constitution, Policies, Membership Forms, Fundraising Forms, Newspaper Support Forms, Price Lists, Information Lists, and Minutes.
