6. REPORTS

President

Mr. Hoffman Wolff highlighted the challenging, but good year VEQ has been through with the continued challenges in relation to the COVID-19 pandemic. VEQ has adapted and continues to make a significant impact on the community by effectively creating and carrying out valuable programming, integrating newcomers and serving as the voice of the community at the municipal, provincial and federal levels. Mr. Wolff thanked the Executive Director, Brigitte Wellens and her staff for being adaptable and flexible in the current conditions.

VEQ has maintained important relationships with government officials at all levels, including the provincial Secretariat for Relations with English-Speaking Quebecers. Like many of you, VEQ is concerned with the implications of the provincial government's proposed Bill 96 as they relate to our community, businesses and schooling. VEQ is working with decision-makers to better understand its effects and to make sure our community's voice is heard.

Another important aspect over the last year has been the growth of the Regional Development Network (RDN), of which Brigitte Wellens is the president. RDN, which brings together 14 regional organizations, serves as a united voice in the sector of socio-economic development for English speakers off the island of Montreal and provides governments with a better understanding of the challenges they face.

Further to this, VEQ continues to carry out events and programs for residents of all ages. We have adapted to the current conditions of the pandemic and a lot of these events were held virtually. VEQ recently received funding from Canadian Heritage to produce the "My Quebec City" podcast, which will allow our region's youth to share their stories and experiences of what the realities are of growing up Anglophone.



Additionally, in April, the provincial government confirmed funding for the Enhancing Regional Community Capacity program, which will allow us to improve our services in the northern perimeter of the region (Stoneham, Shannon, Saint-Gabriel-de-Valcartier, and Portneuf), as well as allow VEQ to improve and expand its organizational capacity.

Seniors are also an important component of our programming: in addition to our Seniors Out and About program, Employment and Social Development Canada, as well as the provincial Ministère de la santé et des services sociaux, both funded new initiatives. One to help reduce social isolation and one to bridge the technological gap among seniors in our area, including a tablet lending library and other virtual activities for community members. Finally, we continue to work with local employability service providers from both linguistic communities, to promote and improve access to their services.

VEQ has also continued to serve as our region's "front door" for English speakers who are new to the area. The Newcomers program provides orientation and referrals regarding community and social programs and services in the area. With funding from Canadian Heritage and the Ville de Québec, we offered a range of services to 371 newcomers from 51 different countries, for a total of 2,113 services. 81% of the newcomers we met were met within the first year following their arrival. Over the course of the 2020-21 fiscal year, VEQ organized and carried out 26 Finding your Niche for Newcomers events and info sessions. Additionally, I am extremely pleased that we have been able to resume in-person newcomers' activities this summer, with a walking tour of Old Quebec, a hiking trip, and a ferry ride to Lévis already taking place.

It has been a pleasure serving on VEQ's Board of Directors for the last six years, as well as serving as its president this year. I am consistently impressed by the dedication and resourcefulness of its staff, and I am truly proud to have been part of the organization. Our community is strong, vibrant and supportive, and I have no doubt that this will continue in the years to come.

Mr. Hoffman Wolff was thanked and congratulated for his years of service.

Executive Director

Ms. Brigitte Wellens started her report with thanks to all guests for participating in the virtual AGM again this year and for VEQ's partners for their year-long support. Special thanks went out to our funders for their financial support and without whom it would be impossible to keep improving services for the English-speaking community: Canadian Heritage, the Secretariat for Relations with English-Speaking Québécois, the Government of Québec, La Ville de Québec, Employment and Social Development Canada, The Jeffery Hale Foundation, the Fondation des Premières-Seigneuries and the VEQ Foundation.

Throughout the last fiscal year, VEQ has continued to create links and strengthen partnerships with organizations from both the English and French-speaking communities. A special thank you to the QCRC, APEAL, the Jeffery Hale Community Partners, and the Morrin Centre to name a few. This also included being an active member of the *Table Régionale de Concertation en Immigration de la Capitale-Nationale*, which brings together organizations directly involved with welcoming Newcomers to our region. In addition, VEQ is also part of the *Comité pour le recrutement et la rétention du personnel Bilingue*, which develops strategies and solutions to address recruiting and retaining bilingual employees. These essential partnerships facilitate the establishment of new collaborations between VEQ and organizations in the French-speaking community, and enable us to maximize our ability to continue to provide quality services.



Ms. Wellens highlighted some of VEQ's projects from the 2020-21 fiscal year:

Through funding from the Secretariat for relations with English-speaking Quebecers, VEQ undertook a two and a half year project in the second half of 2018-19 aimed at expanding the territory it serves into the northern perimeter of Québec City. In the last year, 2 virtual focus groups were carried out to evaluate our progress and research community needs. These focus groups brought together voices from Saint-Gabriel-de-Valcartier, Stoneham-et-Tewkesbury, Shannon, and Portneuf. We also collaborated on several community initiatives throughout the year and helped to spread some joy with festive virtual events such as St. Patrick's in March and September and a series of Christmas carols performed by youth from the 2 local schools in the area.

In addition to the expansion of the local outreach, VEQ continued to undertake a project aimed at connecting with local Carrefours jeunesse emploi centers as part of the Enhancing Regional Community Capacity program. This on-going project aims at building awareness around the employment needs of the English-speaking community and to promote services to the English-speaking youth of the Greater Quebec City region.

Through funding from Canadian Heritage, VEQ also undertook an 18 month project in October 2019 aimed at connecting high school students to various post-secondary and career path programs available in the Greater Quebec City Region. Due to the postponement and eventual cancellation of in-person events, we created a podcast series known as The Pathways Podcast featuring interviews with 19 locals talking about their career journeys.

Thanks to funding again from Canadian Heritage, a project called Bilingual Book Club was created to promote linguistic duality and allow participants to practice their second language. Book Club meetings were facilitated and held virtually twice per month for a total of 17 meetings.

Services to seniors continue to be a major focus for VEQ, therefore we continue to be proactive and implanted a number of useful services for the seniors of our community.

Through the regular support of Jeffery Hale Foundation, the Out & About program continued to provide support, however, in a slightly different way. In this year of transformation, our Out & About program, which normally provides seniors with free transportation to a variety of outings throughout the year, became the telephone check-in program. From quick chats to longer conversations, VEQ carried out over 3000 telephone check-ins. We also provided essential support for the scheduling of vaccination appointments, transportation to these appointments and shopping and delivery of groceries. We were able to witness first-hand the impact that we have on our community.

VEQ enlisted the help of a volunteer who agreed to record video capsules that we then shared with seniors via email, on our YouTube channel, and on Facebook. 7 capsules were produced.

Through financial support from Employment and Social Development Canada through the New Horizon's for Seniors Program, we implanted the Active Seniors Project. The initial goal of the Active Seniors project was reducing social isolation through movement. Because of the Covid-19 pandemic, we enlisted the help of an Art Therapist and transformed the project into a wellness art project. 287 art kits were delivered and 40 seniors benefited from the activities of this project.

Lastly, for our seniors, in January 2021 VEQ received funding from the Government of Québec via the Ministère de la Santé et des Services sociaux, under the program Action Aînés Québec (PAAQ). This funding allowed VEQ to purchase 26 tablets and create a tablet lending library. Each tablet is equipped with a data plan enabling seniors who don't have internet to participate. A partnership with Atwater Library and Computer Centre allows us to provide professional tech sessions to help users learn how to use their tablets.



Projects currently underway in 2021

Thanks to funding from Employment Social Development Canada via New Horizons for seniors, VEQ created the Letters for the Soul project linking community members of all ages to share the art of letter writing, poetry and drawing.

The Enhancing Regional Community Capacity project, which is funded by the Secretariat for Relations with English-speaking Quebecers will continue in the next fiscal year. This funding will allow VEQ to increase its organizational capacity and help us build for the future.

VEQ's work with the Carrefour jeunesse-emploi centres will continue and will grow under the employment strategy to also include other employment service providers helping them to better serve the needs of English speakers.

We will also continue to meet the needs of Newcomers, thanks to funding from Canadian Heritage and Ville de Québec. Several outdoor community activities have already taken place over the summer months and a full schedule of info sessions and activities are planned for the rest of the year.

VEQ is part of l'Initiative pour l'inclusion sociale des personnes âgées : un enjeu collectif, launched by l'Institut sur le vieillissement et la participation sociale des aînés de l'Université Laval (IVPSA). It aims to promote the social inclusion of seniors in the Québec metropolitan area and is being carried out thanks to a contribution from Employment Social Development Canada through New Horizons for Seniors and will end in 2025. VEQ is part of a group of 7 organizations who is receiving funding for the next 4 years. VEQ's actions will focus on reducing the digital divide and social participation via the implantation of intergenerational and intra-generational activities.

Through funding from Canadian Heritage, VEQ will get to share the experience of creating a podcast from scratch by leading youth through workshops to support them in creating their own podcasts episodes and content. This 2 year project hopes to foster a sense of belonging and civic pride and to really give our youth a voice to talk about what matters most to them.

Lastly, our Out & About outings have been back and in full swing over the summer with 40 outings to date. To date, there have been 350 people participating in outings to the museums, the aquarium, des Chutes-de-la-Chaudiere, Art Alive and much more.

The pandemic may have transformed things but we have been busy nonetheless and have lots of exciting initiatives coming up. The format of some activities and projects may still need to be modified but we have adapted and continue to think outside the box.

Ms. Wellens concluded by stating she is honored to be the Executive Director of such a great community organization. Every day is a joy to come to work with fantastic partners and staff members, and government officials. Witnessing and hearing about the impact that we have on our community is what gave us the fuel to keep going in an unprecedented year.

Ms. Wellens thanked outgoing board members for their hard work and dedication. Isabel Sullivan, Hoffman Wolff and Warren Thomson.

Treasurer

Ms. Brigitte Wellens presented the Financial Statements to the membership. There was an increase by \$10,000 in revenues in the last fiscal year. And there was an increase in expenses for additional salaries in the amount of \$40,000 in 2021 and an increased amount in rent due to the opening of our new office in Shannon. Some other categories such as Travel and Expenses were not as per usual because there was limited travel happening due to the pandemic. A lot of the travel funds were reallocated to other budget categories. The excessive revenues over expenses of \$26,736 (24,080 of that are funds from the ERCC-CHSSN project that don't belong in our accumulated surplus). The beginning balance of \$135,935 shows that VEQ is in really good financial health. Our liabilities as of March 31, 2021 \$69,141 which is on par or a little lower than last year. Our end of year cash balance was \$147,446. Ms. Wellens went through the breakdown of the projects for 2020-2021: Core has revenues over expenses of \$3869, Job bank revenue \$2238, deficit of \$568 in Bilingual Book Club, \$28 in Active Seniors and \$33 in the Pathways project.

The Nominations Policy adopted in May 2018 by the membership, establishes a process that gives the Nominations Committee the duty to carry out the necessary steps to produce a slate of candidates for approval at the Annual General Meeting.

In fall 2018, the Nominations Committee consulted the VEQ Board of Directors for future needs of the organisation that may require specific expertise or experience. The committee then conducted a gap analysis to determine the criteria for the recruitment of board members



to fill the vacant positions. The criteria set out in our policy that was adopted by the membership in May of 2018 are:

- Gender;
- Expertise / skills;
- Number of years in Quebec City / Province;
- Age;
- Residency.

To achieve its goals, the Board determined that the organization would be well served with expertise or representation in the education sector, individuals aged 18 to 25, and individuals 65 and older. The Nominations Committee also identified gaps according to the other criteria set out.

Earlier this year, one member of the Board resigned, thus leaving three vacant positions on the board. With two Board members' second terms ending in 2021, and one Board member's first term ending in 2021, the number of seats to be filled was determined. The Nominations Committee was then tasked with recruiting candidates to fill the remaining positions on the Board.

A call for nominations was sent out on April 1, 2021 with a deadline for applications of May 14, 2021. Four members expressed their interest. Interviews were conducted by the Nominations Committee between September 16th and 21st. All candidates were contacted with the results and those retained were asked to confirm their desire to be part of a slate to be presented at the Annual General Meeting.

As an active, non-profit organization that currently has over 4000 members, VEQ has played a vital part in the preservation and development of community life for the English-speaking community for over three decades. Currently, VEQ has active partnerships with over 60 community organizations, institutions, and groups in the area.

Furthermore, VEQ helps individuals participate in community life in the Quebec City region, in both French and English. We welcome newcomers, sponsor community celebrations, research needs, inform citizens, and provide a framework for effective action on behalf of English-speaking people and institutions.

Along with the direct, individual support we offer, VEQ continues to have a voice at the immigration table and foster positive and productive partnerships with the city and other important community stakeholders.

However, newcomers to the city are not the only community members benefitting

from our services. Through the Job Bank, our partnership with YES Employment + Entrepreneurship, and countless other employment service providers, we continue to support employment and business, and entrepreneurship within the community. Of course, our programming is not all business! Thanks to our satellite location, we are also reaching community members who live in the Northern perimeter of the region, ensuring that our services, programs and activities, reach as many individuals as possible.

Through creative and varied cultural programming, VEQ is working hard to keep our members connected to cultural and leisure activities around the Greater Québec City region. Despite the constantly changing social distancing measures related to COVID, we were able to organise over 60 outings with the Out and About program this year. Another bright point of pride was the creation of the My Québec City podcast. This podcast provides a place of youth community members to develop topics and explore issues based on their interests and their experiences living in Québec.

I have been so proud to sit at the head of the board of directors for the 2021-2022 year. The VEQ staff continue to find new and creative ways to go the extra distance in supporting our community. I am looking forward to seeing what next year brings to the English-speaking community and to the Greater Québec City region.

MESSAGE FROM THE EXECUTIVE DIRECTOR

Last year, I began my message saying that 2020 was going to go down in my history book as the year of great resilience. I would categorize this last year, as the year of consolidation.

What we managed to accomplish during the 2021-22 fiscal year, despite the little grey COVID cloud still looming overhead, has been nothing short of extraordinary. Business as usual would have been perfectly acceptable under the circumstances. Instead, we actually increased services and activities, established new partnerships, and opened a community space in Shannon.

The VEQ Newsletter got a makeover and went from 3 publications to 5. The E-Bulletin for Newcomers also went through a transformation. We nearly doubled the number of outings for community members aged 50+, and served 269 more newcomers than last year, an increase of 73%.

We established and strengthened links with 3 regional Carrefour jeunesse-emploi centres and 15 other employment sector organizations, to increase the accessibility of their services to English speakers. We also published weekly #JobTipTuesday Facebook posts highlighting job search resources, workshops and events, helping connect community members to countless networking and employment opportunities.

Through the My Québec City podcast project, we offered workshops to youth, aimed at teaching the rudiments of interviewing, creating and editing a podcast. Then, we provided them with a microphone, literally. Every episode has been so interesting to listen to and there are more on the way. I am

absolutely amazed by our youth.

We maintained our strong partnership with the Jeffery Hale Community Partners (JHCP) and the Jeffery Hale Community Services (JHCS) and continued to collaborate on valuable programs for the English-speaking community such as the Volunteer Income Tax program.

INDEPENDENT AUDITOR'S REPORT

To the Members of
VOICE OF ENGLISH-SPEAKING QUÉBEC (V.E.Q.)

Opinion

We have audited the financial statements of VOICE OF ENGLISH-SPEAKING QUÉBEC (V.E.Q.) (the Organization), which comprise the statement of financial position as at March 31, 2022, and the statements of revenues and expenses, changes in net assets and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Organization as at March 31, 2022, and the results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

Basis for Opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Organization in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Other Matters

Management is responsible for the other information in Appendix 1.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon. In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated.

If, based on the work we have performed, we conclude that there is a material misstatement of this information, we are required to report that fact. We have nothing to report in this regard.

Responsibilities of the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Organization's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Organization or to cease operations, or has no realistic alternative but to do so.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

1. ARTICLES OF INCORPORATION

The Organization obtained its certificate of continuance dated on June 27, 2014 and is governed under the Canada Not-For-Profit Corporations Act.

VOICE OF ENGLISH-SPEAKING QUÉBEC (V.E.Q.) is a not-for-profit organization bound by a common concern of strengthening and promoting the well-being, rights and responsibilities of the multiethnic and multi-religious English-speaking community. The working territory of the organization encompasses the 03 and 12 regions of the Province of Quebec.

2. SIGNIFICANT ACCOUNTING POLICIES

The Organization applies the Canadian accounting standards for not-for-profit organizations.

Use of estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the amounts recognized as revenues and expenses for the periods covered. Actual results may differ from these estimates.

Revenue recognition

Contributions

The Organization uses the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year in which the related expenses are incurred. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

Other revenues

The Organization recognizes its other revenues when all significant acts have been completed and collection is reasonably assured.

Financial instruments

Initial measurement

The Organization initially measures its financial assets and liabilities originated or exchanged in arm's length transactions at fair value. Financial assets and liabilities originated or exchanged in related party transactions, except for those that involve parties whose sole relationship with the Organization is in the capacity of management, are initially measured at cost.

Subsequent measurement

The Organization subsequently measures all its financial assets and liabilities at cost or amortized cost.

Financial instruments (continued)

Impairment

For financial assets measured at cost or amortized cost, the Organization determines whether there are indications of possible impairment. When there are, and the Organization determines that a significant adverse change has occurred during the period in the expected timing or amount of future cash flows, a write-down is recognized in net income. If the indicators of impairment have decreased or no longer exist, the previously recognized impairment loss may be reversed to the extent of the improvement. The carrying amount of the financial asset may not be greater than the amount that would have been reported at the date of the reversal had the impairment not been recognized previously. The amount of the reversal is recognized in net income.
