DIALOGUE MCGILL

In 2004, McGill University received a financial contribution from Health Canada as part of their Official Languages Health Program, resulting in the launch of Dialogue McGill (formerly known as the Training and Retention of Health Professionals project).

Dialogue McGill's primary objective is to support activities that address health care and social services access through: (1) language training to increase health care providers' communication skills and retention rates, (2) innovative human resource initiatives aimed at increasing the number of health and social service providers capable of providing services in English, and (3) conducting program evaluation and research in the aforementioned areas. To accomplish this objective, the Dialogue McGill collaborates with and financially team supports community, educational, and health and social service institutions.

BURSARY PROGRAM

Created by Dialogue McGill in 2011 as a retention initiative, the Health and Social Services Bursary Program provides bursaries to students pursuing studies in health care and psychosocial services who have committed to practice in their field in their home region upon completion of their studies.

The bursaries are coordinated locally by the Englishspeaking Community Networks in different Quebec regions and are designed to respond to regional and local priorities for access to services in English by retention of these graduates in their region of origin.



These graduates will make an important contribution to the English-speaking community of their region.






FUNDING PER YEAR




BURSARIES AWARDED HEALTH CARE



BURSARIES AWARDED SOCIAL SERVICES



Dialogue McGill solicited feedback from the Community Networks (CNs) in a February-March 2022 survey, resulting in data from **19** CN representatives.

Internal Review Process

For the Bursary Program, a selection committee with CIUSSS/CISSS representation is required. Please see the Bursary Program Guide for details.

Students who receive multiple bursaries are committed to 1 year of service to their region per bursary awarded. **5 of 19** Community Networks limit the number of bursaries that a single student can receive:

- 1 bursary per student is imposed by 2 Community Networks
- 3 bursaries per student is imposed by **3** Community Networks



Medical Students

15 Community Networks recommend that medical students continue to be eligible for a bursary, despite physicians having little control of their region of practice post graduation.

Application Process

15 of 19 Community Networks are satisfied with the content of current applications:

- Community Networks suggested providing clearer external and internal timelines, an earlier bursary award date, and avoiding minor and last minute-changes.
- Community Networks reported that students had technical difficulties when completing the bursary application forms. Glitches in PDF applications and lack of intuitiveness were common reasons.

The above suggestions were addressed in the 2022-2023 Bursary Program funding cycle, with clearer timelines (see Important Deadlines 2022), more time for student application preparation (call launched on March 22), earlier bursary award date (Community Networks will receive funds in August with the exception of waitlisted students), and improved forms.

The Dialogue McGill bursary guide specifies that a contract must be signed between the Community Network and the student recipient. **6** Community Networks have a contract that is signed by the recipient upon receipt of the funds. **17** Community Networks would be interested in Dialogue McGill sponsoring legal consultation to help create a standardized recipient contract.

Student Recipient Commitment -

9 Community Networks have had recipients who did not follow through on their commitment to work in the catchement area of the sponsoring Community Network upon graduation.

Community Networks are encouraged to contact Dialogue McGill as soon as a recipient is unable to follow through on their commitment.

Difficulties to find employment and dropping out of their academic program are common reasons for recipients not following through on their commitments, but there are isolated cases in which recipients chose positions outside the region and refunded the bursary.

Community Networks who have not yet been in this situation are highly open to feedback from Dialogue McGill on efficient ways to deal with these situations if they arise.

When recipients are unable to find a job in a public health or a social service institution, **14** Community Networks suggest that employment should be found at community organization that provides public health or social services. **10** Community Networks suggest employment be found in the education sector.

Bursary Program Strengths —

Community Networks described the main strengths of the Bursary Program as follow:

- + Support: Positive effect on supporting students in need of financial assistance
- + Recruitment: Facilitation on the recruitment of professionals in their region
- + Language: Positive effect on English-speaking communities in the regions

Areas of Improvement

Dialogue McGill has made significant changes in order to streamline and simplify its Bursary Program in 2022. Other areas of improvements requested by the Community Networks include:

- increasing the funding amounts available;
- providing available promotional materials;
- simplifying/expediting administrative processes.

NEXT STEPS



Dialogue McGill's Health and Social Services Bursary Program will evolve to meet the emerging needs of the English-speaking community as encompassed by regional access programs to health and social services.

The Bursary Program will continue to support Community Networks in the recruitment and retention of health and social service professionals in their region by financially assisting students who wish to be part of the pool of available human resources.

Community Network Forums —

Dialogue McGill will host a Community Network Forum Series in Fall 2022, starting with a forum on the Bursary Program and planning for the next funding phase (2023-2028). Dialogue McGill also solicited feedback from the Community Networks on their topics of interest.

Topics of particular interest:

- resource sharing between Community Networks;
- regional research needs;
- language acquisition activities.

Dialogue McGill looks forward to seeing the Community Networks and other key stakeholders at this upcoming event!
