
News from Seniors Action Quebec

Recent events

The return from the summer "break" has meant a hive of activity both for us and our partners. It is as though the floodgates have opened after being closed for so long during the pandemic and everyone is now trying to catch up with long-delayed plans and activities. It is heartening to learn how everyone is trying to get back up and running on all cylinders and the difficulties in doing so.



To mark International Seniors Day (October 1), we attended a reception at Montreal City Hall, where the city presented the new MADA (<u>Municipalités et Villes Amies des Aînés du</u> <u>Quebec</u>)report entitled « Stratégie municipale pour les personnes aînées 2023-2030 ».

Montreal has been a member of this programme since 2012 and Seniors Action Quebec sits on the « Comité de suivi de la Stratégie municipale pour les personnes aînées 2023-2030 » (Monitoring Committee). The World Health Organization (WHO) founded the <u>Senior Friendly Municipality</u> (SFM) strategy in 2007. The goal of the SFM is to promote active ageing by optimizing opportunities for health, participation and security to enhance the quality of life as people age.

Andrew Palucci, Director of Policy and Governance, represented Seniors Action Quebec at a town-hall meeting on October 27, 2023, organized by MNA Greg Kelley's riding office on the West Island of Montreal. This enabled us to do some work at the grass-roots level and to learn firsthand about the difficulties being encountered by individuals and organizations on the West Island.

In late October, we met with Alexandre Renaud, the new Senior Regional Engagement Agent for the Quebec and Nunavut Region, at the <u>Office of</u> <u>the Commission of Official Languages</u>, who had contacted us for a "get to know you" exchange.

At the beginning of November, we attended QUESCREN's two-day <u>Inter-</u> <u>Level Educational Table ILET symposium</u> at Concordia University.

Two weeks later, Seniors Action Quebec took a trip to Quebec City to take part in the two-day conference entitled «Journées des partenaires «<u>La</u> <u>lutte pour contrer la maltraitance et la promotion de la bientraitance, c'est</u> <u>l'affaire de tous</u>», organized by the Secrétariat des Aînés. The event was centered around the <u>2022-2027 Action Plan against elder abuse</u> and allowed us to network with other organizations to learn how they are addressing such matters.

Seniors Action Quebec has also renewed contact with its Frenchspeaking counterpart <u>TCAIM</u> (Table de Concertation des aînés de l'île de Montréal) and has been collaborating with them on different projects.

As though all this activity was not sufficient, Seniors Action Quebec has rolled up its sleeves and is in full strategizing mode, looking at best practices and ways of implementing the on-going restructuring and strengthening of the SAQ team to better serve you. More news will be available in time for our next Annual General Meeting to be held in June 2024 – keep an eye open for the official advisory.

UPCOMING WEBINARS in 2024

Our ambitious series of webinars got off to a flying start in September. In partnership with <u>CHSSN</u> and <u>Éducaloi</u> we have addressed matters of great interest to seniors such as mental health issues relating to the COVID-19 pandemic and legal issues revolving around seniors and older adults. In addition, we also embarked on an 8-part series of webinars on issues relating to housing in Quebec and a brand-new set of webinars on various topics on seniors that have come to light.

We shall continue looking at some of these issues in 2024 but will also focus on others.

ONE VOICE COALITION

This Coalition came together pre-pandemic to improve outcomes for English-speaking seniors and the organizations that serve them on the island of Montreal and in the greater Montreal area. However, during the pandemic and lockdown, the coalition had to pivot to assist seniors' access to services and bring assistance to them in their isolation.

Seniors Action Quebec took over management of this coalition in September 2022 and we now act as stewards of the collective. At a recent meeting, SAQ suggested that given the changed circumstances post-COVID, we should examine how the Coalition can move forward to better assist English-speaking seniors. Participants were all in agreement since fundamental questions are in need of clarification and development.

The Coalition, together with our partner, CHSSN, has now decided to reassess its role, mandate and mission. We have therefore begun a series of interviews about the Coalition and how it can develop with as many of the members as possible. These interviews (completely confidential) aim to determine what each participant considers of most importance in the future of the Coalition and are already giving us much food for thought. They will be analyzed and the results reviewed with all participants at a day-long retreat to be held in January 2024.

Together with CHSSN, we have invited all current participants to this retreat where we can present the results of the interviews, what they suggest for the future of the Coalition and propose ways of moving it forward. Facilitators will be on hand to assist us in robust discussions which we believe should culminate in a deeper understanding of the Coalition's role and how it can contribute to better outcomes for English-speaking seniors and the organizations that serve them.

It is our intention to introduce a re-vamped Coalition in 2024 which will be of greater service to English-speaking seniors.

We will advise you of the outcome in due course. Stay tuned!
