

QFHSA 62nd ANNUAL GENERAL MEETING, APRIL 29, 2006 BUSINESS MEETING PROCEDURE

- 1. The Annual General Meeting [AGM] is conducted in accordance with our Constitution, By-Laws and Standing Rules. In the case of any procedural dispute reference shall be made to Robert's Rules of Order Revised.
- 2. Each official voting delegate of each Member Association shall have one vote on any question which comes before the meeting, except for associations more than 250 kilometers from Montreal. Such Associations will still be entitled to three votes, expressed either as an identical or divided vote. Application for such privilege is to be presented in writing to the Executive Secretary prior to the start of the business portion of the Annual General Meeting.
- The quorum for transaction of business at the Annual General Meeting shall be twenty-five percent [25%] of Member Associations in good standing, represented by their official representatives or accredited alternates.
- 4. Voting shall be by ballot or show of hands. All questions shall be decided by a majority of those present and entitled to vote, except those which require a two-thirds [2/3] majority. On ballot votes, the votes of each association shall be handed in by the voting delegates of each association individually but at the same time. Counting of the votes shall be done by non-voting participants.
- 5. A **delegate** may not **speak** for more than two **[2] minutes** on any question under discussion, nor more than twice on any particular motion or resolution. Any person wishing to speak needs to stand and come to the microphone (if we have one).
- 6. Amendments to the Constitution and By-Laws require a two-thirds [2/3] vote of the delegates present and entitled to vote. Notice of the proposed amendments must have been mailed to all Member Associations at least ten [10] weeks prior to the meeting. Modifications to these proposed amendments received two [2] weeks before the AGM will be considered, but no modification may be made from the floor.
- 7. Resolutions to the Annual General Meeting must have been circulated to the Member Associations eight [8] weeks prior to the Annual General Meeting. Resolutions received after the date specified will be presented as Emergency Resolutions only after consideration by the Chairman of the meeting and the Resolutions Committee. Delegates presenting resolutions are reminded that they must be present at the time designated on the agenda for the presentation of their resolution. The presenting party may speak to the resolution, or amendments thereto, for not more than FIVE [5] minutes. In addition to amendments received two weeks before the AGM there may be amendments emanating from the caucus session held earlier, but no further amendments may be made from the floor.

PARLIAMENTARY PROCEDURE

PRINCIPLES

PURPOSE

- Justice and Courtesy for all
- One thing at a time
- Recognition of the will of the majority
- Protection of the rights of the minority

 To conduct business in an orderly and democratic manner by one or more of the following ways:

 communications

- ✓ committee reports
- ✓ motions or resolutions

To participate effectively in the proceedings of meetings, each person needs to know the fundamentals of parliamentary procedure.

THE MAIN MOTION

WHAT IS A MOTION?

A main motion introduces a new item of business; it is a proposal that the group take a certain action. It is the basis of all discussion and states the bounds of discussion. All remarks pertain directly to the contents of the motion on the floor. The making of the motion comes first, discussion follows. A subsidiary motion qualifies the main motion or proposes an alternate timetable for consideration.

WHEN IS A MOTION NEEDED?

- It forms a basis for discussion on all major decisions of the group.
- When in doubt, ask for a motion to be proposed.
- Motions must be made on all matters involving <u>finances</u> not already included in the budget as approved.
- On minor matters, a question may be resolved by the chairman 'taking the sense of the meeting'.
- The decision must be clearly stated for the secretary to report in the minutes as well as for the benefit of the members.

THE STEPS TO PRESENTING A MOTION ARE:

- member stands or raises a hand and says: "Madame Chairman/Mr. Chairman." The chairman recognizes the speaker by name.
- 2. The member says, "I move that", stating or reading a motion.
- Another raises a hand to be identified by the chairman, then says:
 "I second the motion." The seconder believes the motion should be discussed, but <u>may not</u> necessarily be in favour of it.
- 4. Chairman says, "It has been moved by (name of mover) and seconded by (name of seconder) that Is there any discussion?"
- 5. The mover usually speaks first, giving the reasons for the motion. The opportunity to speak to the motion must be given to anyone who wishes to speak to or oppose the motion. Discussion should be addressed to the chairman.
- 6. At the end of the discussion, the chairman says: *"If there is no further discussion" or "Are you ready for the question?"* Then: *"The motion is that" "All in favour?"* (pause while the count is taken by the secretary) *"Opposed?"* (pause while the count is taken by the secretary)

"Abstentions?" (pause while the count is taken by the secretary) "The motion is carried" (or is defeated).

7. If anyone calls "Division" (questions the voice vote), the chair calls for a show of hands or a standing vote: "All in favour raise your hand. All opposed ... " If a majority request it, the vote may be taken by ballot. A "ballot vote" is the recommended procedure for election of officers and for resolving a contentious issue.

SUBSIDIARY MOTIONS

AMENDMENTS CHANGE MOTIONS: To qualify the idea of a motion, but not to change the subject or the intent of the main motion.

1. "I move to amend the motion by":

Inserting or adding a word, phrase or sentence.

Striking out a word, phrase or sentence.

Striking out and inserting a word or phrase or substituting a sentence or paragraph.

- 2. "I second the motion to amend."
- 3. "It has been proposed to amend the motion to read as follows"

The chairman states the main motion and the amendment so the group will understand how the amendment changes the motion. Amendment is handled in the same way as a motion with:

Discussion: "Is there any discussion?"

Question: "If there is no further discussion, the amendment is"

Vote: "All in favour of the amendment"

Chairman announces the outcome:

"The amendment is carried (or defeated)."

"The motion now before the meeting is "

(states the motion plus the amendment(s) if it carried)

In dealing with motions, the vote is taken first on the amendment. If passed, the amended motion is voted on. If the amendment is defeated, the main motion in its original form is voted on.

TO REFER: A question is referred to committee for further study and to submit a recommendation to the group at a later time.

TO TABLE: To set the matter aside until someone moves to reconsider it. **TO POSTPONE DEFINITELY:** Postpone discussion until more facts are available. **TO POSTPONE INDEFINITELY:** The motion may not be considered again that year.

Recommended useful resource materials available for reference during a meeting: A copy of your organization's Constitution and By-Laws. Robert's Rules of Order or other guide to basic rules of parliamentary procedure.

Director Brian Rock was not able to attend. Glenna Uline, Executive Director, was introduced.

The President welcomed guest Bradley Bos, Advisor, Official Languages Support Programs, Canadian Heritage. [Noel Burke, Assistant Deputy Minister for Anglophone Services, MEQ, brought greetings at the luncheon following the meeting. Peter Sheremeta, Provincial Director of the Terry Fox Foundation also spoke at the luncheon meeting about the 25th anniversary of the Terry Fox Run to be held nationwide on September 16th.]

3. ADOPTION OF THE MINUTES OF 2004 AGM (Book of Reports, pages 7-12)

MOTION: Marlyn Brownrigg (Valois Park)/Elena Purser (Lord-Aylmer) to accept the 2004 AGM Minutes in the Book of Reports.

CARRIED

There was no business arising from the 2004 AGM Minutes.

4. <u>PRESIDENT' S REPORT</u> (Book of Reports, pages 13-14)

MOTION: Janet Pelletier (Seigniory)/Brigitte Soucy(Baie Comeau) to accept the President's Report. CARRIED

5. EDUCATION REPORT (Book of Reports, page 33)

Oliver Cole, Chairperson of the Education Committee, presented the report and gave an update on the progress of the School Success Plans survey.

MOTION: Oliver Cole (non-voting participant, St. Monica's School)/Anna Otter (Westpark) to accept the report. CARRIED

6. MEMBERSHIP REPORT (Book of Reports, page 39)

Connie De Giorgio, Membership Chair, spoke to this report. It was noted that several local associations are in danger of losing their status as members of the Federation for failure to fulfill the responsibilities of membership. Some delegates expressed concern about the difficulties of achieving the goal of 10% of family memberships in their schools. It was explained that this is a guideline and that each school is considered on an individual basis taking into account the different factors. QFHSA will try to help a local association experiencing difficulty with low membership and affiliation will not be withdrawn without prior notification. Attendance at such events as the Annual General Meeting and the Fall

Conference are indications that a local association is acting in good faith and is interested in participating in the activities of the Federation.

MOTION: Janet Pelletier (Seigniory)/Cynthia Enright (New Carlisle) to accept the Membership Report. CARRIED

7. <u>CANADIAN HOME & SCHOOL FEDERATION</u> (Book of Reports, page 27)

Donna Norris, Chair, spoke to her report. The CHSF 2005 AGM will be held in Baddeck, Nova Scotia, May 25-29⁻ It is the 110th anniversary of Home and School in Canada. On this occasion Heritage Canada will unveil a plaque recognizing CHSF as an organization of historical significance.

8. <u>LITERACY</u> (Book of Reports, page 36)

Marion Daigle, Literacy Resource Chair, noted that today is the launch of Montreal as the UNESCO-designated World Book Capital for 2005. Montreal is the first North American city to be granted this honour. It coincides with the official opening of the Grande Bibliothèque next Saturday. The *Children and Literacy – A Resource Guide*, developed with the support of a Heritage Canada grant, is nearing completion and will be launched at the Fall Conference next October. Dorothy Nixon, a freelance writer and longtime Home and School member, was thanked for her excellent work in researching and creating this guide.

9. <u>CONSTITUTION</u> (Book of Reports, page 32)

Sylvia Adams, Chair, spoke to the report.

MOTION: Brigitte Soucy (Baie Comeau)/Ane Iacono (LaurenHill) to accept the report. CARRIED

As previously circulated to the Presidents and Voting Delegates, the Constitution Committee recommended three amendments to the By-Laws.

Proposed amendments are *in bold italics*.

9.1 Article III Board of Directors and Officers

1. Board of Directors

a) The Board of Directors shall consist of a maximum of twenty (20) persons, elected at the Annual General Meeting from among the individual/family members of the Federation in good standing, and the Immediate Past President.
 MOTION: Janet Pelletier (Seigniory)/Carmelina Zolla (Gardenview) to accept the proposed Amendment to Article III, Board of Directors.

CARRIED

9.2 Article VII Fiscal Year

The fiscal year of the Association shall start on *April 1* and end on *March 31*. The membership year shall be from September 1 to August 31.

MOTION: Sheila Splane (Lord-Aylmer)/Brigitte Soucy (Baie Comeau) to accept the proposed amendment to Article VII. CARRIED

9.3 Article VIII Banking, Cheques, and Contracts

- 1. The Federation shall open a bank account or accounts with any branch of any chartered *Canadian* bank selected by the Board of Directors.

Statement of Policy and Proposed Resolutions 2005/01 and 2005/02 were previously circulated. Rickhey Margolese, Chair of the Resolutions Committee, spoke to the report.

 - Under the heading EDUCATION, to add: #46 Increased funding for libraries and librarians. [2004/01]

 - #24 Institution of a comprehensive Non-Smoking Policy, for all students in all schools, be developed, enforced and supported. [2004/05]
 - Under the heading MISCELLANEOUS, to add:

Park) to accept the three emergency resolutions for caucusing. [two-thirds majority vote required] **CARRIED**

MOTION: Sheila Splane (Lord-Aylmer)/Anna Otter (Westpark) to recess the meeting until 10:50 for the Caucusing Session and coffee break.

CARRIED

The meeting was called to order at 10:50. Rickhey Margolese presented the Resolutions. A simple majority is required to pass; the procedure for amendments was explained. Additional destinations do not require an amendment.

Vote on Resolutions as circulated and discussed in caucusing sessions.

- 11.4 Student Accident Insurance Policy (Book of Reports, page 48)
 - MOTION: Deb Richardson (Arundel)/Sheila Splane (Lord-Aylmer) to accept the recommendation of the Board of Directors that QFHSA endorse the Reliable Life Insurance Student Accident Plan for the year 2005-2006. CARRIED
- 11.5 **Revised Budget 2005** [previously circulated]
 - MOTION: Leah Trineer (Roslyn)/Arzine Abbas-Brochu (Dunrae Gardens) to accept the Revised Budget 2005. CARRIED [Note: A typographical error in line 13 Provincial Grants Income should be \$20,000 instead of \$40,000. This does not change the column sub-total.]

Balanced Budget

Speaking on behalf of the Board of Directors, the Treasurer noted that the 2005 Budget has a deficit of \$18,600. In order to present a Balanced Budget without using reserved funds, the Board of Directors had made the decision to reduce the expenditures in Line 43, Salaries and related expenses. The contract for the staff position of Executive Director will not be renewed when it expires at the end of June. This position had been created with the understanding that it was contingent upon sufficient funding from non-government sources.

PRESIDENT'S REPORT

Report to the Annual General Meeting, April 29, 2006 Submitted by Donna Norris

The theme for 2004-2005 was **Touching Minds**, Shaping Futures. This coming year the theme will be **The Spirit of the Volunteer**.

Highlights of 2005

- 1. At our 2005 Annual General Meeting, nominations from the floor gave us three new Regional Directors who joined us at the Board of Directors table. They have agreed to stay on as QFHSA Directors for another term.
- 2. In May, three QFHSA directors went to the Canadian Home and School Federation Annual Meeting held in Baddeck, Nova Scotia, to celebrate 110 years of parental involvement in education. An unveiling of a plaque on the site, by the Department of Canadian Heritage, recognized the work Canadian Home and School Federation has accomplished. This recognition is meant for every local Home and School Association across Canada.
- 3. In June we held a Board Orientation weekend to introduce new directors to our Board and to what we are trying to accomplish. The previous March we had held a Funding Diversification Workshop, facilitated by Hugh Maynard and sponsored by Canadian Heritage. We went over the results of that workshop with the new Board members. It was a hard-working weekend, but was very successful. We are continuing to look at ways to diversify our funding and to find partners to join us in some of our undertakings.
- 4. In August, QFHSA held its annual Executive Workshops, for executive members at the local level, at our office. Thirty-one participants, representing sixteen schools, attended workshops given for Presidents, Treasurers, Membership Chairs and Newsletter Editors. The facilitators for these workshops were Norma Stirling, Michelle Armstrong, Marlyn Brownrigg, Oliver Cole, Beverlee Bishundayal and Joanie Beaubien Rossy.
- 5. Our Fall Conference was held October 22nd at Royal West Academy in Montreal West. The large group of RWA H&S volunteers merits a special mention for their efficient and gracious hospitality and organization as the host school. RWA Principal Mary Reynolds's welcoming speech generously credited the Home and School for its exceptional service and contributions to the school.

Our Key Note Speaker, Marion Daigle, launched the *Children's Literacy Resource Guide*, another Home and School initiative, and one that has been a labour of love for Marion Daigle and Dorothy Nixon. Marion spoke on the importance of literacy and gave startling facts regarding illiteracy in Canada. Every participant received a copy of the *Guide* and Marion highlighted some of the contents and provided her audience with ways of using the Guide, in their schools and in their wider communities.

We also had the pleasure of Noel Burke, Assistant Deputy Minister, bringing greetings from the Ministry of Education, Leisure and Sports (MELS) and speaking of his own father's influence in his life: the importance of literacy to his father and the love for reading that was passed on to his children. We had several other special guests attend: Françoise Stake, President of Quebec Provincial Association of Teachers (QPAT); Craig Buchanan & Sandra Munro, Federation of Committees of Parents of Quebec, (FCPQ), and Jacqueline Ritchie from Canadian Heritage, one of our sponsors for this event. Ten workshops were offered. We also held a series of Regional Council meetings. 152 participants attended.

- 6. In November we had an information booth at the QPAT conference, where our new *Children's Literacy Resource Guide* was much in demand. Marion Daigle has scheduled speaking engagements in many schools in Quebec. (She will also be the keynote speaker at the Saskatchewan Association of School Councils Annual Meeting in April 2006.)
- 7. The Canadian Home & School Mid-Term was held in Ottawa in November. Our delegate, Anne MacWhirter, represented us in discussions and decisions at the national table. QFHSA has agreed to take part in their National Substance Abuse Prevention project; our Quebec provincial coordinator will be Elena Purser.
- Our Executives Appreciation Dinner for local Home and School Association Executives was held on February 17th at the Royal St. Lawrence Yacht Club. Once again it was a great success. Stephanie Mitelman was our guest speaker. She presented a very entertaining and informative program on Adolescent Sexuality.
- 9. We continue to work with Home & School Regional Councils and the local Home and Schools. We visited local schools when asked and several Regional Council meetings were also attended by directors.
- 10. We have received a project grant from Canadian Heritage to host three Regional Parent Conferences off-island. The three areas are Chateauguay, Eastern Townships and the Gaspé. Topics included Parenting Today's Youth, Teenage Sexuality, Literacy, Your Child's Self Esteem and Substance Abuse Prevention.
- 11. We partnered with McGill University in a Conference on Bullying held March 27, 2006. The evening panel discussion was on "The Role of Parents and Guardians in Protecting Children from Bullying". Norma Stirling, a past QFHSA President, was the moderator and our Pat Waters spoke on the role of the parent or guardian. The other panelists were Senator Landon Pearson, an MUC police officer, Nancy Knight and her son (a family victimized by bullying). The cost was \$25 per family.
- 12. I continued to represent us at the Quebec Community Groups Network (QCGN), and at the Ministerial Consultations this year (and have gone into more detail in the QCGN Report).
- 13. I would like to acknowledge and thank Michelle Armstrong, Anne MacWhirter, Marg Funnell, Oliver Cole, Beverlee Bishundayal, Debi Brown, Brian Rock, Harold Spanier, Ane Iacono, Connie De Giorgio, Leah Trineer, Marlyn Brownrigg and Joanie Beaubien Rossy for their dedication and hard work this past year. I would also like to mention the hard working and always appreciated staff of QFHSA: Donna Sauriol, Carol Ohlin. The support and teamwork of both the directors and staff made a very busy year enjoyable.

AUDITORS' REPORT

To the Members of QUEBEC FEDERATION OF HOME AND SCHOOL ASSOCIATIONS

We have audited the statement of financial position of Quebec Federation of Home and School Associations as at December 31, 2005, and the statements of revenues and expenses and cash flow for the year then ended. These financial statements are the responsibility of the Associations' management. Our responsibility is to express an opinion on these financial statements based on our audit.

Accordingly, our verification of these revenues was limited to the amounts recorded in the records of the Association and we were not able to determine whether any adjustments might be necessary to revenues and net assets.

In our opinion, except for the effect of adjustments, if any, which we might have determined to be necessary had we been able to satisfy ourselves concerning the completeness of the non-government revenues and contributions referred to in the preceding paragraph, these financial statements present fairly, in all material respects, the financial position of the Association as at December 31, 2005, and the results of its operations and its cash flow for the year then ended in accordance with Canadian generally accepted accounting principles.

NOTES TO FINANCIAL STATEMENTS

AS AT DECEMBER 31, 2005

1. NATURE AND PURPOSE OF THE ASSOCIATION

The Quebec Federation of Home and School Associations is an incorporated, independent, not-for-profit volunteer organization dedicated to enhancing the education and general well being of children and youth. It promotes the involvement of parents, students, educators and the community at large in the advancement of learning and acts as a voice for parents.

2. ACCOUNTING POLICIES

a) Revenue Recognition

The Quebec Federation of Home and School Associations follows the deferral method of accounting for program and history and archive grant and membership fees.

Membership fees are received mostly in the fall of each year and are taken into revenue over the period from September to the following August.

Program funding and grants are received from Federal and Provincial agencies for various donor fiscal years and are taken into revenue over each donor's fiscal year.

History and archive grant revenue is recognized to the extent of the costs which are expensed in any given year.

b) Expensing Capital Purchases

The Association expenses all purchases of a capital nature.

c) Contributed Services

Volunteers at the Federation level contribute approximately 18,150 hours per year to assist the Federation in carrying out its activities. Because of the difficulty in determining their fair value, contributed services are not recognized in the financial statements.

3. FUNDS HELD IN TRUST

The Association has funds in trust amounting to \$5,100 which represents the original contributions of \$ 5,000 made by three donors, who requested that the interest earned on the funds in trust be used to pay for awards given out at the annual general meeting. A committee is appointed to consider all submissions for the awards, and to choose the ones, they consider best, meet the guidelines.

CANADIAN HOME AND SCHOOL FEDERATION (CHSF) Central Vice-President Report Report to the Annual General Meeting, April 29, 2006 Submitted by Michelle Armstrong, Central Vice-President

Over the past year, many partnerships have been created with other national organizations and several more are on the rise: Canadian Association of Health, Physical Education, Recreation and Dance (CAPHERD), Media Awareness Network (MNET), Family Services Canada, and The Learning Partners. Communication between the provincial members has increased over the past year making the Home and School support network stronger.

CHSF has been granted a contribution agreement from Health Canada to support a Substance Abuse Train-the-trainer project that has already begun to spread across Canada. This is an area where the Home and School excels at getting important information to parents from one edge of our country to the other. Partnerships are being formed in the three territories for this project and we are hopeful that they may consider becoming CHSF members in the future. Due to the magnitude of this project, CHSF now has a full time office coordinator.

CHSF has joined Imagine Canada whereby the Board of Directors has taken the oath to ethical financial practices. More information on this important measure can be viewed on <u>www.imaginecanada.ca</u>.

The new membership fee that has been put into place as of the Annual Meeting 2005 has all CHSF provincial members paying the same fee of \$2,150. Some provinces which were fortunate to be able to pay more than that in the past have graciously agreed to continue to support CHSF by making a donation of the balance. This new membership fee helps create a more balanced effect within the Board of Directors and also demonstrates the importance of being a member of CHSF.

The new CHSF information brochure that was created last year is in the process of being printed and will be made available to the provincial members in the near future. This important piece of communication will lend aid to the provincial members for their campaigns as a means of stressing the importance of belonging to and supporting a national parent organization. The CHSF website continues to be updated regularly to ensure the most current information for members all across Canada.

The Annual General Meeting for 2006 will be held in Fredericton, New Brunswick, in May. Executive positions available for nominations are Western Vice-President and Central-Vice President.

Mandate The Editorial Board is meant to oversee content of our newspaper and the website.

There were four regular issues put out last year, of 16 pages each. Circulation has remained steady and the average paid distribution is 5,900; average total distribution of a single issue is 7,600, up slightly from last year. Local associations are welcome to have extra copies of our newspaper at no extra cost.

The Education Committee did not produce an updated, bilingual insert of *MEQanics*, which dealt with questions parents have about the workings of the Ministry of Education. This was originally compiled and translated in 2002 by our Education Committee and updated in 2003. They were considering updating it for 2005, but this did not materialize.

The locals are asked to send in their own school newsletters for inclusion in their section of the paper, *Focus on the Locals*. Even if you don't have a writer on your team, your newsletter will enable us to let other parents know what exciting things are happening at your school and to "steal" any ideas that appeal to them. Diane Radu is Editor of *Focus on the Locals* and also judges the schools' newsletters for us.

The NEWS is grateful to our regular contributors: AMCAL Family Services, Shirley Straughton (Health Issues), Don Smith (Safety Issues), Joanie Beaubien-Rossy (Membership), Canadian Home & School Federation's President, Georgina Allen, and Donna Norris, QFHSA President. And, this past year, fairly regular contributions from Martha Farley, DM Family and School Services, and Dorothy Nixon.

Annual General Meeting 2005

As recommended by the Constitution Committee, the delegates of the Annual General Meeting approved the following amendments to the By-Laws:

Article III Board of Directors and Officers

- 1. Board of Directors
 - a) The Board of Directors shall consist of **a maximum of twenty (20)** persons, elected at the Annual General Meeting from among the individual/family members of the Federation in good standing, and the Immediate Past President.
- Article VIIFiscal YearThe fiscal year of the Association shall start on April 1 and end on March 31.The membership year shall be from September 1 to August 31.Article VIIIBanking, Cheques, and Contracts
 - 1. The Federation shall open a bank account or accounts with any branch of of any chartered **Canadian** bank selected by the Board of Directors.

Annual General Meeting 2006

It has come to the attention of the Constitution Committee that two sections of the By-Laws were not included in the 1999 revision of the Constitution and By-Laws.

These sections concerned the voluntary dissolution of local home and school associations and school closures.

Great changes are presently occurring in Quebec. School boards are reacting to declining enrolments by closing and/or amalgamating schools that have served particular communities for many years. This phenomenon will drastically impact longstanding Home and School associations.

For these pivotal reasons, the Constitution Committee recommends the reintegration into the By-Laws, Article II, Membership and Fees, of #7 and #8 and asks the voting delegates at this Annual Meeting to approve the By-Law Amendments submitted.

The Educaton Committee held 4 meetings during 2005-2006 with the following priorities:

- <u>Collection of School Success Plans and Education Projects.</u> David Harries has made efforts to collect additional school success plans from Home and School Associations.
- <u>The increasing drop out rate and reforming vocational training starting in grade 9</u>.

 I attended the Conference, *Reflections: To Analyze the Reasons for the High Dropout Rates Among English Speaking Black Students in Quebec Schools*, organized by the Black Coalition of Quebec in collaboration with the English Montreal School Board, and The Ministère de l'Éducation du Loisir et du Sport. The conference brought together participants from various disciplines and organizations for four workshops focusing on issues affecting English Speaking Black Students in Quebec Schools. Some of the recommendations that came from the conference workshops were: Better communication mechanisms between schools and parents, more support for parents, more tutorial services at school and in the community for students at risk, easier access for parents and students wanting to enter vocational studies, and greater efforts to have cultural sensitivity, relevance and representation in school curriculum.
- <u>Resolution 1973/3 regarding availability and confidentiality of student records</u>. The committee reviewed this resolution with respect to the request by school boards of parents' scholarity information on student verification forms. We also reviewed and discussed a more recent resolution, 1991/1 on Nominative Information.
- Resolution 1994/4 Vocational Education for Youth

The committee updated this resolution with Resolution 2006/2 Technical/Vocational Education for Youth. The committee met on January 20, 2006: with Guest Marsha Gouett from English Montreal School Board, who works in collaboration with MELS on GOAL program and Hans Heisinger, Executive Director of Carrefour Jeunesse Emploi, NDG, and Katherine Korakakis, Carrefour Jeunesse Emploi, NDG Entrepreneurial Community Agent.

Children's Literacy Resource Guide

Marion Daigle kept the committee informed of developments of the *Children's Literacy Resource Guide* which was launched at the QFHSA 2005 Fall Conference. Resolution 2006/3 *Children's Literacy Resource Guide* is brought forward to meet the challenge of the 21st century knowledge-based society with a need for greater level of literacy skills and lifelong learning.

FINANCE COMMITTEE

This year the Finance Committee was focussed on bringing in a balanced budget by increasing revenues and decreasing expenditures.

There have been several discussions on how to obtain corporate funding. It is the consensus of the committee that our newspaper, the QFHSA NEWS, is our best vehicle for increasing corporate funding and we are working on a plan to implement this.

One time funding was received to complete two specific projects - a Board Development session that focussed on raising awareness of and funding for QFHSA (March 2005) and Community Parenting Workshops (March 2006) in three regional areas outside of Montreal. We thank Donna Norris and Michelle Armstrong for taking on this valuable membership development project.

We also thank Margaret Funnell for her ongoing dedication in preparing the annual program grant application from Canadian Heritage Minority Languages Department.

We are cognizant of the fact that school enrolment is declining along with the number of schools. Therefore, as we go forward, the Committee will continue to seek out increased revenues, other than increasing membership fees, while continuing to provide the services our members have come to value from QFHSA in these troubling times.

Recommendation

That the QFHSA family membership fee for 2006-07 be maintained at \$16.00.

FUNDRAISING

The Pediatric and Adolescent Trauma Program of the Montreal Children's Hospital of the MUHC provided pamphlets free of charge to QFHSA on the subject of "Returning to Sports After an Injury". Many thanks to Debbie Friedman, coordinator of the program.

HIGHLIGHTS

Chickenpox

After years of warning parents about the side effects of chickenpox and encouraging the chickenpox (varicella) vaccine, this committee saw the Quebec Minister of Health, Philippe Couillard, announce in January 2006 that the varicella vaccine is now included in the Quebec vaccination schedule. It will be covered by Quebec Medicare and therefore free of charge to all those who qualify for Medicare. This is a huge step in the right direction to the reduction of vaccine preventable illnesses.

Cardio-Pulmonary Resuscitation Program

Mr. Couillard is also supportive of another of this committee's endeavors. He has observed the High School CPR Program in action and was very impressed. This was a QFHSA initiative in 1997 in collaboration with the ACT Foundation (Advanced Coronary Treatment Foundation of Canada). Plans are underway to set up this program in 250 high schools in Quebec. Presently 50 schools have implemented the High School CPR Program.

HISTORY / ARCHIVES PROJECT

Part 2 of the Archives Project is now completed. There are now 60 boxes in the archive collection and further work is still to be done. We need further funding to continue. Principal Activity - 2005-06

Children's Literacy Resource Guide Launch

Fall Conference – October 22, 2005

- <u>Keynote address</u> Marion Daigle gave a historical background re CHSF (Canadian Home & School Federation) and QFHSA emphasizing their strong commitment to literacy, in order to strengthen the context in which to launch the Guide. Many examples of practical strategies were outlined to highlight how families, community organizations, teachers and individuals can facilitate the Guide to meet their needs.
- <u>Ready! Set! Go!</u> a follow up workshop was ably handled by Anne MacWhirter and Harold Spanier, QFHSA directors, both of whom have wide experience with literacy activities. Facilitator Marion Daigle.

<u>November/December</u> – a huge mailing included: all Home & School Associations not at the conference, Quebec literacy organizations, *Guide* contributors, educational and community organizations, CHSF, individuals, teachers, principals, out-of-province requests.

This project was funded by the Department of Canadian Heritage.

Other Important Activities

- 1. June 9, 2005 Grenville Elementary Marion Daigle visited their new larger library. Home and School Past President Kathy Ivall is the library co-ordinator.
- September 8, 2005 (International Literacy Day) Center for Literacy of Quebec Giant Book Sale launch – attended by Donna Sauriol, Carol Ohlin and Marion Daigle. A gift certificate of \$400 was presented to QFHSA. An additional \$400 was given later. Books purchased go to Fall Conference participants and for school visits.

- October 28, 2005 John Abbott College Information and Library Technologies Department. Marion Daigle gave her annual workshop for 26 students. The focus was on the *Guide*. The JAC \$150 honorarium was given to a school library technician.
- <u>November 17, 2005 Roslyn Elementary School</u> Marion Daigle gave a workshop for teachers and community representatives on the *Children's Literacy Resource Guide*.
- <u>November 18, 2005 Teachers Convention</u> Anne MacWhirter, Alan MacMillan and Marion Daigle hosted a very busy information table with a special focus on the *Resource Guide*.
- January 27, 2006 Roslyn Elementary Family Literacy Day Using ideas from the new *Guide*, Principal Jim McMorran and Leah Trineer, representing the Home and School Association, organized an outstanding Family Literacy Day school assembly. In addition 16 families with newborns were presented with beautiful Born to Read bags, funded by the Home & School Association. The EMSB (English Montreal School Board) organized media coverage.

January 27, 2006 – Family Ties New Carlisle Literacy Day Celebration Anne MacWhirter presented the program Your Child Can Succeed in School – and You as Parents Can Help using pages from the Children's Literacy Resource Guide.

 The second successful annual celebration was held at the school library, sponsored by the
 Home and School Association and the school. Marion Daigle and Myrna Guy were co ordinators. 28 families with 30 children received beautiful Born to Read bags.

Background

After initiating the consultation process with its elementary schools in September 2005, the Lester B. Pearson School Board Council of Commissioners voted on its decision on January 12, 2006: a plan to close six elementary schools, to merge many other schools, and to move more than 2,000 students. It is estimated that 23 Home and School Associations will be affected by the closures and mergers, which is more than a thousand of our family members and approximately 30% of our total membership.

At the January Board of Directors meeting, the *ad hoc* Transition Committee was created to monitor the affects of the LBPSB Major School Change and to assist our local associations in the process.

Action

An information meeting was held on March 14, 2006. Invitations were extended to the 23 Home and School Associations and three other schools affected by the Major School Change. Representatives from thirteen schools attended. The agenda included discussion on the financial implications, inventory of donations, history and archives, end-of-year activities.

It was emphasized that it is extremely important that local associations keep accurate records since the current associations will be closed and will re-open with new names and possibly new locations depending upon the individual situations. <u>Copies of all decisions and documents should be signed, dated, and forwarded to QFHSA</u>:

- 1. Final financial statements, signed and dated by the President & Treasurer, and a financial report to the school families.
- 2. Inventory and disposal of purchases (Moveable Property).
- 3. Termination of contracts.
- 4. Transfer of funds to new bank accounts or in temporary trust to QFHSA.

Archival materials should be catalogued and retained.

Closing schools will be honoured at the Annual General Meeting.

The Committee will continue to monitor the situation and act as necessary.

Recommendations to the Annual General Meeting 2006

- Resolution 2006/1 Wider Access to English Education
- Constitution and By-Laws, Article II, Membership and Fees, Sections 7 and 8: To reintegrate these two sections setting procedures for dissolution and closure of local associations which were in previous versions of the Constitution.

The press releases were sent out in mid-October to <u>The Montreal Gazette</u>, <u>CFCF News</u>, <u>Global News</u>, <u>This Morning Live</u>, <u>CBC News/Canada Now</u>, <u>CBC Radio</u>, and twenty-eight community newspapers across Quebec. These recipients were also mailed an invitation to the Fall Conference, the table of contents and some sample pages from the *Children's Literacy Resource Guide*.

B. C.A.C.E. Meetings

 C.A.C.E.'s AGM in 2005 was held in Ottawa from November 5th -7th. Unfortunately, QFHSA did not send a delegate as the majority of the seminars were not relevant to QFHSA's mandate. This year's AGM will be held in St. John's, Newfoundland from October 15th - 17th, 2006. The next Montreal/Quebec Chapter meeting is scheduled for March 24th, 2006 at CBC-Radio Canada where we will meet with members of the radio and television departments to discuss educational issues and have a tour of the facilities.

Executive Workshops

In August the annual Executive Workshops were held for local association presidents, treasurers, and membership chairpersons. This event is another opportunity for executive committees to meet each other and to share ideas and information. Kits containing materials to facilitate the work of the local association were distributed.

Membership Page in the QFHSA NEWS

Each issue of the NEWS has a membership page with ideas, up-dates, articles about schools and a message from the membership chairperson.

Major School Change - Membership ad hoc Transition Committee

The Lester B. Pearson School Board announced on January 12/06 its decision to close six buildings, and shift 2,300 students in 14 elementary schools. This Major School Change will affect 19 of our local associations. The Membership *ad hoc* transition committee prepared a plan of action, distributed a recommended list of procedures, and hosted an information meeting. It is expected that these changes have the potential to create significant impact on our membership.

Membership Fee

As approved by the delegates at the 2005 Annual General Meeting, the family membership fee for this year was \$16. It is not expected to change for 2006/07.

MOTION

To ratify the decision of the Board of Directors' meeting of January 14, 2006, to terminate the affiliation of the following Home and School associations for failure to submit memberships and fees by February 1: Eardley Elementary, Philemon Wright High School, and Terry Fox Elementary (Pierrefonds). [as required by the Standing Rules, Article II, Section 2]

Note: Warning letters were sent in February to those local associations with low membership.

Mandate:

to prepare the application for the Department of Canadian Heritage [DCH] Program funding; to participate at meetings of and communicate with the Quebec Community Groups Network [QCGN]; to prepare programs and outreach for off-island communities; to apply for other projects that may from time to time be funded by CANHER; to produce new or revised promotional materials linked to membership development; in addition a member sits on the Finance Committee.

QFHSA is a member of the QCGN whose five-year agreement with the Federal Government for the disbursement of the Official Languages Communities Support Program funds was renewed a year ago in April. QCGN members sign a contract with the Department of Canadian Heritage for the Program grant and for any Project grants. The Quebec Federation of Home and School Associations [QFHSA] President plus one other member represent QFHSA at the QCGN meetings across the Province.

In April 2005, QFHSA again received DCH Program funding, this time increased by 12.5% over the year before. The results-based management requirement means detailed reports are linked to the instalment payments given out during the year. QFHSA has applied for Program funding for 2006/2007. A special Project grant will provide three off-island Regional Parent Workshops to supplement the Program ones already planned.

The DCH Program funding plus membership revenue and a Ministry of Education, Leisure and Sport [MELS] grant are QFHSA's main sources of revenue. The Program funding allowed QFHSA, amongst other outreach activities:

a] to bring parent members from off-island Home and School Associations in more remote areas to its workshops, Fall Conference and Annual General Meeting. It helped subsidize important Regional Council meetings off-island, for example in Western Quebec and Eastern Shores, in addition to meetings held in Montreal at the time of the Fall Conference and AGM.

b] to subsidize cost of PALS Plus workshops and visits by QFHSA representatives, when requested, to local and potential Associations to elaborate our services and offer support.

c] to publish four issues per year of the Quebec Home & School NEWS, provide important materials both for the Fall Conference and AGM and to print and distribute membership material including pamphlets on Why a Home and School is Important and on Homework.

d] to network with educational and community partners where we interact with parent representatives and volunteers, educational, social and health professionals, and other community personnel. This included among many activities, the Canadian Home and School Federation [CHSF] Annual Meeting at Baddeck, NS, and mid-term meeting in Ottawa; Born to Read and other literacy activities; a March panel on Bullying and Schools at the McGill Conference on Bullying, and attendance at the Network Lunches on Montreal's West Island where the community partners meet for talks on topics of high importance to the well-being of youth.

NOMINATIONS COMMITTEE

Nominees must be paid-up members in good standing. [QFHSA By-Laws Article VI, 4]. Nominations should be signed by at least two, and preferably three, persons from the Local Association and/or the QFHSA Board of Directors.

Deadline

The deadline for receiving nominations to be voted on at the AGM is March 27, 2006. Nominations received after that date would be considered by the Board of Directors for appointment. (QFHSA Standing Rules Article VII, 3.)

Officers of the Federation

According to our By-Laws [Article II, 2 (a)] "The officers of the Federation shall be elected annually at the Annual General Meeting from among the Directors of the Federation." These positions can be nominated from the list of present Directors as well as from the list of newly-nominated Directors.

QUEBEC COMMUNITY GROUPS NETWORK REPORT (QCGN)

Report to Annual General Meeting, April 29, 2006 Submitted by Donna Norris, President

- This year was a year of change and celebration for the Quebec Community Groups Network (QCGN). In May QCGN celebrated its 10th Anniversary of service to the English Speaking Community.
- 2. QCGN was a signatory to the contribution agreement with Health Canada and responsible for the administration of the \$4.7 million that was being invested in the English-speaking community over a five-year period for the Health and Social Services Networking and Partnership Initiative (HSSNPI).
- 3. QCGN was becoming increasingly involved in consultations with various departments, such as Industry Canada, Justice Canada and the Privy Council. QCGN participation on the Consultative Committee for English-speaking Minority Communities (health and social services), the Justice Department's advisory committee and the National Coordination Committee (PCH and the English-speaking communities).
- 4. During the past year the QCGN has completed and endorsed its Strategic Plan as well as the Community Development Plan. The Strategic Plan was endorsed this year by QFHSA and the 23 other community groups that are members of QCGN. The Community Development Plan that had been in progress for the last three years will provide the community with the tools required to further its development. We would like to acknowledge the support of PCH in respect to the Community Development Plan and the Strategic Plan, and thank PCH officials at the regional and national offices.
- 5. An invitation from the Official Languages Intergovernmental Affairs from the Office of the Privy Council was extended to QFHSA President to participate in the Ministerial Consultations held in Ottawa on October 26th & 27th. The midpoint of the "Dion Action Plan for Official Languages" was the issue of this consultation. The Honourable Mauril Bélanger, Deputy Leader of the Government in the House of Commons, the Minister responsible for Official Languages, Minister for International Trade, Minister Responsible for Official Languages, and Associate Minister of National Defence, welcomed participants to the third ministerial consultations for minority language communities. The moderator was Ms. Anne Scotton, Director General, Official Languages, Privy Council Office. Minister Bélanger put forth the following two questions;
 - How do we work together to implement the Horizontal Results-based Management and Accountability Framework?
 - How do we complete the implementation of the Action Plan in order to better position ourselves for its renewal?

Throughout the consultation the second question was addressed. Organizations seemed to have a better understanding of the question and are still unsure how to proceed with Horizontal Results-based Management and Accountability Framework. The delegates who were addressing the panel of Ministers were given two minutes each to bring forward praise, or our dissatisfaction, with how we were proceeding and/or what we felt had been accomplished.

Martin Murphy President of QCGN made the closing remarks for the English-speaking community and Jean–Guy Rioux, President of Fédération des communautés francophone et acadienne made the closing remarks for the Francophone group. The session ended with Minister Bélanger's closing remarks. All participants were invited to the House of Commons the next morning to see the Action Plan for Official Languages document tabled. We were also invited by the Honourable Mauril Bélanger to a celebration lunch that took place at the House of Commons West Block.

- 6. Norma Stirling joined me at the QCGN table this year. We have attended a three-day meeting in Montreal and another in Quebec City. In June QCGN will be having its 11th AGM. Both Norma and I will be attending to represent QFHSA.
- 7. In Quebec City on March 23rd 2006, I attended another Ministerial Consultation representing QFHSA. These consultations bring you face to face with QFHSA Government Partners. All QGCN members are represented and a dialogue between the Government Partners and the Non-Profit Organizations takes place. The dialogue between us is important and can help determine the Federal Government's commitment to the Official Language Law. It is essential that our government partners hear what we, as an English-speaking minority, think, feel and require in order to have thriving English-speaking communities throughout the Province of Quebec.
- This year QCGN and Canadian Heritage have made it possible for QFHSA to have Regional Parent Conferences in the Gaspé, Eastern Townships and the Chateauguay Valley region.

1945 - First issue of the Quebec Home & School NEWS put out as a mimeographed newsletter. It has been published as a newspaper/magazine continuously since 1948.

2000s

2000 - Parental Advocacy Project begun with a grant from Canadian Department of Heritage. 2002 - "Come Read With Mel" contest in collaboration with Office of Commissioner of Official Languages and Literacy Partners of Quebec.

1990s

1994 - PALS (Parents Assist Learning and Schooling) - bilingual workshops introduced through the Canadian Home & School.

1997 - Lewis Peace Prize established to honour an individual or group that actively contributes to a safe and peaceful school community, or world.

1980s

1980 - Verv successful STOP/ARRÉT bumper sticker campaign highlighting safety.

1988 - TEACHER APPRECIATION WEEK became an annual event across Canada.

1950s 1950 - Quebec Federation inaugurated the Leslie N. Buzzell Award for outstanding service to The Federation and for furthering the aims of

Home & School and education. 1954 - Quebec Federation's Insurance Committee instrumental in introducing Student Accident

Insurance in the province.

1960s

1962 - Quebec Royal Commission of Inquiry on Education established (Parent Commission). QFHSA presented a 45.000 word brief to the Commission, containing 176 recommendations, based on a poll of local associations.

1966 - QFHSA statement regarding guidance services in schools.

1968 - QFHSA received the first Quebec Community Safety Award for its con-

tribution to the development of an effective safety program.

1973 - Gordon Paterson Award (named for the first President of QFHSA) established to recognize an outstanding educator who has encouraged the participation of parents in education.

1977 - Brief to Secretary of State requesting accountability of federal funds granted to provinces for minority and second language instruction.

> 1978 - Quebec Federation, with 17 co-plaintiffs, filed writ in Quebec Superior Court, challenging the constitutionality of Bill 101.

1979 - Federation granted status as a registered charity.

1970s

OFHSA's Literacy Awareness Programs

Begun in 1990 to celebrate International Year for Literacy, the Canadian Home and School Federation initiated a major Literacy in the Information Age awareness and activity campaign. OFHSA continues to actively promote: Born to Read/Le Goût de Lire, school and community libraries. "Come Read With Mel" wriing contest, family literacy programs, book drives, etc., throughout the province. Many small rural English language communities, in particular, benefit from the financial support for material resources.

The growing importance and recognition of the Federation, particularly in educational circles of the province is proven by the fact that a growing number of organizations have co-operated with Federation on the one hand and have requested and received Federation's co-operation and advice on the other.
