# ACTION PLAN FOR OFFICIAL LANGUAGES 2018–2023

#### Official languages in Canada

#### A central characteristic of Canadian identity

- Powerful symbol of our diverse and inclusive society
- Linguistic duality is a founding principle of Canada
- Essential tools for integration, inclusion, learning and dialogue

## **Listening to Canadians**

#### Cross-Canada consultations were held from June to December 2016

- More than 7,000 Canadians were heard
- 22 round tables in multiple Canadian cities, six of which were broadcast live on the Web
- 6,375 people replied to online questionnaires and more than 100 submissions and letters were received

#### Reports from Parliamentary Committees were considered

➤ The final report on the 2016 Cross-Canada Official Languages Consultations was presented in June 2017.

## Concerning trends

#### Decreasing demographic weight of the Francophone population across Canada\*

• The relative weight of the Francophone population outside Quebec is expected to drop from 3.8% in 2016 to 3.0% in 2036, down from 6.1% in 1971

#### Low rate of bilingualism among Canadians\*

- A modest projected increase in bilingualism will come mainly from Francophones and English-speakers in Quebec
- The rate of bilingualism among English-speakers outside Quebec is expected to remain very low:
  - from 6.8% in 2016 to 6.7% in 2036

➤ Despite significant gains, these concerning trends indicate that current efforts are insufficient to maintain the vitality of our official languages

#### Objectives of the 2018–2023 Action Plan

Restore the proportion of Francophones living in linguistic minority communities to 4% by 2036

Promote the vitality of English-speaking communities in Quebec (ESCQ), particularly in regions outside of Montreal

#### By 2036, increase the bilingualism rate

- of English-speakers outside Quebec from 6.8% to 9%
- of the Canadian population from 17.9% to 20%


