QFHSA 66th ANNUAL GENERAL MEETING – April 24, 2010 BUSINESS MEETING PROCEDURE

- 1. The **Annual General Meeting** [AGM] is **conducted in accordance** with our Constitution, By-Laws and Standing Rules. In the case of any procedural dispute reference shall be made to Robert's Rules of Order Revised.
- 2. Each official voting delegate of each Member Association shall have one vote on any question which comes before the meeting, except for associations more than 250 kilometers from Montreal. Such Associations will still be entitled to three votes, expressed either as an identical or divided vote. Application for such privilege is to be presented in writing to the Executive Secretary prior to the start of the business portion of the Annual General Meeting.
- 3. The quorum for transaction of business at the Annual General Meeting shall be twenty-five percent [25%] of Member Associations in good standing, represented by their official representatives or accredited alternates.
- 4. Voting shall be by ballot or show of hands. All questions shall be decided by a majority of those present and entitled to vote, except those which require a two-thirds [2/3] majority. On ballot votes, the votes of each association shall be handed in by the voting delegates of each association individually but at the same time. Counting of the votes shall be done by non-voting participants.
- 5. A **delegate** may not **speak** for more than two [2] **minutes** on any question under discussion, nor more than twice on any particular motion or resolution. Any person wishing to speak needs to stand and come to the microphone (if we have one).
- 6. Amendments to the Constitution and By-Laws require a two-thirds [2/3] vote of the delegates present and entitled to vote. Notice of the proposed amendments must have been mailed to all Member Associations at least ten [10] weeks prior to the meeting. Modifications to these proposed amendments received two [2] weeks before the AGM will be considered, but no modification may be made from the floor.
- 7. Resolutions to the Annual General Meeting must have been circulated to the Member Associations eight [8] weeks prior to the Annual General Meeting. Resolutions received after the date specified will be presented as Emergency Resolutions only after consideration by the Chairman of the meeting and the Resolutions Committee. Delegates presenting resolutions are reminded that they must be present at the time designated on the agenda for the presentation of their resolution. The presenting party may speak to the resolution, or amendments thereto, for not more than FIVE [5] minutes. In addition to amendments received two weeks before the AGM

there may be amendments emanating from the caucus session held earlier, but no further amendments may be made from the floor.

PARLIAMENTARY PROCEDURE 2010

PRINCIPLES

PURPOSE

- Justice and Courtesy for all
- One thing at a time
- the Recognition of the will of the majority
- Protection of the rights of the minority

To conduct business in an orderly and democratic manner by one or more of following ways: communications

committee reports motions or resolutions

To participate effectively in the proceedings of meetings, each person needs to know the fundamentals of parliamentary procedure.

THE MAIN MOTION

WHAT IS A MOTION?

A main motion introduces a new item of business; it is a proposal that the group take a certain action. It is the basis of all discussion and states the bounds of discussion. All remarks pertain directly to the contents of the motion on the floor. The making of the motion comes first, discussion follows. A subsidiary motion qualifies the main motion or proposes an alternate timetable for consideration.

WHEN IS A MOTION NEEDED?

- It forms a basis for discussion on all major decisions of the group.
- When in doubt, ask for a motion to be proposed.
- Motions must be made on all matters involving <u>finances</u> not already included in the budget as approved.
- On minor matters, a question may be resolved by the chairman 'taking the sense of the meeting'.
- The decision must be clearly stated for the secretary to report in the minutes as well as for the benefit of the members.

THE STEPS TO PRESENTING A MOTION ARE:

1. member stands or raises a hand and says:

"Madame Chairman/Mr. Chairman."

The chairman recognizes the speaker by name.

- 2. The member says, "I move that...", stating or reading a motion.
- 3. Another raises a hand to be identified by the chairman, then says:

 "I second the motion." The seconder believes the motion should be discussed, but may not necessarily be in favour of it.
- 4. Chairman says, "It has been moved by (name of mover) and seconded by (name of seconder) that..... Is there any discussion?"
- 5. The mover usually speaks first, giving the reasons for the motion. The opportunity to speak to the motion must be given to anyone who wishes to speak to or oppose the motion. Discussion should be addressed to the chairman.
- 6. At the end of the discussion, the chairman says:

```
"If there is no further discussion . . . . . . . " or "Are you ready for the question?" Then:
```

"The motion is that "

"All in favour?" (pause while the count is taken by the secretary)

"Opposed?" (pause while the count is taken by the secretary)

"Abstentions?" (pause while the count is taken by the secretary)

"The motion is carried" (or is defeated).

7. If anyone calls "Division" (questions the voice vote), the chair calls for a show of hands or a standing vote: "All in favour raise your hand. All opposed ... " If a majority request it, the vote may be taken by ballot. A "ballot vote" is the recommended procedure for election of officers and for resolving a contentious issue.

SUBSIDIARY MOTIONS

AMENDMENTS CHANGE MOTIONS: To qualify the idea of a motion, but not to change the subject or the intent of the main motion.

1. "I move to amend the motion by":

Inserting or adding a word, phrase or sentence.

Striking out a word, phrase or sentence.

Striking out and inserting a word or phrase or substituting a sentence or paragraph.

- 2. "I second the motion to amend."
- 3. "It has been proposed to amend the motion to read as follows "

The chairman states the main motion and the amendment so the group will understand how the amendment changes the motion. Amendment is handled in the same way as a motion with:

Discussion: "Is there any discussion?"

Question: "If there is no further discussion, the amendment is "

Vote: "All in favour of the amendment...."

Chairman announces the outcome:

"The amendment is carried (or defeated)."

"The motion now before the meeting is "

(states the motion plus the amendment(s) if it carried)

In dealing with motions, the vote is taken first on the amendment. If passed, the amended motion is voted on. If the amendment is defeated, the main motion in its original form is voted on.

TO REFER: A question is referred to committee for further study and to submit a recommendation to the group at a later time.

TO TABLE: To set the matter aside until someone moves to reconsider it.

TO POSTPONE DEFINITELY: Postpone discussion until more facts are available. **TO POSTPONE INDEFINITELY:** The motion may not be considered again that year.

Brian Peat, Central Vice-President of the Canadian Home and School Federation, was unable to attend. He sent an excellent message which was read by Vice-President Marlyn Brownrigg, the QFHSA delegate to CHSF.

WELCOME AND INTRODUCTIONS

The meeting was chaired by President Debi Brown. She welcomed everyone and introduced those at the Head Table: Barbara Milne-Smith, Past-President of QFHSA and a Life Member of Canadian Home & School Federation, serving as Parliamentarian; Anne MacWhirter, Director, Time Keeper; Marlyn Brownrigg, Vice-President, Speakers List; Carol Ohlin, Recording Secty.

The remaining Directors were also presented to the delegates and thanked for their services: Beverlee Bishundayal, Secretary; Oliver Cole, Treasurer, and Directors: Liette Chamberland, Diana Donnelly, Rickhey Margolese, Carol Meindl, Charlene Morrison, Brian Rock, Barbara Schnider and Sheila Splane. Wanda Leah Trineer, Executive Vice-President, and Donna Norris, Past President, were not present. Also introduced were Roch Gamache, Executive Director; Harold Spanier, Director of Community Services and this year's recipient of the Buzzell Award; and Marion Daigle, a Past President of QFHSA, a CHSF Life Member, and Literacy Resource.

The President welcomed guest Serge Laurendeau, President, Quebec Provincial Association of Teachers.

Membership awards were presented by Marlyn Brownrigg and Barbara Schnider, Membership Co-Chairs. Libby McCullough, Jubilee Elementary School in Pointe Claire, was the recipient of the teacher book draw. Newsletter awards were presented by Liette Chamberland, Chair of the Education Committee, since Diane Radu, Editor of the QFHSA NEWS Focus on the Locals section was not able to attend the meeting. The President welcomed everyone.

The 65th Annual General Meeting was officially called to order at 1:30 p.m.

Beverlee Bishundayal, Registration Credentials, reported that there were presently 29 Home & School Associations in attendance which fulfilled the requirements for a quorum.

1.2 <u>Parliamentary Procedure</u>

Barbara Milne-Smith briefly reviewed the Business Meeting Procedures described in the Book of Reports, page 3, and the principles of Parliamentary Procedure, pages 4-5.

2. ACCEPTANCE OF AGENDA

The President noted that the Constitution and By-Laws Report should be added to the Agenda in the Committee Reports.

MOTION: Joanie Beaubien (Beaconsfield High)/Fe Solomon (Dorval) to accept the Agenda with the addition of the Constitution Report. **CARRIED**

3. ADOPTION OF THE MINUTES OF 2008 AGM (Book of Reports, pages 7-12)

MOTION: Liette Chamberland (Sherwood Forest)/Sheila Splane (Lord Aylmer) to accept the 2008 AGM Minutes in the Book of Reports. **CARRIED**

There was no business arising from the 2008 AGM Minutes.

4. PRESIDENT' S REPORT (Book of Reports, pages 14-16)

Debi Brown presented her report, noting in particular the hiring of the Executive Director, Roch Gamache.

MOTION: Lindsay McLeod (St John Fisher)/Liette Chamberland (Sherwood Forest) to accept the President's Report. **CARRIED**

EXECUTIVE DIRECTOR'S REPORT (Book of Reports, pages 17-18)
Roch Gamache briefly referred to his report, highlighting the Strategic Plan, the development of new initiatives in membership service offerings, a service-learning program, marketing-communications, and the appointment of the Director of Community Services, Harold Spanier.

COMMUNITY SERVICES REPORT

In this newly-created position, Harold Spanier is developing an expanded approach to services for the membership. A recent pilot project has been a partnership with Montreal-based Lobster Press to provide quality books at a substantial discount to some group affiliate members and which may be extended to include local associations off Montreal Island.

- 7. CANADIAN HOME & SCHOOL FEDERATION (Book of Reports, page 31)

 Marlyn Brownrigg, the QFHSA delegate to CHSF, spoke to her report, reviewing the status of Home & School federations in other provinces. In Prince Edward Island, for example, H&S has been recognized by the government as a partner and has received funding for two years. In June 2009, she will attend the CHSF annual general meeting in Winnipeg.
- **8.** <u>COMMUNICATIONS/TELEPHONE CHAIN</u> (Book of Reports, page 33)
 Anne MacWhirter explained the purpose of the phone calls and email communications for keeping in touch with the local associations and sharing of information.

EDUCATION COMMITTEE (Book of Reports, pages 35-38)

Liette Chamberland, Education Chair, acknowledged the assistance of Bryden Murray as her mentor on education issues as she re-established the Education Committee. In addition to the current sub-committees on French Second Language and Special Needs, a new sub-committee on the problem of school violence will be created.

MOTION: Liette Chamberland (Sherwood Forest)/Heidi Werbin (Sherwood Forest) to accept the two recommendations in the Education Report:

- That the QFHSA recruits additional assistance from local Associations in order to cover more concerns and issues.
- That the QFHSA recruits additional assistance from off-island and from the regions in order to have a better view of the situations throughout the whole of the province.

CARRIED

CONSTITUTION AND BY-LAWS COMMITTEE (Book of Reports, page 34)

Liette Chamberland explained that QFHSA has begun the process of reviewing its governing documents which can also serve as a template for the Constitution and By-Laws of the local Associations.

MOTION: Liette Chamberland (Sherwood Forest)/Mary Skagos (Gardenview) to accept the recommendation in the report:

That the QFHSA recruits assistance from at least 4 local Associations to review the first draft of proposed amendments to the Constitution and By-Laws.

CARRIED

LITERACY COMMITTEE (Book of Reports, pages 43-45)

Marion Daigle, a member of the committee, presented the report and thanked Literacy Director Diana Donnelly for her excellent work this year, including participation in the Gazette Raise-a-Reader campaign and the projects supported by this grant. Marion reviewed the literacy information in the conference kits, noting the 2 new topics to be added to the *Children's Literacy Resource* Guide (for a total of 18 subjects added to the original 2005 book). She acknowledged Dorothy Nixon's invaluable role in researching and creating the CLRG and continuing to develop new material.

12. MEDIA & PUBLICITY (Book of Reports, page 46)

Beverlee Bishundayal spoke to her report. She will continue to produce the homepage on-line seasonal newsletter, The QFHSA Download, even though she will be stepping down from the Board of Directors and moving from Quebec.

13. MEMBERSHIP COMMITTEE (Book of Reports, page 47)

Barbara Schnider, Co-Chair, presented the report on behalf of the committee and Co-Chair, Marlyn Brownrigg. She thanked Harold Spanier for his efforts in successfully increasing the Group Affiliate memberships to 16. The next membership workshop will be the Executive Workshops scheduled to be held September 11th.

14. RIGHTS REPORT (Book of Reports, pages 51-52)

Rights Committee Chairman, Brian Rock, thanked Marion Daigle for her invaluable contributions to the work of the committee. He then reviewed some of the major issues of the year;

Donations received for the fund-raising campaign to give financial support to

the families appealing Bill 104 to the Supreme Court of Canada were forwarded to legal counsel Brent Tyler. [Note: Later in the afternoon, special guest Mr. Tyler gave a brief review of the history of Bill 104 and an update on the current status of the appeal.]

- A special meeting with Graham Fraser, Commmissioner of Official Languages of Canada, was held in June 2008.
- The availability of English Language high school textbooks: Serge
 Laurendeau, President of the Quebec Provincial Association of Teachers
 (QPAT), reported to the delegates that as a result of the pressure from all of
 the concerned parties, there has been commitment from MELS (Ministry of
 Education, Leisure and Sports) that there will be simultaneous availability of
 textbooks before the implementation of programs.

Marion Daigle, referring to the information provided by the Quebec English School Boards Association (QESBA), reviewed the English schools annual enrollment figures for 2006-2008. During this time, there has been a decline of 5,000 students in the English community. Serge Laurendeau added that this represents 200 fewer teachers across the province.

Bryden Murray, Chair of the FSL Sub-Committee, explained that although there have been tremendous changes in education during the past forty years, there has been little evaluation of the success of French second language programs in Quebec. The resolution calls for focused research aimed at evaluating and strengthening the programs.

There were no amendments or changes to the resolution previously circulated.

a special authorization, would be presented with substantial obstacles in dealing with Parent-School communications at all levels, including independent study activities, thus creating the inability to actively participate in the education and support of their children, if the latter were to be enrolled in French school;

PRESIDENT'S REPORT

Report to the Annual General Meeting, April 24, 2010 Submitted by Carol Meindl, President

<u>Theme</u> The theme for 2009 -2010 was 65 Years Of Partnership The theme for 2010-2011 is Building A Future: Together

Main Activities- The Board of Directors was very busy during the past year since the previous AGM. Board of Director's meetings were held in May, June, September, October, November, January, February and March. In addition, the Directors organized and attended the AGM, Post AGM Meeting, Executive Workshops for Local Associations, The Fall Conference and the Executive Appreciation Dinner. Additional meetings, particularly Executive and Finance Committee meetings were held in the fall, usually with a teleconferencing component. One third of our Directors live outside of the Montreal area and travel long distances to attend functions and Board meetings.

<u>Committees</u> Committees were working hard on behalf of the membership and schools. Please see the respective reports for a summary of the following committees' activities.

<u>CHSF- Canadian Home and School Federation.</u> Marlin Brownrigg, QFHSA Vice- President, represented the provincial organization at the 2009 CHSF Annual General meeting in Winnipeg, Manitoba in June and at the Mid term Meeting in Montreal in November. In May, Rickhey Margolese will be the new representative and will attend the 2010 CHSF AGM in St Andrew's, New Brunswick.

Communications with Local Associations

- Four issues (June, September, December, March) of the QFHSA NEWS were mailed to home addresses of all members, as well as Group Affiliate members, liaison organizations and all English Schools across Quebec.
- Local Association presidents received phone calls and e-mail messages on a regular basis from the Directors and our staff. E-mailings were sent throughout the year with information and invitations to special events such as Executive Workshops, Fall Conference, Executive Appreciation Dinner, and AGM.
- The website was updated with new features and a *Facebook* page was also developed to encourage feedback on ideas and concerns.
- An ftp site was set up for the local associations to access forms and material directly.
- The provincial office was available as a source for information and advice.

Other Activities

- 1. On May 3 at the 2008 Annual General Meeting, the keynote speaker, Brent Tyler, presented a history of the restrictions of access to English education in Quebec. In 2009 Brent Tyler was invited back to update the QFHSA on the recent developments with Bill 104 and some of the anticipated outcomes. By October of 2009 the Supreme Court of Canada had struck down Bill 104 and ruled it as unconstitutional. The QFHSA's Education, Rights, and Public Affairs Committee has been keeping abreast of all the subsequent developments.
- 2. At the 2009 AGM we welcomed new Director Giovanna Spadafora to the Board.
- 3. In May and June Harold Spanier, began his tour of the Gaspe and North Shore, visiting the local Associations and meeting with schools interested in more information about QFHSA.
- 4. In June QFHSA Vice President, Marlyn Brownrigg, attended the Canadian Home and School Federation's Annual Meeting in Winnipeg, Manitoba, on behalf of the QFHSA.
- 5. Also in June Executive Director, Roch Gamache and Harold Spanier met with MNA Kathleen Weil with regards to a funding request to continue work on the archiving project. A sum of \$2000.00 was granted and over the next two months the entire collection of QFHSA newsletters and newspapers, going back 65 years, were digitally scanned as a permanent archive.
- 6. In July, farewell was said to long time Executive Secretary, Donna Sauriol, after more than 30 years of service with the QFHSA.
- 7. In September another long time staff member, Carol Ohlin, decided to retire after 12 years of service. The QFHSA began looking for new staff to carry on the work in the office.
- 8. In October the Annual Fall Conference was held at Beaconsfield High School and was attended by more than 80 delegates representing approximately 30 schools across Quebec.
- 9. In November the Canadian Home and School Federation held its Mid-Term Meeting in Montreal and were hosted by our Directors at the Cavendish offices.
- 10. In December, The Olympic Torch Relay Event, organized by Roch Gamache Lailah Cowan, Julie Girardin, Jenn Beauregard and Harold Spanier was held at Hudson Town Hall. This event was attended by 150 enthusiastic fans of the 2010 Olympics and were there to watch Mr Everet Bastet carry the Olympic torch on it's way to Vancouver for the Winter Games in February, 2010.
- 11. With great regret farewell was said to Roch Gamache as Executive Director and Harold Spanier as Director of Community Services, as funding to maintain those positions was no longer available.
- 12. Never the less, the follow up to the Olympic Torch Relay was the 'Reach for the Torch Sports Fair" event in Vaudreuil in February. This event hosted 250 students from the LBPSB and featured an address from Stephanie St-Pierre, Olympian and

This meeting turned into a working session as the Committee members produced the QFHSA Draft Resolution on An Appeal to the Government of Quebec - Wider Access to English Education re: Bill 104.

6. Regular Meeting of January 14th, 2010

Discussion focused on the QFHSA Draft Resolutions on An Appeal to the Government of Quebec - Wider Access to English Education re: Bill 104 and Special Education. The issues of Student Ombudsmen re: Bill 88 and the state of negotiations between teachers and the Government of Quebec were also debated.

7. Special Meeting of March 11th, 2010

Mr. Serge Laurendeau, President of the Quebec Provincial Association of Teachers, was the special invited guest as the QFHSA Draft Resolutions regarding Special Education and An Appeal to the Government of Quebec - Wider Access to English Education re: Bill 104 were topics discussed as was the state of negotiations between QPAT and the Government of Quebec.

8. Special Meeting of Executive Committee of March 25th, 2010

The Chair of the Education, Rights, and Public Affairs Committee and the Committee's Archives/History Resource met with the QFHSA Executive Committee to agree on a plan of action to bring to completion the QFHSA Archives Project and the QFHSA History Project.

(There is absolutely no truth at all to the rumour circulating that Marion was present in Bytown when the original BNA Act with its heralded section 93. (2) was signed.) HISTORY / ARCHIVES PROJECT

Report to the QFHSA Annual General Meeting, April 24, 2010 Submitted by Marion Daigle, Co-ordinator

BACKGROUND

This project falls under the mandate of the Education, Rights and Public Affairs Committee. Previous to 2009-10 it was under the mandate of the Rights Committee.

2000 - The Board of Directors gave approval for the Rights Committee under the chairmanship of Marion Daigle, to secure funding to update the QFHSA History and, for the first time, to set up proper Archives

<u>The Foundation for the Advancement of Protestant Education in Canada</u> – Marion Daigle and Winifred Potter, a Rights Committee member presented a proposal to the Foundation Board of Directors which was accepted.

A grant of \$30,000 was given to QFHSA for this project. The Foundation has been a generous donor since 1984, particularly where issues related to parental rights in education are concerned.

OFHSA HISTORY

- March, 1970 A History of Quebec Home and School by William Asherman was first published
 - The QFHSA History project was set up under the direction of Rod MacLeod, historian, McGill University as part of the Quebec Protestant Education Project (QPERP). To date 4 drafts have been submitted to a corps of History readers and the review is ongoing. Delays in completing the project are due to the co-ordinator's (Marion Daigle) responsibilities and obligations as a resource on several Federation Committees. In addition, the archival work has been very time consuming but essential in helping the historians access the research material needed.

ARCHIVES

2001-2006 – Under the supervision of Gordon Burr, Senior Archivist, McGill University (also a consultant to QFHSA) Josée Martel, archivist and co-ordinator, Marion Daigle and volunteer Carol Ohlin, over 60 boxes of very valuable archival material has been catalogued and stored. There is still a great deal to do.

In 2002 Gordon Burr said, in part, in a letter to QFHSA:

'After having viewed the holdings of the QFHSA I sincerely hope all these extremely valuable archival records can soon be made available to researchers. The records for this cooperative body of parents, teachers and students provide a wonderful opportunity for the study of Quebec's Anglophone cultural, social and educational milieu at both provincial and local levels'

June, 2009 –

QFHSA NEWS – a grant of \$2000 was given to QFHSA by the office of Kathleen Weil, MNA for NDG, to digitize the NEWS. This was completed in August 2009 and is a welcome addition to the Archives project.

Additional funding to complete the archives is an ongoing concern.

October 24. 2009

Fall Conference – 65 Years of Making a Difference

Marion Daigle gave a keynote address on our QFHSA History which highlighted Home and School activities, locally and provincially, as well as paying tribute to the many tireless and dedicated volunteers. Barbara Milne-Smith was honoured for her 50 years of outstanding volunteerism.

QFHSA is fortunate to have the support, expertise and enthusiasm of very qualified historians and archivists. In addition QFHSA volunteers comprising past presidents and other long time Board Members who served many years on important committees have a wealth of knowledge and experience to share.

Recommendation

It is recommended that local Home and School Associations take steps to record their history and to catalogue their archives. This is particularly important where school closures are concerned. Information is included in the AGM Conference kit.

- Prepared annual filing of Charitable Information Returns.

Adminstrative changes:

There were several major changes in administration this year. Following the recommendations of our Strategic Plan, the current committee mandates were consolidated and reviewed. The twelve standing committees were consolidated into the current seven committees:

The QFHSA also created the executive staff position of Director of Community Services to support Literacy and Parenting, Communications and Special Events, Community Services and Membership Development and Special Projects.

Harold Spanier stepped into this role on a volunteer basis April to December 2009

Staffing Changes

There were significant changes in the staffing of the QFHSA home office as well. We saw the departure of long time Executive Secretary, Donna Sauriol, and the retirement of Administrative Assistant, Carol Ohlin. Severance packages were prepared for each respectively, reflecting seniority and time served in the office.

New staff were hired, trained and in place by the end of September, in time for the new school year rush. It has been a learning experience for all involved to establish a smooth running office. Many tasks that were done quietly behind the scenes by the previous staff were taken on by Board members until the new staff became familiar with and successsfully re-invented office procedure.

Grant Funding to support an Executive Director ran out by the Spring of 2009. Both Roch Gamache and Harold Spanier offered to stay on, *pro bono*, for the summer and fall and complete projects and tasks initiated during their mandates. Honoraria were offered to them at the end of December 2009 in compensation for work completed.

<u>Financial changes</u>: The reporting statements to the Board were simplified and various accounts were consolidated and adjusted for improved efficiency. Work was done with the accountant and the past administrative assistant on implementing QFHSA's new accounting structure. Project modules were instigated and are now working in accordance with an accrual accounting method.

The financial statement for the 2009-2010 year was good and we came in over budget by \$2910.22.

Please see the proposed Budget for 2010 and the financial statement for January 1 to December 31, 2009 below.

RECOMMENDATION: The Finance Committee recommends that the proposed Budget for 2010 be approved by the membership at the Annual general meeting, April 24, 2010.

Much of the QFHSA's membership material and resources are sadly out of date. Much needs to be done to update the look and the content of QFHSA resources. Office expenses have increased over the years. The Finance Committee would like to recommend to the membership an increase in Membership Fee of \$2.00, from \$16.00 to \$18.00 for the 2010-2100 year.

RECOMMENDATION: That the Annual Membership Fee be increased to \$18.00 from the current \$16.00 in light of the need to update materials and resources (pamphlets, brochures, website, etc)

Board of Director Changes

October saw changes to the Board of Directors. Liette Chamberland, our Corporate Secretary and Education Chair, resigned her position, as did our Treasurer, Oliver Cole.

The Executive Director stepped in to prepare financial statements for Board meetings and the Executive Committee over saw financial considerations in the absence of a Treasurer.

To support initiatives aimed at providing parents with workshops on various subjects pertaining to actions geared toward children and youth in the context of school and community life.

Activities 2009-2010:

May 2009

- Diana Donnelly resigned as chair on April 25, 2009 and Harold Spanier, Director of Community Services, acted as the Interim Coordinator of the Literacy Committee.
- Boxes of books were allocated to group affiliate members, and Home and School Associations in rural Quebec regions.
- Harold Spanier visited Riverview (Port Cartier), Queen Elizabeth High School and Flemming Elementary (Sept Iles) and our Home and School Association in Baie Comeau. He met with parents, teachers and community leaders about the role of Home and School.

June 2009

- Marion Daigle attended the new Born to Read Recognition Celebration at the Riverdale Community Learning Centre (CLC). This event was sponsored by the Montreal West Island Born to Read Group which organizes the Born to Read and Mother Goose program at Riverdale CLC.
- Harold Spanier visited Metis Beach, New Carlisle and Belle Anse schools as well as community groups along Quebec's Gaspé Peninsula. Boxes of books were delivered.
- A Grant of \$3,400 from the 2008 Canwest Raise-a-Reader (RAR) campaign was received in June, 2009.

July 2009

• Harold Spanier submitted a grant application in July, 2009 for the 2009 Canwest RAR campaign in September. We were accepted and expect a grant in the near future.

October 2009

• Giovanna Spadafora offered to chair the Literacy and Parenting Committee until April 24, 2010. This was approved by the Board of Directors.

November 2009

- Marion Daigle gave her annual literacy lecture to the students of the Information and Library Technologies Department of John Abbott College. Giovanna Spadafora attended and introduced herself as the new chair of the QFHSA Literacy and Parenting Committee. An honorarium of \$150 was donated to Beverley Graham, an EMSB school librarian.
- David Poulsen, author and coordinator of a literacy program in Alberta, visited guests at the QFHSA offices as part of the TD Canadian Children's Book Week. This visit was
- organized by Harold Spanier.
- QFHSA members set up the annual display at the Quebec Association of Provincial Teachers (QPAT) convention in Montreal. The Children's Literacy Resource Guide (CLGR) is a popular feature.

December 2009

- Books were delivered by Marion Daigle to the nursery/daycare program of Dans La Rue.
- Boxes of books were sent to the following community groups and schools:
 Netagamiou Community Learning Centre (CLC) (Chevery); Mecatina CLC (La Tabatière); Gaspé/Percé CLC; Family Ties (New Carlisle); Bonaventure High School.

January 2010

- Giovanna Spadafora attended a videoconferencing workshop on literary initiatives, held at Riverview CLC. The following organizations were represented: MELS, Riverview CLC, Riverview Elementary, Beurling Academy, Center for Literacy of Quebec, Verdun Public Library and QFHSA. MELS highlighted its recognition awards (5th year), part of its Action Plan on Reading. Netagamiou CLC was the recipient this year.
- Family Literacy Day: Several Community Learning Centers as well as Edgewater Home and School Association held Born to Read activities and celebrations on or close to January 27, 2010.
- Giovanna Spadafora and Marion Daigle attended the Born to Read celebrations at Edgewater School. This program is now in its 6th year and is very successful because of the collaboration among home and school volunteers, Edgewater staff and community volunteers.

February 2010

- Giovanna Spadafora and Carol Meindl attended a meeting with the MELS team
 overseeing the Action Plan on Reading (Lisa Storozuk, program coordinator). MELS
 discussed the different aspects of the plan (i.e., recognition awards; staff development;
 resource for parents). Giovanna and Carol presented the QFHSA literacy initiatives (Born
 to Read; Children's Literacy Resource Guide; support for reluctant reader programs;
 support for community and school libraries).
- Giovanna Spadafora and Marion Daigle visited Lindsay Place High School and pledged \$300 for its Literacy Program for Teens. The success of this program is due to the enthusiasm and dedication of the staff, the support of the administration and the students' willingness to participate.
- Giovanna Spadafora and Rickhey Margolese (QFHSA board member) attended a MELS workshop on "Strengthening School-Community Collaboration". The aim of the workshop was to develop a framework within which partnerships can be established and/or strengthened between CLCs and community-based organizations.

Other

• The QFHSA received a generous donation of National Wildlife Federation Magazines and art paper by the Tembec Paperboard Group. This donation in kind is being distributed to schools and community organizations.

Future Directions: Literacy

- The Committee wishes to develop a literacy survey to be sent to local associations to find out about current literacy activities and local literacy needs and concerns at the elementary and high school levels.
- The Committee would like to present the *Born to Read* program to new home and school associations and reintroduce it to established home and school associations. The aim is to increase the number of elementary schools that promote the benefits of reading to newborns and toddlers.
- The Committee wishes to undertake a revision of the *Children's Literacy Resource Guide* in order to continue to make it available as a valuable resource for parents, staff and community organizations.

Future Directions: Parenting Programs

In addition, she suggested we send our resolution to La minister de la Culture, des Communications et de la Condition féminine who is responsible for the application of the French Language Charter.

The *Statement of Policy* is a compilation of statements based on resolutions passed over the years by the delegates at the Annual General Meeting. It complements the purposes and objectives of Quebec Federation of Home and School Associations Inc. Following the AGM, it is updated each year and copies distributed to the local associations.
