In Memoriam - Donna Sauriol

Over the past 67 years the Quebec Federation of Home and Schools has demonstrated a remarkable diversity of involvement in the constantly changing educational and social issues that directly impact our children and youth.

The QFHSA is membership driven; members are volunteers (parents, students, educators and community icons) and donate varying degrees of time and effort to "enhance the education and general well-being of children and youth". Membership numbers grow and contract over time, resulting in constant changes of Executive Committees and the Board of Directors.

The continuity, solidity and backbone of a volunteer organization like the QFHSA can often be found in its staff members. Between the years of 1975 and 2009, we were fortunate to have one employee in particular who helped to maintain the integrity and continuity of our mandate. Prior to 1976, Donna's lifetime of service had already begun. She was an involved Home and School volunteer for her children's elementary school. She then served as an Area Representative on the QFHSA Board of Directors representing the Rosedale, Somerled, Kensington and Royal Arthur Home and School Associations. Her transition to office staff was a natural progression.

Donna Sauriol worked tirelessly during these 33 years with a work ethic that went far beyond any job description, any remuneration and any of the few accessory benefits the QFHSA was able to offer.

During Donna's tenure, she "broke in" many of the QFHSA presidents. She helped Board members, Committee Chairmen and members accomplish their QFHSA mandates. There were Annual General Meetings, Leadership Conferences, special meetings, financial records, agendas, books of reports, briefs, resolutions, changes to the Constitution, By-Laws, Standing Rules, membership mailings, Canadian Home and School issues, government submissions, copying and distribution of reports, reminders to people to meet specific deadlines – PLUS — the routine daily calls received by the QFHSA office for help or advice from the membership at large. For years, Donna was the virtual editor of the "News" ensuring its timely publication. Donna did this latter task in her spare time, at home.

The aforementioned tasks were ongoing requirements each year. In addition, historical undertakings by the QFHSA were added to this list which required input from office staff. Examples are the following:

- 1977 and onward: the QFHSA Brief and Court Action respecting Bill 101;
- 1978 and onward: numerous briefs addressing issues on Education, Health, the Canadian Constitution, etc.;
- Canadian Home and School Federation annual and mid-term meetings held in Montreal.

Each of these undertakings required large amounts of time be devoted to them by both the Home and School members immediately involved and by our office staff, in particular Donna.

Donna's work with the QFHSA did not go unnoticed. In 2004, she received the Buzzell Award for "unique, longstanding and meritorious service to the QFHSA at the provincial level". She also received a Volunteer award from the Canadian Federation of Home and Schools, recognizing her exceptional

service. Each year, during the AGM, the QFHSA presented Donna with a "wee gift", usually tickets to the Roger's Cup Tennis Tournament at Jarry Park as a thank you for her dedication and hard work.

Upon Donna's passing, many e-mails were sent to the QFHSA expressing how much she would be missed. The messages clearly expressed the impact of Donna's special qualities upon every person she touched. These wonderful observations should be shared:

- Depth of knowledge
- An advisor to all members: old and new
- · Caring, thoughtful, loyal, and kind
- An enthusiastic supporter
- Her passion for language and the written word
- Unobtrusive, discreet, private
- Supportive, dedicated, welcoming
- Passionate about education, children, and their parents
- Pillar of strength
- True friend and supporter of Home and School
- Integral part of the spirit of QFHSA
- Made a significant difference in the lives of many people.

Donna Sauriol loved the QFHSA and her work because it was an extension and an expression of her own beliefs and goals. Donna's work was her vocation and it exemplified her essence as a human being.

We are sometimes "ships that pass in the night" in our relationships with others. We were so fortunate that Donna Sauriol's ship docked at the QFHSA wharf in 1976, and that it rested at the QFHSA anchorage for 33 years.

We were all the richer for her presence among us and we will miss her.

QFHSA 67th ANNUAL GENERAL MEETING – April 30, 2011 BUSINESS MEETING PROCEDURE

- 1. The **Annual General Meeting** [AGM] is **conducted in accordance** with our Constitution, By-Laws and Standing Rules. In the case of any procedural dispute reference shall be made to Robert's Rules of Order Revised.
- 2. Each **official voting delegate** of each Member Association shall have **one vote** on any question which comes before the meeting, **except** for associations more than 250 kilometers from Montreal. Such Associations will still be entitled to three votes, expressed either as an identical or divided vote. Application for such privilege is to be presented in writing to the Executive Secretary prior to the start of the business portion of the Annual General Meeting.
- 3. The **quorum** for **transaction of business** at the Annual General Meeting shall be twenty-five percent [25%] of **Member Associations in good standing**, represented by their official representatives or accredited alternates.
- 4. **Voting** shall be by ballot or show of hands. All questions shall be **decided by a majority of those present** and entitled to vote, **except** those which require a two-thirds [2/3] majority. On ballot votes, the votes of each association shall be handed in by the voting delegates of each association individually but at the same time. Counting of the votes shall be done by non-voting participants.
- 5. A **delegate** may not **speak** for more than two [2] **minutes** on any question under discussion, nor more than twice on any particular motion or resolution. Any person wishing to speak needs to stand and come to the microphone (if one is available).
- 6. **Amendments** to the **Constitution and By-Laws** require a two-thirds [2/3] **vote** of the delegates present and entitled to vote. Notice of the proposed amendments must have been mailed to all Member Associations at least ten [10] weeks prior to the meeting. Modifications to these proposed amendments received two [2] weeks before the AGM will be considered, but **no modification may be made from the floor.**
- 7. **Resolutions** to the Annual General Meeting must have been circulated to the Member Associations eight [8] weeks prior to the Annual General Meeting. Resolutions received after the date specified will be presented as **Emergency Resolutions** only after consideration by the Chairman of the meeting and the Resolutions Committee. Delegates presenting resolutions are reminded that they must be present at the time designated on the agenda for the presentation of their resolution. The **presenting party** may **speak** to the resolution, or amendments thereto, for not more than FIVE [5] **minutes**. In addition to amendments received two weeks before the AGM there may be amendments emanating from the caucus session held earlier, **but no further amendments may be made from the floor.**

PARLIAMENTARY PROCEDURE

PRINCIPLES PURPOSE

- Justice and Courtesy for all
- One thing at a time
- Recognition of the will of the majority
- Protection of the rights of the minority

✓ To conduct business in an orderly and democratic manner by one or more of the following ways: ✓ communications

✓ committee reports

✓ motions or resolutions

To participate effectively in the proceedings of meetings, each person needs to know the fundamentals of parliamentary procedure.

THE MAIN MOTION

WHAT IS A MOTION?

A main motion introduces a new item of business; it is a proposal that the group take a certain action. It is the basis of all discussion and states the bounds of discussion. All remarks pertain directly to the contents of the motion on the floor. The making of the motion comes first, discussion follows. A subsidiary motion qualifies the main motion or proposes an alternate timetable for consideration.

WHEN IS A MOTION NEEDED?

- It forms a basis for discussion on all major decisions of the group.
- When in doubt, ask for a motion to be proposed.
- Motions must be made on all matters involving <u>finances</u> not already included in the budget as approved.
- On minor matters, a question may be resolved by the chairman 'taking the sense of the meeting'.
- The decision must be clearly stated for the secretary to report in the minutes as well as for the benefit of the members.

THE STEPS TO PRESENTING A MOTION ARE:

- 1. member stands or raises a hand and says:
 - "Madame Chairman/Mr. Chairman."

The chairman recognizes the speaker by name.

- 2. The member says, "I move that . . . ", stating or reading a motion.
- 3. Another raises a hand to be identified by the chairman, then says:
 - "I second the motion." The seconder believes the motion should be discussed, but <u>may not</u> necessarily be in favour of it.
- 5. The mover usually speaks first, giving the reasons for the motion. The opportunity to speak to the motion must be given to anyone who wishes to speak to or oppose the motion. Discussion should be addressed to the chairman.
- 6. At the end of the discussion, the chairman says:
 - "If there is no further discussion " or "Are you ready for the question?" Then:
 - "The motion is that "
 - "All in favour?" (pause while the count is taken by the secretary)
 - "Opposed?" (pause while the count is taken by the secretary)
 - "Abstentions?" (pause while the count is taken by the secretary)
 - "The motion is carried" (or is defeated).

7. If anyone calls "Division" (questions the voice vote), the chair calls for a show of hands or a standing vote: "All in favour raise your hand. All opposed ... " If a majority request it, the vote may be taken by ballot. A "ballot vote" is the recommended procedure for election of officers and for resolving a contentious issue.

SUBSIDIARY MOTIONS

AMENDMENTS CHANGE MOTIONS: To qualify the idea of a motion, but not to change the subject or the intent of the main motion.

1. "I move to amend the motion by ":

Inserting or adding a word, phrase or sentence.

Striking out a word, phrase or sentence.

Striking out and inserting a word or phrase or substituting a sentence or paragraph.

- 2. "I second the motion to amend."
- 3. "It has been proposed to amend the motion to read as follows "

The chairman states the main motion and the amendment so the group will understand how the amendment changes the motion. Amendment is handled in the same way as a motion with:

Discussion: "Is there any discussion?"

Question: "If there is no further discussion, the amendment is "

Vote: "All in favour of the amendment "

Chairman announces the outcome:

"The amendment is carried (or defeated)."

"The motion now before the meeting is "

(states the motion plus the amendment(s) if it carried)

In dealing with motions, the vote is taken first on the amendment. If passed, the amended motion is voted on. If the amendment is defeated, the main motion in its original form is voted on.

TO REFER: A question is referred to committee for further study and to submit a recommendation to the

group at a later time.

TO TABLE: To set the matter aside until someone moves to reconsider it.

TO POSTPONE DEFINITELY: Postpone discussion until more facts are available.

TO POSTPONE INDEFINITELY: The motion may not be considered again that year.

Recommended useful resource materials available for reference during a meeting: A copy of your organization's Constitution and By-Laws. Robert's Rules of Order or other guide to basic rules of parliamentary procedure.

GREETINGS

Mr. LaFrance brought greetings from MELS. He announced that there would be a Forum on education in the fall 2010 to examine such topics as school governance and student fees for higher education, the alignment of the labour market with vocational-technical education, the involvement of community with regards to youth sector education and the delivery of services to special needs students. He also told us that English text books would be available for all grade levels in all subjects for the start of the 2010-2011 school year.

GUEST SPEAKER

Serge Laurendeau, President of the Quebec Provincial Association of Teachers, was our keynote speaker. He updated the delegates on teacher contract negotiations regarding the need for salary improvements to be able to retain new teachers and the critical need to ensure long-term job security, especially in the vocational and the adult sectors. He explained that teachers had set targets for improving the situation for students with special needs: specifically, new models regarding integration in mainstream schools; lowering class size maximums; increasing funding for training and professional development for all personnel, materials and resources. He spoke about the need for a strong partnership between parents and teachers in achieving mutual goals in the education of our children.

Membership awards were presented by Marlyn Brownrigg and Barbara Schnider, Membership Co-Chairs. Newsletter awards were presented by Carol Meindl, President, as Diane Radu, former Editor of the QFHSA NEWS *Focus on the Locals* section, was not able to attend the meeting.

8. EDUCATION, RIGHTS and PUBLIC AFFAIRS COMMITTEE REPORT

Brian Rock spoke to the report. He recommended that the delegates vote on the 6 resolutions that Rickhey Margolese would be presenting during her report on the Resolutions Committee. He talked about the various committee meetings that had been held during the year. Much discussion during these meetings revolved around QFHSA's position on wider access to English education: specifically, the preparation of the Press Release outlining QFHSA's position on the Supreme Court of Canada's ruling that Bill 104 is unconstitutional and needs to be withdrawn or modified and the writing of Resolution 2010/1 on An Appeal to the Government of Quebec. Wider Access to Education re: Bill 104, which was unanimously adopted during this AGM meeting. Other discussion items revolved around the writing of 3 resolutions on teacher negotiations in relation to special needs students and the need to restart the History/Archives Project. Brian gave special thanks to Marion Daigle for service provided to the Education, Rights and Public Affairs Committee well beyond the call of duty.

8.1 History/Archives Report (Book of Reports, pages 27-28)

Marion Daigle reminded delegates that records of meetings, newsletters, flyers, programs, etc. tell the story of the significant contributions made by volunteers to the overall well-being of your local school and to the community at large. Information about setting up your Home and School archive is available at the QFHSA office. The QFHSA archives are a valuable resource tracing the history of the Anglophone population of Quebec.

In June 2009, a letter was received from the Office des personnes handicapées requesting clarification on the 6^{th} Whereas and suggesting that we forward this resolution to la ministre de la Culture, des Communications et de la Condition féminine.

9.2 Statement of Policy

The Statement of Policy was not updated in 2009 and should be ready to be voted on at the 2011 AGM.

9.3 Caucus Sessions on Resolutions

Rickhey Margolese explained that the caucus sessions help everyone to gain a greater understanding of the issues being addressed. She said to ask questions; give suggestions about follow up, etc. These sessions are an informal way of reaching a consensus. There would be 4 sessions running simultaneously: Session 1 – Resolution 2010/1; Session 2 – Resolutions 2010/2, 2010/3 and 2010/4; Session 3 – Resolution 2010/5 and Session 4 – Resolution 2010/6. After these sessions, there would be a nutrition break followed by the voting on the six resolutions.

9.4 RESOLUTIONS 2010

A simple majority is required to pass; the procedure for amendments was explained. Additions and/or changes to the destinations do not require an amendment.

Report to the Annual General Meeting - April 30, 2011 Submitted by Carol Meindl, President

<u>Theme-</u> The theme for 2010 was **Building a Future- Together**

The theme for 2011 is **Get Involved- Education Matters!**

Main Activities- The Board of Directors makes every effort to attend as many Board meetings as possible and enjoys a 90% attendance rate. In 2010 we held 9 Board meetings from March 2010 to March 2011. In addition to attending to the regular business of running the organization, the Board members organized and attended the Annual General Meeting, Post AGM Meeting, Executive Workshops, Annual Fall Conference (venue: Gardenview Elementary School) and the Executive Appreciation *Barbara Coloroso* Event (Sheraton Airport Hotel) There were a flurry of assorted meetings held throughout the year as members of the Board chaired committee meetings and attended conferences and seminars on behalf of the QFHSA. The president spent a significant amount of time in the office working on grant applications, answering questions from Local Associations and overseeing the general running of the organization, in lieu of an Executive Director.

<u>Committees</u> -The various committees were diligent in pursuing the issues and concerns of the local associations. Please see the respective reports in this book for a summary of their activities.

<u>CHSF</u> - (Canadian Home and School Federation) Rickhey Margolese, QFHSA Executive Vice President, represented our provincial organization at the 2010 CHSF Annual Meeting in St Andrews by the Sea, New Brunswick (May 28-30), the mid-term meeting in Ottawa, Ontario (Nov 11-14) and a special cross country teleconference meeting was held on February 5, 2011 and was attended by Carol Meindl in Rickhey's absence.

Communications with Local Associations

• 4 issues of the NEWS, 3 of which were in the new QFHSA Newsletter format, were mailed and emailed out to all members, as well as to Group Affiliates, liaison organizations and all English Schools across the province. Shifting to a majority email mailing list has proved to have its challenges.

- Local association presidents remained in contact with the phone chain committee and
 received information and notice of events regularly from the Directors. It is important for
 each Local association to have a QFHSA liaison to report to their Home and School
 about QFHSA events and developments.
- Mailings were sent throughout the year with information and invitations to special events such as the Annual General Meeting, Executive Workshops, Fall Conference, and Executive Appreciation (Barbara Coloroso) Event.
- The provincial office on Cavendish Boulevard was open regular hours as a resource for information and advice.
- Electronic Surveys were used to gauge membership evaluation of Workshops and events and to provide feedback.

Other activities

In <u>April</u>, QFHSA Executive committee held a series of meetings with representatives of **BFL Insurance** to review liability insurance for local association executive committees and general membership.

President Carol Meindl and Executive VP Rickhey Margolese represented the QFHSA at the 2010 **Community Learning Centres Resource Committee** meetings held at regular intervals over the year. The Community Learning Centres project is dedicated to sustaining and vitalizing the English Speaking Communities across Quebec by making local schools in remote areas the centers for community learning.

<u>In April</u>, at the **AGM**, Liette Chamberland was welcomed back to the Board, and Rosalind Hoenig, Jennifer Bogart and William Harwood were sworn in as new QFHSA Directors.

<u>In May</u>, a Board Orientation Workshop (May 15) was held with the help of the Center for Community Organizations, with the objective of clarifying the role of the board and exploring new directions for the future. Committees were re-examined and re-organized. (see Administration Report)

Rickhey Margolese and Carol Meindl attended the CLC Networks Annual Conference, *Together in Partnership for our Youth*, a collaboration between CLC, LEARN and MELS.

The QCNA (Quebec Community Newspaper Association) held its Annual General Meeting and Education Conference, May 18, at the Chateau Vaudreuil and was attended by members of the Editorial Committee, Jenn Beauregard, Lailah Cowan and Mary Skagos.

The Bibliothèque et Archives nationales du Québec(BAnQ) held an open house, May 21, and invited the QFHSA, as a parent organization interested in education, to tour the facilities and learn about the collections and services it offers to the Anglophone sector.

<u>In June</u> the QFHSA received approval from PCH (Patrimoine Canadian Heritage) for a grant of \$23,000 to develop and deliver a series of science activities for students ages 8-16 in remote school areas of Quebec. The YES (Youth Exploring Science) project was launched March 12,

2011 and ran 5 sessions to April 16. Approximately 25 students from the Huntingdon and Eaton Valley regions were given the opportunity to explore science in a fun and interactive way, thanks to the PCH grant and the generous donation of the Community Learning Centres video-conferencing network.

Much work was done over the summer by the Editorial Committee to reformat the QFHSA NEWS and the resulting product is refreshing to the eye and a pleasure to read. We encourage all local association to submit articles of interest from their school's activities.

From <u>June-August</u> the Rights committee, and, Rickhey Margolese in particular, were very busy researching and writing a **Brief to Challenge Bill 103** that had been proposed by the Liberal Party of Quebec and introduced to the National Assembly. QFHSA was invited to present our brief to the National Assembly Committee on Culture and Language on Sept 10th. QFHSA was represented by Jim Wilson, Liette Chamberland, Rickhey Margolese and Carol Meindl. The hearings were televised live on Canal Assemblie Nationale along with all the other organizations which were invited to present briefs.

On August 25, the QFHSA received an invitation to present evidence to the Standing Senate Committee on Official Languages about the situation of the English Speaking Minority Communities in Quebec. Marion Daigle and Carol Meindl represented the QFHSA at the witness hearings in Montreal on September 17, 2010.

<u>In October</u>, the QFHSA's Education Committee Chair, Liette Chamberland, participated in a Summit for Special Needs, (Oct 25) convened by Education Minister Line Beauchamp and held in Quebec City. Liette participated in cooperation with the FCPQ (Quebec Federation of Parents' Committees, English Affairs) which was one of the various education organizations invited to participate.

Also that month, Liette Chamberland was nominated and accepted by Minister Beauchamp as a member of the Advisory Board on English Education, chaired by Cathrine Le Maistre. The mandate of this Board is to advise the Minister of Education, Leisure and Sport on all matters affecting the educational services offered in English elementary and secondary schools in Quebec.

Jim Wilson, Co-Chair of the Rights Committee was chosen to be our representative at PACTE (Provincial Advisory Council of Teachers in English)

<u>In November</u> the QFHSA was invited to participate in the Vocational/Technical Training Symposium, arranged by the Ministre de l'education, loisir et du sport (November 3^{rd)} and held at the Sheraton Airport Hotel. This symposium shed light on all that is available in Quebec in terms of Vocational and Technical training and illuminated the attractive alternative this can be to a university education. The QFHSA sent more than 7 representatives to evaluate the variety of workshops and information sessions presented.

<u>In January 2011</u> the Family Treasures Essay Competition was launched, in partnership with LEARN and the Community Learning Centres and invitations were sent to all member

association schools to participate. Thirteen (13) schools participated with a total of 153 essays submitted. The winners were awarded a \$50 Chapters gift certificate. A \$50.00 Chapters gift card was also awarded to the classroom of the winning submissions for the purchase of books. The winning submission will be featured in the June issue of the NEWS and all student submissions received a Certificate of Participation. A collection of all the essays will be compiled and a copy will be sent to the libraries of each school that participated.

There is much that the QFHSA can be involved with and much more it can accomplish. We need parents with an interest in their children's education to join us on our committees, to explore new areas and new opportunities. Our door is always open. The coffee is on.

We have audited the statement of financial position of Québec Federation of Home and School Associations (Federation) as at December 31, 2010, and the statements of changes in net assets, operations and cash flow for the year then ended. These financial statements are the responsibility of the Federation's management. Our responsibility is to express an opinion on these financial statements based on our audit.

Except as explained in the following paragraph, we conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we plan and perform an audit to obtain reasonable assurance whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation.

In common with many charitable organizations, the Federation derives revenues and contributions from various sources, the completeness of the non-government revenue and contributions are not susceptible to complete audit verification. Accordingly, our verification of these revenues was limited to the amounts recorded in the records of the Federation and we were not able to determine whether any adjustments might be necessary to the statements of operations, changes in net assets and cash flow.

In our opinion, except for the effect of adjustments, if any, which we might have determined to be necessary had we been able to satisfy ourselves concerning the completeness of the non-government revenues and contributions referred to in the preceding paragraph, these financial statements present fairly, in all material respects, the financial position of the Federation as at December 31, 2010, and the results of their operations and their cash flow for the year then ended in accordance with Canadian generally accepted accounting principles.

NOTES TO FINANCIAL STATEMENTS

AS AT DECEMBER 31, 2010

1. NATURE AND PURPOSE OF THE ASSOCIATION

The Québec Federation of Home and School Associations is an incorporated, independent, not-for-profit volunteer organization dedicated to enhancing the education and general well-being of children and youth. It promotes the involvement of parents, students, educators and the community at large in the advancement of learning and acts as a voice for parents.

2. ACCOUNTING POLICIES

a) Revenue Recognition

- Membership fees are received mostly in the Fall of each year and are taken into revenue over the period from the first of September to the following thirty-first of August.
- ii) Program funding and grants are received from Federal and Provincial agencies, the revenue from Federal agencies is recognized over the donor fiscal year which is from the first day of April to the following thirty-first day of March. The revenue from the Provincial agency is from the Ministry of Education and is recognized over the period from the first day of September to the following thirty-first day of August.
- iii) All other revenues are recognized when received.

b) Expensing Capital Assets

The Federation expenses all capital assets in the year they are acquired.

c) Contributed Services

Volunteers at the Federation level contribute approximately 24,800 hours per year to assist the Federation in carrying out its activities. Because of the difficulty in determining their fair value, contributed services are not recognized in the financial statements.

2. ACCOUNTING POLICIES (Cont'd)

d) Use of Estimates

The preparation of financial statements in conformity with Canadian generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from these estimates.

3. FUNDS HELD IN TRUST

The Federation has funds in trust amounting to \$9,500. The donors have requested that the interest earned on the funds in trust be used to pay for awards given out at the annual general meeting. A committee was formed to consider all submissions for the awards, and to choose the ones they consider best meet the guidelines.

4. DEFERRED PROGRAM GRANTS

The deferred program grants from Canadian Heritage and the Québec Ministry of Education are utilized for operating activities and are calculated as follows:

CHSF 2010 Board Meeting and AGM

The Annual Spring Board meeting and AGM were held in St. Andrews by the Sea, New Brunswick, from May 27th to 29th 2010.

Four of the 6 Directors were new to the Board: Owen Parkhouse (PEI); Cheryl Kennedy (NS); Teresa Blum (ON) and Rickhey Margolese (QC). Glyn Morgan (NB) was returning and BC was vacant until they could fill the position.

There was a change to the Executive from a Western VP, a Central VP and an Eastern VP to only 2 VPs in order to be more fiscally responsible. CHSF pays for the Executives to come to meetings. The Executives were Janet Walsh (NS) – President; Brian Peat (ON) – 1^{st} VP; Cynthia Richards (NB) – 2^{nd} VP; and Eva Cameron (MB) – Secretary-Treasurer.

Since this meeting, there have been changes to the Directors and Executives. Ann Whiteaker (BC) became a Director and Deb Giesbrecht (MB) replaced Brian Peat as 1st VP.

Much of the 3 days of meetings dealt with:

- setting priorities for CHSF
- brainstorming on how to get all the provinces back to the table
- deciding on actions for the Drysdale Fund
- understanding and passing the budgets for 2009/2010 and 2010/2011
- approving policy and changes to the Constitution & Bylaws.

On Saturday evening delegates and guests met to celebrate award winners at the Gala Dinner where, amongst others, two of the CHSF Board members were also honored. Glyn Morgan was awarded Life Membership and Brian Peat was given the President's Award.

Mid-Term Meeting November 2010

The mid-term meeting was held in Ottawa from November 11-13, 2010. Board members formed into working groups to examine priorities, policies, communications and the constitution and bylaws.

CHSF decided on the 2010-2011 top priorities:

- 1) To become more visible nationally;
- 2) To communicate more effectively with provincial member associations;
- 3) To find additional funding to launch National projects.

Headway has been made to become more visible nationally. CHSF executives met with the Canadian Association of Principals (CAP) to discuss common issues and to develop opportunities in working together. CHSF President, Janet Walsh, sits on the Advisory Council of the Canadian Education Association (CEA) and CHSF1st VP Brian Peat has been a part of the Copyright Consortium (CMEC) looking at this new legislation. CHSF submitted its Brief on Bill

C-32 - Copyright Modernization Act to the Legislative Committee in January 2011. It is posted on its website.

Special Meeting

A special teleconference meeting took place on February 5, 2011 to pass a motion to amend the fiscal year end from December 31st to August 31st. It was carried unanimously.

Varia

The Canadian Home and School Federation (CHSF) is working on a petition calling for the creation of a Minister of State in Canada for Children and Youth. A letter was sent to all provincial and federal MPs to find out their thoughts on this idea. Many positive letters have been received and are still coming in. The petition is being created with a dual purpose: to act as a petition and to include CHSF's ideal job description for this new minister. CHSF will be ensuring that any petition sent out to collect signatures will comply with all legal requirements. More information will be forthcoming.

CHSF started Teacher & Staff Appreciation Week (TSAW) in 1988, and the tradition continued in 2011 as TSAW was scheduled for Feb 13 – 19, 2011. A poster was sent electronically to all provincial associations for them to disseminate to schools.

CHSF continues to work towards banning the sale of Energy Drinks to minors. In response to a letter from the Canadian Minister of Health, follow-up letters have been sent to the remaining Provincial Health Ministers. CHSF will keep its members apprised of any new developments.

- The Finland model of education was discussed, including the fact that only oral proficiency in a second language is required in order to graduate, not writing and reading.

Resolutions

Several ideas for proposed Resolutions for the upcoming QFHSA AGM were discussed:

- 1. All programs developed by MELS should be available in both English and French simultaneously: QFHSA Resolution 2007/2 "The New Curriculum High School Textbooks in English");
- 2. More funds for specialized programs and / or schools need to be made available
- 3. More Globalization of Programs (i.e. how do we ensure that successful programs developed for an individual school can be implemented throughout other schools- e.g. Seminar on How Boys Learn)
- 4. More Professional Development Days for teachers to require them to learn the latest teaching methods (i.e.: the same way that lawyers do)
- 5. University training for new teachers

OFHSA HISTORY AND ARCHIVES PROJECT

This will be a valuable tool in educating our membership and the wider public about the influential role that parental involvement has played in Quebec's schools and communities in the 20th century. It should stimulate further involvement in this century.

Donna Sauriol, former QFHSA Executive Secretary for over 33 years, passed away on December 11, 2010. She was an invaluable contributor to this project and was responsible for keeping so many of the records and historical resources. The richness of our archives is largely due to her hard work.

A \$30,000 grant from a private foundation was received in late 2000.

History Project

McGill University historian Rod MacLeod and Mary Ann Poutanen have submitted draft manuscripts and further work is to be done once the archives are completed.

Archives Project:

Under the capable guidance and supervision of Gordon Burr, Archivist, McGill University and Josée Martel, Archivist, half of the relevant documents (60 boxes) have been archived.

The remaining documents are being sorted and will be archived by Marion Daigle, assisted by Carol Ohlin.

The archivists have been extremely impressed by the volume and quality of valuable information about the activities of volunteers working on behalf of the education and well being of children and families in schools and communities all over Quebec. This is particularly relevant to the minority language population.

Recommendation

It is recommended that local Home and School Associations take steps to record their history and to catalogue their archives. This is particularly important where school closures are concerned. Information is included in the AGM Conference kit.

Therefore be it resolved that Quebec Federation of Home and School Associations Inc. urge the Government of Quebec to respect the 2009 unanimous ruling of the Supreme Court of Canada that Bill 104 is unconstitutional, and henceforth, to *absolutely* take no further legal, *legislative and/or other* actions to lessen access to education in English.

Resolution 2010/4

Editorial changes to the last Be it further resolved:

Be it further resolved that Quebec Federation of Home and School Associations Inc. request the Minister of Education, Leisure and Sport to retain funding already in place *in the separate envelope (mesure spéciale)* and to provide additional financial support for training *for all personnel*, materials and resources.

Mr. Tyler had represented the plaintiffs both in Quebec and at the Supreme Court of Canada where the judges ruled that Bill 104 was unconstitutional. However, the Supreme Court permitted the province time to rewrite the law. The Quebec government responded by drafting Bill 103, and just prior to the summer recess invited interested groups to submit briefs. As our Federation considered that the revised law provided no substantive change, it was incumbent that we air our views in the public arena.
- June, July, August, September, 2010 Preparation and Presentation of a Brief on Bill 103, An Act to Amend the Charter of the French Language and other Legislative Provisions.
 - Given the specific rules regarding presenting a brief, and the limited time to have it ready, (August 16) the Federation owes a vote of thanks to Rickhey Margolese, Chris Eustace and Marion Daigle who worked tirelessly over the summer months to produce the Brief. There were countless rewrites and edits, but, by August 10, a 34-page brief was ready. Its essence thrust was that it is parents, not the State, who determine the education for their offspring; a message that is still not heeded in Quebec.
- <u>September 10, 2010</u> <u>Quebec City Presentation</u>
 <u>Four members:</u> Rickhey Margolese, Carol Meindl, Liette Chamberland and Jim Wilson travelled to Quebec City to formally present the Brief to the Parliamentary Committee of the National Assembly on Culture and Communication. The four needed to rehearse and

hone their remarks to meet the very strict time limits for oral presentations. A copy of the brief was widely distributed to all Home and School Associations, educational partners, community organizations and provincial and federal departments and agencies. An additional word of thanks to Rohinton Ghandhi, who, by using the original video, has produced copies of the Brief presentation to the National Assembly hearings on DVD, and they are available to interested parties.

August 25 – September 17, 2010 – Preparation and Presentation of a Brief to the Senate
 Standing Committee on Official Languages - Montreal Hearings

Shortly after receiving an invitation on August 25, QFHSA struck a Brief Committee: Carol Meindl, Marion Daigle, Rickhey Margolese, Jim Wilson. Their mandate was to express the Federation's views on the social, economic, educational and cultural conditions of the Official Languages Minority English-speaking population in Quebec.

<u>September 17, 2010</u> – Carol Meindl, President and Marion Daigle, Past President represented QFHSA at the public hearings in Montreal. Their presentation was extremely well received. Copies of the Brief have been widely circulated to Home and School Associations, educational partners, community organizations, provincial and federal government departments and agencies.

The Brief Committee is indebted to Rickhey Margolese, Brief Coordinator, for her extraordinary commitment in keeping the committee on target in meeting the strict deadlines.

A Brief presented to The Parliamentary Committee of the National Assembly Culture and Communications on Bill 103: An Act to Amend the Charter of the French Language and Other Legislative Provisions, August, 2010

Report to the Annual General Meeting - April 30, 2011 Submitted by Jim Wilson Co-Chair and Marion Daigle, Rights Committee Resource

On January 19, 2010 QFHSA Board of Directors authorized the Rights Committee to organize and prepare a bilingual brief to address the Federation's concerns addressed in Bill 103. This follows QFHSA's historical precedent in responding to any legislation which seeks to restrict the parents' right to choose the educational path best suited for their child.

The Parliamentary Committee of the National Assembly on Culture and Communications set a deadline of August 16, 2010 to receive all briefs. The Brief was submitted to Quebec City on August 10.

Several working sessions were spent on research, preparing drafts and revisions (at least 14) over the month of July. The committee is indebted to the translating and printing services for helping us meet our deadline. It was a team effort.

Background

Bill 103 was the Quebec government's response to the Supreme Court decision which declared Bill 104 as being unconstitutional, but allowed the law to stand for one year to allow the provincial government the opportunity to revise the law with a view to bring it within the bounds of constitutionality. Although the law had been passed in 2002, by a Parti Quebec government, it had received unanimous support in the National Assembly. Its principal provision was to prevent students who had attended a private English school for more than one year to obtain an eligibility

certificate for an English school education. Hitherto, this had been possible under both Quebec and Canadian law.

Summation of QFHSA Brief: Central Theme

QFHSA believes that all parents in Quebec, regardless of citizenship and linguistic status, should have the right to choose the language of schooling best suited for their children. At no time must a child's education be delayed because of a bureaucratic decision on eligibility for admission to an English language school.

The Brief explained the Federation's position on Bill 103 under the following headings:

1. **Parental Rights in Education: a Historical Perspective** – outlined the erosion of rights since the 1970s from the passage of Bill 22, Bill 101, The Canadian Constitution Act 1982 (section 23) as well as Bill 104.

2. Bill 103 – Procedural Impediments Trump Democratic Principles –

The Brief argues against the bureaucratic structures outlined in the Bill to further limit the right of entry into English schools.

3. Protection and Promotion of the French Language

The Brief argued that the supportive bilingual Minority English-speaking communities in Quebec do not threaten the French language.

4. The Future of the English Language School System in Quebec

The Brief argued that the English school system in Quebec is in decline and in jeopardy and that Bill 103 does not allow for the maintenance and nurturing of the English school system. This was supported by statistical data.

<u>Conclusions and Recommendations</u> (Excerpt from pages 19 – 20 of the Brief)

In a democratic society one should always seek to expand on rights, never to diminish them; with rights come responsibilities. In this case, it is the responsibilities of the majority towards the minority and the minority towards the majority.

Conclusions

We firmly believe that:

- 1. Bill 103 does not meet the intent and spirit of the ruling, as it does not constitute minimal impairment of the constitutional rights of Quebec parents. It fails to meet both the moral and legal aspects as prescribed in the Supreme Court of Canada's judgment on "Bill 104".
- 2. The perceived threat to the French language comes principally from being a smaller population in proportion to the Canadian and American cultures. The supportive bilingual minority English-speaking communities in Quebec do not threaten the French language.

3. All parents in Quebec, regardless of citizenship and linguistic status, should have the right to choose the language of schooling best suited for their children.

This belief is based on Article 26(3) of the *United Nations Universal Declaration of Human Rights*, 1948.

"Parents have a prior right to choose the kind of education that shall be given to their children."

Recommendations

We respectfully recommend that:

- 1. The Government of Quebec withdraw Bill 103.
- 2. The Government of Quebec respect the ruling of the Supreme Court of Canada on "Bill 104", as stated in our Resolution of April 24, 2010:

 Therefore Be it Resolved that the Quebec Federation of Home and School Associations Inc. urge the Government of Quebec to respect the 2009 unanimous ruling of the Supreme Court of Canada that Bill 104 is unconstitutional, and henceforth, to absolutely take no further legal, legislative and/or other actions to lessen access to education in English.

- 3. The Government of Quebec undertakes further action to abrogate section 59 of the Constitution Act, 1982, as stated in our Resolution of May 3, 2008:

 Be it further resolved that s.23(1) of the Constitution Act, 1982, which guarantees access to minority official language education on the basis of a citizen's mother tongue, be brought immediately into force in Quebec, by the exercise of the power conferred by section 9, that is to say, by the proclamation made by the Queen or the Governor General under the Great Seal of Canada with the authorization of the legislative assembly or government of Quebec.

Delegates had several working sessions prior to their presentation. There was a vigorous discussion with the Parliamentary Committee and QFHSA did an excellent job in defending our position.

Consultation with the Standing Senate Committee on Official Languages on September 17, 2010

Report to the Annual General Meeting - April 30, 2011 Submitted by Marion Daigle, QFHSA Past President

On August 25, 2010 QFHSA received an invitation to prepare a presentation for the public hearings of the Standing Senate Committee on Official Languages to be held on September 17, 2010 at the Hotel Delta Montreal.

Mandate: The Committee's purpose on its province wide tour (Sept 13 - 17) was to assess

the social, economic, educational and cultural conditions of the Official

Languages Minority English speaking population in Quebec.

QFHSA Executive Committee agreed that the Federation prepare a bilingual Brief for presentation to the Committee.

<u>Brief Coordinator</u> – Rickhey Margolese. The Federation is indebted to our extraordinary team leader who went well beyond the call of duty to organize timelines, deadlines, layout, correspondence, mailings, press releases etc.

Preparation of the Brief:

Several working sessions were spent on research, preparing drafts and revisions over a 22 day timeline. The committee is indebted to the translating and printing services for helping us to meet our deadline. It was a team effort.

Presentation:

President Carol Meindl and Marion Daigle, Past President, represented QFHSA. Presentations at the public hearings were limited to 30 minutes consisting of a 5 minute introduction followed by a question and answer period. In her presentation the President focused on several issues and challenges, particularly related to the education sector. She briefly outlined five topics of special interest to the Federation and tabled a Brief which would expand on these ongoing concerns

1. <u>Community Growth and Development</u> – the school is often the primary cultural institution, especially in rural Quebec. Our schools are in jeopardy and constantly in need of resources – human and financial.

- 2. <u>Wider Access to English Education</u> restrictive legislation on eligibility for English schooling remains our most serious concern. Shrinking student populations have led to shrinking school budgets. A shrinking school population has led to a shrinking pool of volunteers. Home and Schoolers are finding it increasingly difficult to find the hours necessary to maintain services.
- 3. Official Language Minority Communities Support Programs the President expressed our appreciation for both the core and special projects funding provided by Canadian Heritage. These funds are essential to all of the minority language communities and organizations in Quebec.
- 4. Accountability for the Funding of Minority Language Education and Second Languages <u>Instruction</u> –this has been on the QFHSA agenda for forty years. Carol emphasized the need for increased efficiency in the reporting procedures and in the opportunity for public scrutiny by taxpayers of the spending of tax dollars. Maintaining quality French language programs is one of the top priorities in this area of concern.

In her conclusion the President emphasized the need for increased recognition of the status of the English language minority in Quebec. She said, "We are a minority within a minority and that is often forgotten when decisions are made affecting the vitality of our very diverse community".

In the discussion which followed the Committee praised the quality of the presentation. They were visibly impressed about the Federation's wealth of detailed knowledge and activity related to the Official Languages Act since 1970. They indicated to us and other presenters during their week's visit that they had not realized just what a challenge it truly is to be an English minority in Quebec.

David Birnbaum, Executive Director, QESBA said on September 17. 'The Francophone minority communities in the rest of Canada do not have to wake up every morning knowing that the perception around them is that anything that is done to their benefit is perceived to be at the expense and detriment of the majority'.

Copies of the Brief on Bill 103 prepared for the Parliamentary Committee of the National Assembly in August 2010 were circulated to the Committee.

RECOMMENDATIONS

- 1. Increased consultation opportunities with both provincial and federal Official Languages departments by the "grassroots" level of stakeholders.
- 2. Increased support to help access to English education, essential for the survival of the schools and communities of the English language minority of Quebec.
- 3. Increased efficiency in the reporting procedures for the accountability of funding for minority language education and second languages instruction. Increased opportunity for public scrutiny on the spending of our tax dollars in this area must be respected.

FAMILY TREASURES ESSAY COMPETITION

Report to the Annual General Meeting - April 30, 2011 Submitted by Carol Meindl, President

Mandate:

- To give students an opportunity to explore their own family history through the description of a 'family treasure'.
- To provide a creative opportunity to combine the areas of English Language Arts, History and Culture.

History:

The original concept of the Family Treasures Essay competition was credited to Ben Loomer (LEARN) who presented it at a CLC Resource Committee meeting as an opportunity for community organizations to participate in Family Literacy Day

General Information

The Competition was open to all Home and School member associations and CLC schools, targeting Cycle 3 (Grade 5-6) students and Secondary 1 and 2 (Grade 7-8)

Students were invited to write a 250-word (Cycle 3) or a 350-word (Secondary 1,2) word essay describing a family treasure, why it is important to their family and what it means to them. Submissions could include a digital photograph or illustration, if desired.

QFHSA assembled a panel of three judges: Kuljinder Kaur Magee- QFHSA Literacy Committee; Rod MacLeod – QAHN (Quebec Anglophone History Network); and Ben Loomer - LEARN. Essays were judged on content, spelling, grammar and poignancy.

English Arts teachers, as well as History and Ethics and Culture teachers, initiated the project in their classrooms and submitted the top five choices to QFHSA. The contest was launched January 27, 2011 in conjunction with Family Literacy Day and submissions were accepted up until March 18th, 2011.

Youth Exploring Science (YES) Project

Mandate

Schools in the Greater Montreal area have access to many services and activities for children. The YES project was initiated by QFHSA to provide services to member schools and Community Learning Centres in the off-island areas of Quebec, where these kind of educational opportunities do not readily exist. A partnership with the CLC network and LEARN (Leading English Education and Resource Network) would allow us to reach these children via the CLC video-conferencing system.

The Project

An application for the Youth Exploring Science Project was submitted to Patrimoine Canadian Heritage (PCH) and the Natural Sciences and Engineering Council of Canada (NSERC) by Harold Spanier in 2009. In 2010, PCH accepted the proposal and granted the project \$23,000. The original concept was then modified to reflect the more modest budget.

Committee members met with Evelyn Castillo and contracted her for workshop animation. Evelyn had been giving *LiveStuff* workshops for the last 4-5 years and had a number of very interesting and suitable subjects prepared. The committee chose a series of five workshops for elementary and high schools. Invitations were sent out to all English schools within a reasonable driving distance from a local Community Learning Centre (CLC), of which there are 23 in the province.

Elementary workshops ages 7-11:

Hydroponics- Kids jumpstart their own hydroponics garden while learning about the cultivation method as well as the nutritional needs of plants.

Dino Dig- An activity that transforms kids into real paleontologists! Each child received a rock containing a mystery fossil that would be revealed using paleontology tools.

Root Beer making- An activity that teaches kids how to make home-brewed root beer while learning the basics of biotechnology.

Health Matters- Kids learn about different ways of protecting themselves against microbes and keeping their body healthy.

The science of perfumes- One of the most ancient ways of communication is the sense of smell; this activity lets kids explore this sense while creating their own perfume.

Secondary Workshops 12-17:

DNA extraction - Kids extract the plant DNA and learn about this very important molecule.

The science of perfumes - (see description above)

The science of cosmetics - This activity lets kids get acquainted with the steps producing a cosmetic product from laboratory research to mass production.

Where's the fat? - Kids figure out the percentage of fatty content using real food, while learning about healthy eating habits.

Root Beer making - (see description above)

Outcome

The workshops took place on Saturday afternoons between 1:00 pm -3:30 pm from the Riverdale High school CLC in Pierrefonds using the video conferencing network system. Two CLCs participated in the project: Eaton Valley and Greater Huntingdon, with a total student participation of 25, for elementary and high school. The workshops began on March 12 and were offered for the following four weeks. The students were very enthusiastic and loved the workshops and the video-conferencing format.

Recommendation

It is clear, from this pilot project initiative, that there is a need for these services in the regions. The committee recommends that QFHSA continue to seek funding to offer these kinds of workshop services to members in the regions through the CLC video conferencing network.

Community Learning Centers Resource Committee

Report to the Annual General Meeting - April 30, 2011 Carol Meindl/ Rickhey Margolese-Liaisons

Mandate of the Community Learning Centers: Schools, vocational and adult training centers are not only part of the educational system; they are part of the communities they serve. This connection is important in Anglophone communities, especially those that only represent a small percentage of the total population in their area. The benefits of this connection have been well demonstrated in a wide variety of contexts. The school's impact on students is strengthened by the support of family and community, while the latter are strengthened by the support of the school.

Objective: 'The Community Learning Center's initiative is aimed at supporting the development of a diverse group of CLCs that will serve as 'hubs' for English-language education and community development in their respective communities, as well as to offer models for future practice. 'Together we're stronger' is a particularly apt expression to describe the potential of collaborative school-community relations: schools/centers, community groups and other public and private sector agencies working together to improve the opportunities to and from life-long learning for youth and adults and contribute to the overall development of the community. It is for this reason that the Ministère de l'Éducation, du Loisir et du Sport (MELS) is supporting the development of 23 Community Learning Centers located in schools across Quebec and is preparing to develop three more in New Richmond, New Carlisle and Grosse-Ile (for a complete list of CLC locations go to www.learnquebec.ca/en/content/clc). Unfortunately, the CLC network has been underused and in some cases not developed. There needs to be more information about what the CLC network can offer community groups and parents. The potential is enormous.

<u>The CLC Community Resource Committee</u> (CRC) was founded in 2007 with the mandate to facilitate communication and collaboration between the Community Learning Centers and community partners (such as QFHSA). The Committee is coordinated by the CLC Provincial Resource Team with membership from organizations (QFHSA) serving English-speaking communities across Québec.

As a result of its participation on the CRC, the QFHSA has been actively working in partnership with the established CLCs and has developed two projects in 2010-11:

- <u>The YES (Youth Exploring Science)</u> project offered science workshops to 25 students 7-11 years and 12-16 years from schools of the surrounding area of the Eaton Valley (Eastern Townships) and Greater Huntingdon (South Shore) CLCs and broadcast them through their video-conferencing network.
- <u>Family Treasures Essay Competition</u> which invited all QFHSA local association schools plus Community Learning Center schools to participate in an essay writing competition that would provide an opportunity to explore personal family history as well as culture and English Language Arts.

The QFHSA will continue to explore areas of collaboration with the CLCs in 2011-2012.

QUEBEC COMMUNITY GROUPS NETWORK (QCGN) REPORT

Report to the Annual General Meeting, - April 30, 2011 Submitted by Carol Meindl, President

<u>Mission:</u> The Quebec Community Groups Network (QCGN) identifies, explores and addresses the strategic issues affecting the development and vitality of English-speaking Quebec. It encourages dialogue and collaboration among its member organizations, individuals, community groups, institutions and leaders. In partnership with member organizations, stakeholders, community leaders and institutions, it articulates the views of English-speaking Quebec on issues of strategic concern and takes action to address them.

The QCGN strives to be the recognized voice for English–speaking Quebec with the Federal and Provincial Governments. They are often invited to participate in round table discussions and to submit briefs to government committees. They were responsible for the enormously successful visit of the Standing Senate Committee on Official Languages to Quebec and Montreal in September of 2010. The QFHSA was invited to testify as witnesses at those hearings.

The QCGN was asked to add its voice to concern raised by the English Community about the proposed reforms to the structures in the Centres de réadaptation en déficience intellectuelle et en troubles envahissants du développement (CRDIs) of Montreal that would threaten health and social service institutions of the English Speaking Community of Quebec; The QCGN wrote letters to regional and provincial access committees, to MNAs in affected ridings and to Ministers of Social Services and Health alerting them to the communities concern. The item was removed from the agenda as a result of the information campaign, an excellent example of the power of the English Speaking Community when it mobilizes and speaks with one voice.

<u>Activities</u>: The QCGN had its Annual General Meeting in Sainte-Foy, June 2010 and Carol Meindl attended as the QFHSA representative. She has attended several Board meetings as well as Board orientation sessions and other events that the QCGN has developed in partnership with its member organizations over the past year. Although QFHSA no longer has an Executive Director to participate in the QCGN E.D. Network, Carol Meindl, as President, has functioned temporarily in this capacity.
