ENGINEERING FEASIBILITY STUDY:

The contract for the community radio network has been signed by the Coasters Association and Petrie Telecommunications. Mr. Jacques Lachance will be our consultant for the study and will be responsible for the liaison, writing and presentation of the final engineering report. Petrie Telecommunication Ltd. shall determine the minimum required radiated powers, antenna heights and location suitable antenna sites in order to provide reliable communications on the following radio links that were decided by radio network from all committee regional communities\municipalities on the Coast.

Scenario #1

Consolidation of the facilities and creation of a first network involving Blanc Sablon and a support studio in the municipality of Bonne Esperance.

Scenario #2

Consolidation of the facilities of a second network linking St. Augustine and Kegaska.

Scenario #3

Linking Blanc Sablon and Kegaska through a network.

Petrie telecommunications shall deliver a progress report by February 10th, a draft report by March 23rd and a final report by May 25th. Communications will be made with the regional radio committee to ensure ongoing contact and coordination of study.

YOUTH PROJECT COMMITTEE:

An Ad-hoc committee was organized to formulate a plan to meet the objectives of the youth project. This committee met in St. Paul's River on January 15th. The minutes of this meeting will be sent to you as soon as the Secretary has completed it.

HOSPITAL SERVICES:

The 1992-1993 year was marked by numerous changes in the nursing department. Ms. Madeleine St. Gelais was named Interim Director of Nursing following the departure of

Nicole Berube in May, The new organizational plan saw the transfer of diagnostic services (radiology, laboratory, E.C.G.) to the Professional Services Department and the transfer of the archives and reception the Executive services to Director. By the same token, management of the clinics was transferred to Administration of Coast Programs Department on January If you wish to 11, 1993. obtain a list of all coastal nurses, social workers, etc. - we have it on file.

SUPER REGIONAL SERVICES - H. & S.S.

CASA and the Coasters are working the health dossier together for services off the Coast, because a lot of our problems are similar. Also, working together gives us a better chance of receiving outside help.

A letter was written by A.Q. and all the Associations to meet with Mr. Dupuy at the Spring Planning Convention in Ottawa. The response by Raymonde Gagnon, Scheduling Assistant, to the request was that the letter will be brought to the Minister's attention.

JOINT YOUTH PROJECT:

This project was applied for by Outaouais Alliance to hire a co-ordinator at their office to manage the project and each Association and Alliance Quebec will hire a researcher who will research the employment needs for our youth in our region, etc. All the researchers will make their own report and share it with the others and the co-ordinator will compile all the reports into one. The project was accepted and will start in the new fiscal year.

FORUM FOR YOUNG CANADIANS:

As you are aware, the Coasters Association sponsored one student this year to attend this Forum in Ottawa which was Colin Shattler from the St. Augustine school. We contributed an amount of \$195. towards Colin's trip out of our


PROJECTS:

Priscilla Griffin was selected to create a Handbook for the Board. Her project started the 10th of January and will be completed on February 25th. It is for seven weeks.

Monique Collier was selected for the seniors project. She will produce a pamphlet and a report for our seniors. Her project started on the 10th of January and will be completed

on March 4th, it is for eight weeks.

Dwayne Keats was chosen for the Youth retention project, his project started on January 17th and will be completed on September 9th, it is for 36 weeks. He has to do a thorough report on the employment and educational needs of our youth on the Lower North Shore.



YOUR EXECUTIVE COMMITTEE WAS QUITE BUSY THIS MONTH MAKING DECISIONS AND HERE ARE THE CONCLUSIONS:

- They selected the candidates for the three projects.
- ▶ After an inventory of stock was done at the office, they decided to insure our stock for \$55,000. The cost to insure our stock from December/93 to December/94 was \$2,127.68.
- ▶ They decided to change the dates of the A.G.M. to March 18, 19 & 20, due to the heavy work load at the office and other commitments at that time.
- ▶ A note-pad computer and a dita-phone was purchased for the youth project within the budget. They also decided to buy a computer for the office within the youth project budget. It was decided that Dwayne set-up office in his home and install his own phone.
- ▶ They decided that the Youth retention committee meeting be held in St. Paul's River. They all attended the meeting, except Wilson Duty calls.
- ▶ They agreed to pay Mr. Fraser's accommodations and vehicle transportation since his college could not afford to do so. The college purchased his ticket to attend the youth meeting.
- ▶ They agreed that Monique work the French communities for her senior project.
- ▶ They agreed to pay Chris Gascon an advanced fee of \$1,000. towards the Community Directory project. Chris, former employee of QLF, is helping to complete the Directory.
- ▶ They decided that we should sell tickets for Inter-Canadian and Maybelline together and the Quilt separately. The tickets will be sold up to the AGM and again at the AGM.

▶ They agreed to have a conference on Thursday February 10th, to discuss business arising concerning the AGM and a few other issues.

PROJECT COMPLAINT LETTER:

A letter of complaints was received from one of the candidates, Ms. Eileen Cox from Chevery, stating that she felt that favouritism and family members were the key words when the candidates were selected for the three projects. Mr. Patrick Maurice expressed the feeling of some residents of St. Augustine in the selection process of these projects. Residents of St. Augustine also requested that extra members be on the Executive Committee. This issue will definitely be placed as priority on the agenda of our next Board meeting.
