

MESSAGE FROM RENE BABIN

I thank you for the opportunity to express some of my thoughts on the Tourism Conference which I attended on Quebec's Lower North Shore, March 8 to 10, 1996.

It is clear that through the discussions that were held in the workshops, participants expressed the need for a tourism strategy to be inclusive within a process of regional development as a whole, linking economic benefits with regional identity, cultural development and community pride. The development of a tourism strategy must involve the participation of community members and organizations. This will ensure a coordinated effort among key players and stake holders to work together in developing objectives and action plans for the region.

On this note, I have outlined some basic principals to consider when preparing a tourism development strategy for a region that is predominantly of a minority language:

- That the region maintains and develops its ties with the majority group or other minority groups in the region.
- ❖ That a broad range of representation and partnership is needed for tourism and economic development initiatives, including other minority language groups in the region.
- * Efforts should be made at offering products and services in both

official languages to potential visitors and clientele, and strengthening ties within the political structure of the province.

Long term efforts at community economic development, the basis of a successful tourism strategy, will be achieved through consensus, involving as many people as possible. I applaud the efforts undertaken by the organizing committee and the Coasters Association, and I look forward to the opportunity of working with them, and possibly a new regional organization, again. If I can be of any assistance or if you would like to discuss these matters further, please do not hesitate to contact me.

PROJECTS

Paie

We applied for a Paie Project through Travail Quebec to employ an office clerk for a duration of 26 weeks.

Extra

We applied for an Extra Project through Travail Quebec to employ 15 community workers, for a duration of 12



months. We have requested a subsidy of \$18, 000 to cover operating expenses.

Article 25

Application for an Article 25 project was submitted to Human Resources Development to employ an office receptionist. We requested \$13,500.00 to assist with the overhead costs.

TAGS Program

We have submitted a project under the tags program through

HRD to hire a regional Tourism Animator. We requested a contribution of \$66, 279.00 to cover all operational costs.

Youth Potential

We applied for a "Youth Potential" Project to Canadian Heritage, as the second phase of a three phase project. The positive results of our two recent Youth Project may benefit the results of this one. We've requested a total of \$31,143 in funding to cover all costs.

Student Career Placement

The Manager of HRD's employment centre sent us an application form for the Summer Employment Program for students, with background information. have submitted 2 projects: one "Gardening" for entitled animators to work the three sectors, and we have requested a total of \$11, 211 in funding; entitled another Development" for 7 students, and we have requested a total

of \$ 22, 521 in funds. We have already received many phone calls inquiring of our Student Projects this year. We are not the only ones who are anxious to receive positive feedback on these projects.

Tourism Conference

Nathalie is working to complete the Resource Guide and she has received many Biographies from the authors. We are constantly receiving faxes of translations for the Resource Guide from Yvan Gelinas. Nathalie's project has been extended to make sure that the Resource Guide will be completed and distributed.

Canadian Heritage granted us an amount of \$4,687 for translation expenses for the Tourism Conference. They are requesting a report to be submitted on the activities carried out under the grant within the two months.

Also they have awarded us another \$3000 for the follow-up to the conference.

Letter to the Principal

A letter was sent to Mr. James Smith regarding the manner in which Coasters employees were treated before and during the Tourism Conference.

Minister of Transport

- ♦ Live Entertainment
- ♦ Plus, much more

We have a copy of their plan of this vessel at the office, and we intend to keep in touch with Mr. Dumas for future developments.

They asked the Coasters to write a support letter to the Minister of Transport for their Norta Inc. Company, and a letter suggesting to have the proposal call by June 15th. It was decided that we will support their initiatives and letters will be produced.

The President visits the office a few times per week to attend to business or to do errands for the association.


