QFHSA 65th ANNUAL GENERAL MEETING – April 25, 2009 BUSINESS MEETING PROCEDURE

- 1. The Annual General Meeting [AGM] is conducted in accordance with our Constitution, By-Laws and Standing Rules. In the case of any procedural dispute reference shall be made to Robert's Rules of Order Revised.
- 2. Each official voting delegate of each Member Association shall have one vote on any question which comes before the meeting, except for associations more than 250 kilometers from Montreal. Such Associations will still be entitled to three votes, expressed either as an identical or divided vote. Application for such privilege is to be presented in writing to the Executive Secretary prior to the start of the business portion of the Annual General Meeting.
- 3. The **quorum** for **transaction of business** at the Annual General Meeting shall be twenty-five percent [25%] of Member Associations in good standing, represented by their official representatives or accredited alternates.
- 4. Voting shall be by ballot or show of hands. All questions shall be decided by a majority of those present and entitled to vote, except those which require a two-thirds [2/3] majority. On ballot votes, the votes of each association shall be handed in by the voting delegates of each association individually but at the same time. Counting of the votes shall be done by non-voting participants.
- 5. A **delegate** may not **speak** for more than two **[2] minutes** on any question under discussion, nor more than twice on any particular motion or resolution. Any person wishing to speak needs to stand and come to the microphone (if we have one).
- 6. Amendments to the Constitution and By-Laws require a two-thirds [2/3] vote of the delegates present and entitled to vote. Notice of the proposed amendments must have been mailed to all Member Associations at least ten [10] weeks prior to the meeting. Modifications to these proposed amendments received two [2] weeks before the AGM will be considered, but no modification may be made from the floor.
- 7. Resolutions to the Annual General Meeting must have been circulated to the Member Associations eight [8] weeks prior to the Annual General Meeting. Resolutions received after the date specified will be presented as Emergency Resolutions only after consideration by the Chairman of the meeting and the Resolutions Committee. Delegates presenting resolutions are reminded that they must be present at the time designated on the agenda for the presentation of their resolution. The presenting party may speak to the resolution, or amendments thereto, for not more than FIVE [5] minutes. In addition to amendments received two weeks before the AGM there may be amendments emanating from the caucus session held earlier, but no further amendments may be made from the floor.

PARLIAMENTARY PROCEDURE

PRINCIPLES

PURPOSE

- Justice and Courtesy for all
- One thing at a time
- Recognition of the will of the majority
- Protection of the rights of the minority

 To conduct business in an orderly and democratic manner by one or more of the following ways:

- ✓ committee reports
 - ✓ motions or resolutions

To participate effectively in the proceedings of meetings, each person needs to know the fundamentals of parliamentary procedure.

THE MAIN MOTION

WHAT IS A MOTION?

A main motion introduces a new item of business; it is a proposal that the group take a certain action. It is the basis of all discussion and states the bounds of discussion. All remarks pertain directly to the contents of the motion on the floor. The making of the motion comes first, discussion follows. A subsidiary motion qualifies the main motion or proposes an alternate timetable for consideration.

WHEN IS A MOTION NEEDED?

- It forms a basis for discussion on all major decisions of the group.
- When in doubt, ask for a motion to be proposed.
- Motions must be made on all matters involving <u>finances</u> not already included in the budget as approved.
- On minor matters, a question may be resolved by the chairman 'taking the sense of the meeting'.
- The decision must be clearly stated for the secretary to report in the minutes as well as for the benefit of the members.

THE STEPS TO PRESENTING A MOTION ARE:

- member stands or raises a hand and says: "Madame Chairman/Mr. Chairman." The chairman recognizes the speaker by name.
- 2. The member says, "I move that ...", stating or reading a motion.
- Another raises a hand to be identified by the chairman, then says:
 "I second the motion." The seconder believes the motion should be discussed, but <u>may not</u> necessarily be in favour of it.
- 5. The mover usually speaks first, giving the reasons for the motion. The opportunity to speak to the motion must be given to anyone who wishes to speak to or oppose the motion. Discussion should be addressed to the chairman.
- 6. At the end of the discussion, the chairman says: *"If there is no further discussion" or "Are you ready for the question?"* Then: *"The motion is that" "All in favour?"* (pause while the count is taken by the secretary) *"Opposed?"* (pause while the count is taken by the secretary)

"Abstentions?" (pause while the count is taken by the secretary) "The motion is carried" (or is defeated).

7. If anyone calls "Division" (questions the voice vote), the chair calls for a show of hands or a standing vote: "All in favour raise your hand. All opposed ... " If a majority request it, the vote may be taken by ballot. A "ballot vote" is the recommended procedure for election of officers and for resolving a contentious issue.

SUBSIDIARY MOTIONS

AMENDMENTS CHANGE MOTIONS: To qualify the idea of a motion, but not to change the subject or the intent of the main motion.

1. "I move to amend the motion by":

Inserting or adding a word, phrase or sentence.

Striking out a word, phrase or sentence.

Striking out and inserting a word or phrase or substituting a sentence or paragraph.

- 2. "I second the motion to amend."
- 3. "It has been proposed to amend the motion to read as follows"

The chairman states the main motion and the amendment so the group will understand how the amendment changes the motion. Amendment is handled in the same way as a motion with:

Discussion: "Is there any discussion?"

Question: "If there is no further discussion, the amendment is"

Vote: "All in favour of the amendment"

Chairman announces the outcome:

"The amendment is carried (or defeated)."

"The motion now before the meeting is"


(states the motion plus the amendment(s) if it carried)

In dealing with motions, the vote is taken first on the amendment. If passed, the amended motion is voted on. If the amendment is defeated, the main motion in its original form is voted on.

TO REFER: A question is referred to committee for further study and to submit a recommendation to the group at a later time.

TO TABLE: To set the matter aside until someone moves to reconsider it. TO POSTPONE DEFINITELY: Postpone discussion until more facts are available. TO POSTPONE INDEFINITELY: The motion may not be considered again that year.

Recommended useful resource materials available for reference during a meeting: A copy of your organization's Constitution and By-Laws. Robert's Rules of Order or other guide to basic rules of parliamentary procedure.

The remaining Directors were also presented to the delegates and thanked for their services: Leah Trineer, Executive Vice-President; Oliver Cole, Treasurer; Marlyn Brownrigg, Vice-President; Beverlee Bishundayal, Secretary; and Directors: Diana Donnelly, Carol Meindl, and Barbara Schnider. Director Brian Rock, recipient of this year's Leslie N. Buzzell Award, was not present as his return flight from an education conference in Portland, Oregon, had been delayed in Chicago due to bad weather. Past President Donna Norris, Chair of the Nominations Committee, was unable to attend. Also present were Marion Daigle, a Past President and QFHSA Literacy Director, and Barbara Milne-Smith, a Past President and Secretary of the Rights Committee.

The President welcomed guest Tarek Toni, QFHSA Advisor, Official Languages Support Programs, Department of Canadian Heritage.

Membership awards were presented by Marlyn Brownrigg and Barbara Schnider, Membership Co-Chairs. Suzanne Gionet of Pierre Elliott Trudeau Elementary School (P.E.T.E.S.) was the recipient of the teacher book draw. Newsletter awards were presented by Diane Radu, Editor of the QFHSA *NEWS Focus on the Locals* section.

The President welcomed everyone and briefly explained the contents of the Conference Kits.

4. **PRESIDENT' S REPORT** (Book of Reports, pages 13-14)

Debi Brown presented her report, noting that it has been a very busy year, including media attention resulting from our public stance on the Bill 104 Legal Defence Fund. The January meeting with the Minister of Education, Leisure and Sport (MELS) to discuss the Governance of School Boards was highlighted in the April issue of the QFHSA *NEWS*. **MOTION:** Diana Donnelly (Lindsay Place High School)/Lindsay McLeod (St John Fisher) to accept the President's Report. **CARRIED**

5. CANADIAN HOME & SCHOOL REPORT (Book of Reports, page 25)

Marlyn Brownrigg, the QFHSA delegate to CHSF, spoke to her report. In June 2007, she attended the CHSF Annual Meeting in Saskatoon and the Midterm meeting in Ottawa in November. The two main CHSF initiatives are directed towards educating and informing parents: the DrugWise Parents project and Parenting the Net (MNet). The 2008 Annual Meeting will be held at Sheridan College in Oakville, Ontario, at the end of May.

During this year the Membership Committee focused on reviewing the contents of the Membership Kit, initiating the Group Affiliate Membership campaign, and contacting the local associations on a regular basis with phone calls and email by the Directors. Sherwood Forest Home & School will host a LBPSB Sector 3 Regional Council meeting on May 7.

- 7. <u>LITERACY REPORT</u> (Book of Reports, pages 32-34)

Marion Daigle highlighted some of the major activities of the year listed in the report, including mailings of boxes of books to different regions of Quebec that do not have access to bookstores and libraries. She noted that 14 new topics have been added to the *Children's Literacy Resource Guide* since its original distribution, including two new pages included in the Conference Kit – *Magazines for Children* and *Literacy and Comics*. Dorothy Nixon was thanked for her work in developing these additional pages. Also acknowledged for their financial support were the Gazette Raise-a-Reader campaign and Geoffrey Kelley, MNA. Tembec Paperboard Group has donated many boxes of magazines for pre-school children and a generous supply of craft paper. Diana Donnelly described the Lindsay Place High School pilot project - a special literacy program for students reading below grade level. Funds from the Raise-a-Reader grant have been used to provide age-appropriate books for these teen "reluctant" readers. These students were enthusiastic volunteer participants in the September 2007 RAR fundraising campaign.

8. **<u>RIGHTS REPORT</u>** (Book of Reports, pages 43-44)

In the absence of the Rights Committee Chairman, Brian Rock, the report was presented by Marion Daigle. At the 2007 AGM, two resolutions proposed by the Rights Committee were approved:

2007/4 Retention of English Schools 2007/6 Permanent Linguistic Voters List for School Board Elections

• In January 2008, Debi Brown and Leah Trineer met with Michelle Courchesne, Minister of Education, Leisure and Sport (MELS), for the consultation on school boards. At that meeting, the Minister indicated she had read the 2007 resolution on the Permanent Voters List and agreed that the automatic transfer of parents to to a French school board voting list after their children graduate from an English

- high school was not logical. The Minister stated that she intended to raise this issue with the Cabinet.
- The 'Bill 104' Legal Defence Fund has been established to assist the 26 families who are appealing this law to the Supreme Court.
- Graham Fraser, Commissioner of Official Languages, will meet with QFHSA on June 13.
- Enrollment figures for Quebec English language schools for 2006/07 and 2007/08 continue to indicate a serious decline as the number of high school students is not replaced with incoming kindergarten students.
- MOTION:Diana Kowal-Gibson (Lindsay Place High School)/Barbara Schnider
(Jubilee) to accept the recommendation to vote on Resolution 2008/1
Wider Access to English Education.CARRIED
- MOTION: Diana Donnelly (Lindsay Place High School)/Marlyn Brownrigg (Jubilee) to accept the Rights Report. CARRIED

9. **RESOLUTIONS AND POLICY** (Book of Reports, pages 41-42)

PRESIDENT'S REPORT

Report to the Annual Meeting – April 25th, 2009 Submitted by Debi Brown, President

The theme for 2008 – 2009 was *Building Partnerships*. The theme for 2009 – 2010 is 65 Years of Partnership.

The Board of Directors has been very active during the past year since the previous AGM. Board meetings were held on Saturdays in June, September, November, January, February, and March. In addition, the Directors organized and attended the AGM, Post-AGM meeting, Executives Workshops for local associations, the Fall Conference, and the Appreciation Dinner. Additional meetings, particularly of the Executive Committee, were held through teleconferencing. One-third of our Directors live outside of the Montreal area and travel long distances to attend our functions and Board meetings.

Committees were working hard on behalf of our membership and schools. Please see their reports for a summary of these committee activities:

<u>CHSF – Canadian Home and School Federation</u>. Marlyn Brownrigg, QFHSA Vice-President, represented our provincial organization at the 2008 CHSF Annual General Meeting in Oakville, Ontario, and at the Mid-Term meeting in Ottawa in November. In June, she will attend the 2009 AGM in Winnipeg.

Communications with local associations

- 4 issues (June, September, December, March) of the Home and School *NEWS* were mailed to the home addresses of all members, as well as Group Affiliate members, liaison organizations, and English schools across the province.
- Local association presidents received phone calls and e-mail messages on a regular basis from the Directors.
- Mailings were sent throughout the year with information and invitations to special events such as the Executive workshops, Fall Conference, Appreciation Dinner, AGM.
- The provincial office was available as a resource for information.

Other activities

1. On <u>May 3</u>, at our 2008 Annual General Meeting, the keynote speaker, Brent Tyler, presented a history of the restrictions of the right of parents to choose for their children the language of instruction in education in Quebec. Mr. Tyler has been fighting on the behalf of students who have not been allowed to enter English language instruction schools. Although in August 2007 the Quebec Court of Appeal ruled that Law 104 was unlawful, the Quebec government filed an appeal to the Supreme Court of Canada. In

December 2008 Mr. Tyler appeared before the Supreme Court of Canada to represent the families challenging the government's appeal. QFHSA launched a fund-raising campaign to assist the legal expenses of these families and raised \$1,345.

- 2. At the AGM we welcomed new Directors Liette Chamberland and Charlene Morrison to the Board and welcomed back Rickhey Margolese, a long-time Home & Schooler.
- 3. At the <u>June</u> Board meeting the President reported that interviews were underway to find an Executive Director. She shared her vision for a change in the role of the Directors of the Board when an Executive Director is hired. It centered on streamlining committees and to have them take a more active role.
- 4. In <u>May</u>, QFHSA Vice-President Marlyn Brownrigg attended the Canadian Home & School Annual Meeting in Oakville, Ontario, on our behalf.
- 5. In <u>August</u>, the Personnel Committee completed its interviews and selected a candidate, Roch Gamache, for the position of Executive Director for a term to end March 31, 2009, subject to renewal if funding is secured.
- 6. In <u>August</u>, Directors and staff were surveyed to determine how much time and what duties they perform for QFHSA with an objective to re-organize the committee structure.
- 7. In <u>September</u> the President and Executive Director met with a representative of the Department of Canadian Heritage Official Languages to discuss our funding.
- 8. In <u>September</u> QFHSA offered its support to several English Montreal School Board local Home and School Associations operating daycare services which had received a summons from the Commission des relations du travail. The Confédération des syndicats nationaux challenged the operation of these daycares since the employees were not covered by the collective agreement governed by the CSN. Roch Gamache, Executive Director, organized an information session with the local associations at the EMSB and other follow-up meetings. Our legal counsel was also present.
- 9. In <u>September</u> Rickhey Margolese, Brian Rock, Roch Gamache and Debi Brown met with Christos Kritsidimas, political attaché for MNA Yolande James, Minister of Immigration and Cultural Identity in response to our Resolution on Wider Access to English Education.
- 10. Throughout the year the Directors have discussed the liability insurance coverage for local associations and continue to work on finding a solution that meets their needs.
- 11. Under the guidance of the Executive Director there have been weekly staff meetings with the President in attendance.

I would like to acknowledge and thank Leah Trineer, Beverlee Bishundayal, Oliver Cole, Marlyn Brownrigg, Liette Chamberland, Diana Donnelly, Anne MacWhirter, Rickhey Margolese, Carol Meindl, Charlene Morrison, Brian Rock, Barbara Schnider and Sheila Splane for their dedication and hard work to the QFHSA Board of Directors and its committees

.I would also like to thank our resource persons, without whom much work would not have been done: Harold Spanier, Marion Daigle, Sylvia Adams and Pat Waters.

A thank you beyond description goes to the QFHSA support staff, Donna Sauriol and Carol Ohlin, who keep all of the Directors on task and are a tremendous resource and support to the local home and schools. A special thank you to our Executive Director, Roch Gamache, who enthusiastically stepped into the job and handled several difficult portfolios in the first month, including filling in for the Treasurer who took a leave of absence in the fall.

Finally, I would like to say a special thank you to two very dedicated Home and Schoolers who have retired this year – Don Smith and Donna Norris. Their unfailing dedication to QFHSA over the years is, and will be, greatly missed.

EXECUTIVE DIRECTOR'S REPORT

Report to the Annual General Meeting – April 25, 2009 Submitted by Roch Gamache, Executive Director

In line with the strategic development plan that we submitted to the Board earlier this year, we are now in the midst of deploying a new organizational structure that will permit the QFHSA to increase its service offering to better serve local communities. In this context and acting on my recommendation to the Board of Directors, we have added a Director of Community Services to the organization's staff.

What's more, the QFHSA is currently working to institute a series of new programs that are in step with our community-focus. For instance, a service-learning program, which could serve as a possible strategy and program geared toward increasing student success and achievement, is currently being closely analyzed by our staff. Also noteworthy is the initiative to develop a Quebec-wide video conferencing system to enable our more remote regions to benefit from workshops and tools not always accessible to them.

It is important to mention that new collateral and promotional material will be available as we are now working on a new marketing-communications plan that will also provide local associations with various items including a "beginning of the year package" where each local president will be given tools to be used in the course of an H&S presentation that may be given during each member school's Annual General Assembly. Also, in the course of our communications strategy, our Leadership Building Campaign tour has begun and we hope to develop strong alliances with many Central Parents Committees and Governing Boards.

I have also undertaken the initiative of modernizing our website. By reorganizing and adding to its content, our goal is to create a space that better reflects who we are; a welcoming place where all our members and where the community at large, near and far, can come together, gather information and exchange on topics relating to our mandate. "QFHSA.org" will become our calling card in homes, schools and other Anglophone institutions. Within the next few weeks, an ftp access will be given to our members thus giving each and everyone the possibility of consulting and exchanging many documents pertaining to QFHSA activities and programs

Once the current challenges are met and the short list of priorities are addressed, we can begin working on the mid-term and long-term plans, which I can assure you include many more exciting projects that we will venture to undertake as we continue to focus on the QFHSA's innovation and growth to better serve our children and parental community. The framework for a review of our public affairs outreach strategy will be laid, the goal of which is to ensure we fully substantiate our role as advocate for Anglophone parents. Our goal is to strengthen our position as the body that is best poised to defend our community's rights and interests in matters relating to the education of Québec's young Anglophones.

HIGHLIGHTS

Communications and market research

- Over the course of the last months, I have met with many community organizations and private companies in order to develop co-marketing opportunities and partnerships.
- The strategic development plan outlines a marketing-communications strategy where new promotional and collateral material has been developed and is currently being produced.

- The Leadership Building Campaign Tour will strengthen our outreach geared towards parents involved within schools as we are recruiting new members from Governing Boards.
- QFHSA is now part of the Youth Count initiative.
- I am currently in the process of reviewing the QFHSA *NEWS* concept and looking at an integrated and multimedia approach.
- A database management strategy has been implemented and new technological tools have been acquired.
- Focus groups are being created in order to adapt the QFHSA service offering to its members needs.

Administration

- A new organizational chart and structure has been implemented for improved efficiency and a new director of Community Services is now part of the executive staff.
- A review of the liability insurance parameters is taking place.
- Daycare issue: QFHSA has actively supported its members by intervening in a dossier involving our members who faced legal challenges in a context of "after school services" involving the Commission des relations du travail du Québec, the CSN and the English Montreal School Board.
- Through approaches with organizations such as LEARN, we are seeking ways to implement a permanent regional structure that will provide local administrative support to our members.
- While consolidating QFHSA's relationship with its actual financial partners such as Canadian Heritage and MELS, I have been working on funding diversification using a project management approach targeting such potential partners as the Secrétariat à la jeunesse.

Community Services

- I have asked Harold Spanier to join the executive staff team and he is now acting as Director of Community Services.
- A new service offering including the currently offered programs and workshops will be presented to QFHSA members.
- Special pilot projects are being explored and preliminary development has been initiated:
 - Service Learning Program;
 - o Québec en forme;
 - o Promo Science;
 - Public Safety- Crime Prevention Program;
 - A cultural/sports related program (not yet public);
 - A series of workshops dedicated to integration and disciplinary issues within schools.

Advocacy and Public Affairs

- Work is being done in order to ensure QFHSA is formally recognized at MELS (Ministère de l'Éducation, du Loisir et du Sports) and the Secrétariat à la jeunesse du Gouvernement du Québec.
- Starting in 2010, QFHSA's AGM will host a public affairs plenary session and workshops where policy driven initiatives will be discussed and resolutions pertaining to public administration in the education field will be adopted.
- I am discussing various avenues with other groups such as the Anglophone parents of the FCPQ that could lead to strategic alliances where Anglophone youths' interests will be better represented.

AUDITORS' REPORT

To the Members of **QUEBEC FEDERATION OF HOME AND SCHOOL ASSOCIATIONS**

We have audited the statement of financial position of Quebec Federation of Home and School Associations (Federation) as at December 31, 2008, and the statements of changes in net assets, revenues and expenses and cash flow for the year then ended. These financial statements are the responsibility of the Federation management. Our responsibility is to express an opinion on these financial statements based on our audit.

Except as explained in the following paragraph, we conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we plan and perform an audit to obtain reasonable assurance whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation.

In common with many charitable organizations, the Federation derives revenues and contributions from various sources, the completeness of the non-government revenue and contributions are not susceptible to complete audit verification. Accordingly, our verification of these revenues was limited to the amounts recorded in the records of the Federation and we were not able to determine whether any adjustments might be necessary to revenues and net assets.

In our opinion, except for the effect of adjustments, if any, which we might have determined to be necessary had we been able to satisfy ourselves concerning the completeness of the nongovernment revenues and contributions referred to in the preceding paragraph, these financial statements present fairly, in all material respects, the financial position of the Federation as at December 31, 2008, and the results of their operations and their cash flow for the year then ended in accordance with Canadian generally accepted accounting principles.

NOTES TO FINANCIAL STATEMENTS

AS AT DECEMBER 31, 2008

1. NATURE AND PURPOSE OF THE ASSOCIATION

The Quebec Federation of Home and School Associations is an incorporated, independent, not-for-profit volunteer organization dedicated to enhancing the education and general wellbeing of children and youth. It promotes the involvement of parents, students, educators and the community at large in the advancement of learning and acts as a voice for parents.

2. ACCOUNTING POLICIES

a) Revenue Recognition

- i) Membership fees are received mostly in the Fall of each year and are taken into revenue over the period from the first of September to the following thirty-first of August.
- ii) Program funding and grants are received from Federal and Provincial agencies, the revenue from Federal agencies is taken over the donor fiscal year which is from the first of April to the following thirty-first of March. The revenue from the Provincial agency is from the Ministry of Education and is taken over the period from the first of September to the following thirty-first of August.
- iii) All other revenues are recognized when received.

b) Expensing Capital Purchases

The Association expenses all purchases of a capital nature.

c) Contributed Services

Volunteers at the Federation level contribute approximately 24,700 hours per year to assist the Federation in carrying out its activities. Because of the difficulty in determining their fair value, contributed services are not recognized in the financial statements.

2. ACCOUNTING POLICIES (Cont'd)

d) Use of Estimates

The preparation of financial statements in conformity with Canadian generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from these estimates.

e) Future Accounting Changes - Financial Instruments

In December 2006, the Canadian Institute of Chartered Accountants issued Section 3862, Financial Instruments - Disclosures and Section 3863, Financial Instruments - Presentation. These two Sections will be applicable to financial statements relating to fiscal years beginning on or after October 1, 2007. Accordingly, the Quebec Federation of Home and School Associations will adopt the new standards for its fiscal year beginning January 1, 2009. Section 3862 on financial instruments disclosures requires the disclosure of information about the significance of financial instruments on the entity's financial position and performance as well as the nature and extent of risks arising from financial instruments to which the entity is exposed during the period and at the balance sheet date, and how the entity manages those risks. Section 3863 on the presentation of financial instruments is unchanged from the presentation requirements included in Section 3861.

The Quebec Federation of Home and School Associations is currently evaluating the impact of the adoption of these new Sections on its financial statements.

3. FUNDS HELD IN TRUST

The Federation has funds in trust amounting to \$9,500. The donors have requested that the interest earned on the funds in trust be used to pay for awards given out at the annual general meeting. A committee is appointed to consider all submissions for the awards, and to choose the ones they consider best meet the guidelines.

Report to the Annual General Meeting – April 25, 2009 Submitted by: Marlyn Brownrigg, QFHSA CHSF Delegate

CHSF June 2008 Board Meeting and Annual General Meeting

The 2008 CHSF board meeting and Annual General Meeting took place at Sheridan College in Oakville, Ontario. The board members continued the strategic planning and marketing workshop started in November 2007. Goals are to increase the visibility of CHSF, update the website and logo, and develop new partnerships with other organizations. A resolution on a sex offender registry submitted by the Ontario Federation of Home and School Associations was adopted and the QFHSA resolution on firearms (adopted at the QFHSA AGM in April 2007) will be voted on this June.

Mid-Term Meeting November 2008

Due to the resignation of President Bev Mullin, Janet Walsh (N.S.) was installed as interim president until the AGM in June 2009. Cynthia Richards (N.B.) replaced her on an interim basis as Eastern Vice-President.

The "Drugwise" project with Health Canada has ended with the final audit still to be completed. This project was more successful in some provinces than others. The "Parenting the Net" project supported by Bell Canada has also finished and Cathy Wing of MNet is looking at how CHSF and the provinces can continue to use the materials at a reasonable cost. The June 2009 board meeting and Annual General Meeting will be held in Winnipeg, Manitoba.

<u>Varia</u>

As is the case with many volunteer organizations, CHSF is struggling financially and is looking for sustainable grants. Cost cutting measures were implemented at the November 2008 mid-term meeting. Some provinces are also finding it a challenge to pay the CHSF membership dues and to fund travel expenses for delegates. With fewer delegates at the board table the workload falls to fewer and fewer volunteers.

CHSF has been keeping the provinces informed on the changes to the copyright bill which is now slated for Fall 2009. The changes may adversely affect how schools can use materials especially those available on the web.

CHSF supported the Centre for Science in the Public Interest's policy on school nutrition.

COMMUNICATIONS Home & School NEWS Report to the Annual General Meeting - April 25, 2009 Submitted by the office

Mandate: The Editorial Board oversees the content of our newspaper and the website.

There were four regular issues published last year, of 16 pages each. Circulation has remained steady and the average paid distribution is 5,800; average total distribution of a single issue is 7,300. Local associations are welcome to have additional copies of our newspaper at no extra cost.

The local associations are asked to send in their own school news for inclusion in their section of the paper, *Focus on the Locals*. Even if you don't have a writer on your team, a copy of your own newsletter will enable us to let other parents know what exciting things are happening at your school and to "steal" any ideas that appeal to them. Diane Radu is Editor of *Focus on the Locals* and also judges the schools' newsletters for Newsletter Prize winners, given out at the AGM. In 2008 the winners were: Gardenview, Sherwood Forest and Macdonald High School. The school winners for 2009 are: Gardenview, Macdonald High School, Evergreen, Willingdon, and Edgewater.

The NEWS is grateful to our regular contributors: AMCAL Family Services, Marlyn Brownrigg and Barbara Schnider (Membership), Shirley Straughton (Health Issues), Don Smith (Safety Issues), Canadian Home & School Federation, and Debi Brown, QFHSA President. Our Margaret Funnell covers the West Island Networking Lunches with an array of family oriented topics. And, this past year, we've had contributions from Martha Farley, DM Family and School Services, Christine Clarke, Centre for Literacy, LEARN (Leading English Education & Resource Network) and Dorothy Nixon.

QFHSA would like to take this opportunity to thank Don Smith, our safety expert, for his <u>years</u> of contributions to our newspaper. He began his column in 1981 and has decided that he is not as up-to-date on safety issues as he once was. As a police officer, dealing with youth, he had a very unique and common-sense approach to many safety issues.

We also publicize the Terry Fox Run, Geordie Youth Theatre, Teacher/Staff Appreciation Week, The Gazette's Raise-a-Reader campaign, and the Quebec Literacy Foundation, as well as Family Literacy Day (January 27th).

This past year we had meetings with Michelle Courchesne, Minister of Education, reported on in April, and with Gordon Fraser, Commissioner of Official Languages, reported in the September issue. And we supported the families appealing Bill 104 with their legal expenses by organizing a donations campaign (June issue).

CONSTITUTION AND BY-LAWS Report to the Annual General Meeting – April 25, 2009 Submitted by Liette Chamberland, Chair

Mandate

- To ensure that the Federation's Constitution, By-Laws and Standing Rules allow a functioning organization;
- To vet the constitutions of local associations when submitted and to make suggestions for improvements or additions.

Activities 2008-2009:

During the course of the year, the Constitution and By-Laws Committee has looked at the possibility to change the Constitution and By-Laws "all in one format" to a Constitution that would stand on its own and would be separate from the By-Laws. The reasoning behind the change was brought up by the difficulties sometimes experienced by the local Associations at creating their own set of Constitution, By-Laws and Standing Rules.

Furthermore, when a new local Association is in the process of writing its official documents, the difference in the timeline for sending in the documents - Constitution within the first six (6) months, and By-Laws within the first two (2) years – it often results that, for as long as the By-Laws are not attached to the Constitution, the latter is invalid.

A first draft of amendments has been proposed and will be studied in depth over the course of the year 2009-2010.

The new changes, if accepted and approved at the next AGM, will in no way affect the official documents sent by the local Associations. It will only concern the new local Associations.

However, for those who would like to follow-up with the changes, workshops would be available to help them at understanding the concept of the different documents and in writing their own documents.

Consequently, new templates of each document would be offered to all local Home and School Associations.

At this time, there are no proposed changes to the Constitutions and By-Laws to be voted on.

Recommendation:

• That the QFHSA recruits assistance from at least 4 local Associations to review the first draft of proposed amendments.

EDUCATION COMMITTEE

Mandate:

The mandate of the QFHSA Education Committee is incredibly broad: it is to follow everything that is going on in education. Since this is not really feasible, it has adopted the following strategy:

- 1. To adopt priorities for the year, which include at least one "deliverable" (in other words, something tangible);
- 2. To review articles on education in La Presse, Le Devoir and The Gazette;
- 3. To have liaison members attend various committee meetings at the MELS and elsewhere;
- 4. To invite speakers to give presentations on various topics in education;
- 5. To be consulted by the QFHSA Board of Directors on education issues;
- 6. To prepare resolutions for the AGM.

Education Committee:

At the beginning of the year, the Education Committee has reviewed many different issues and concerns:

- Drop-Out rate
- Mainstream vs. Resources
- Ethics and Religious Culture Program
- Immersion
- Ratio Teacher / Children
- Textbook
- Teacher shortage

For lack of resources, the Education Committee has selected to examine closely the following issues:

- Textbook;
- Special Needs;
- French Second Language (originally Immersion).

Textbook Sub-Committee:

Sub-Committee members:

Liette Chamberland - Education Committee Liaison, Marion Daigle – Literacy Committee Liaison, Brian Rock – Rights Committee Liaison.

Activities:

The Science and Technology III text has been received as has the French version of the Cultural Math text (course replacing Math 416). The first volume of the English version arrived in January and subsequent volumes are set to come at a rate of two chapters per month. However, the teacher's guides with answers to the problems have not been received, making the teaching of the new math curriculum more difficult than it needs to be. There has been some backing off on deadlines for some Sec. V courses slated for compulsory implementation in Fall 2009. Leo LaFrance, Assistant Deputy Minister for English Services, MELS, has a set of short-to-long-term goals to follow which will ultimately have English and French texts published concurrently. In the long run, we need to push for these materials to be in the schools during the spring prior to the year of implementation.

The Sub-Committee is keeping up to date with this issue.

Special Needs Sub-Committee:

Activities:

In order to better orient itself, the Sub-Committee has concentrated its efforts at defining its views on different terms that are commonly used.

In the process, it has collectively adopted the following three-fold purpose of Education:

- First, to extend children's knowledge, experience and imaginative understanding, and their awareness of moral values and capacity for enjoyment;
- Second, to enable them to have the skills and abilities to apply them, in order to be active citizens and responsible contributors to society, capable of achieving as much independence as possible;
- Third, to develop an appreciation of life long learning.

Since then, this principle has been approved, and will become part of the Education Committee's mandate.

The remaining goals until the end of this term are to achieve a consensus on the following definitions:

- Mainstream;
- Inclusion;
- Integration;
- Special Needs.

The rationale of this exercise is to have a common understanding of these terms, thus enabling the Sub-Committee to better assess the concerns and make informed decisions.

French Second Language Sub-Committee:

Activities:

The Sub-Committee has studied the Immersion situation in New-Brunswick, since recently the Government of New-Brunswick had announced drastic changes to the Province's French Second Language Program. Two studies were examined: 1) PricewaterhouseCoopers LLP evaluation of the NB French Language Programs which was commissioned by the New Brunswick Department of Education in 2000, and 2) the February 2008 Report of the French Second Language Commission, <u>A Comprehensive Review of French Second Language Programs and Services Within the Anglophone Sector of the New Brunswick Department of Education which provide the background to the decisions taken last winter and also to the revised model, which feature an additional Grade Three Immersion entry level, announced in August, 2008. Several aspects of the studies and the Program decisions were discussed by the Sub-Committee: the consultation process, the context, their standards, the motivating concerns.</u>

This study was followed by many questions and concerns:

- a. Immersion and Streaming;
- b. Immersion and Special Needs Students;
- c. High School Retention;
- d. Exit Profiles / Expectations;
- e. Student Perceptions of their Second Language Capacity;
- f. Literacy, Readiness, Support;
- g. Content Subjects in French;
- h. Oral / Auditory Focus;
- i. Teacher training;
- j. Models of Delivery;
- k. Single, Double or Multiple Models;
- I. Social / Emotional Factors;
- m. Scheduling Concerns;
- n. Research.

The Sub-Committee agreed that the Education Committee propose a Resolution to the 2009 Annual General Meeting of the QFHSA:

Resolution 2009/01-French Second Language Programs in Quebec

Disposition of 2008 Resolutions

Following the adoption of the resolutions at the Annual General Meeting, French translations were done and bilingual versions, with covering letters, were mailed to the appropriate destinations.

- In September, Rickhey Margolese, Brian Rock, Roch Gamache and Debi Brown met with Christos Kritsidimas, political attaché for MNA Yolande James, Minister of Immigration and Cultural Identity, to discuss the resolution on *Wider Access to English Education*.
- In a letter dated September 3, 2008, the President of the Quebec English School Boards Association, Debbie Horrocks, responded to Resolution 2008/1 Wider Access to English Education.

"... QESBA has decided to seek to intervene before the Supreme Court of Canada in the Bill 104 case. Clearly, the future of our English public school system, so central to the future of our communities across the province, requires that the government of Quebec allow our schools to benefit from greater enrolment growth and stability. QESBA hopes to make that case before Canada's highest court in the coming months.

I would welcome the chance to meet with you to discuss this and other matters of mutual interest."

STATEMENT OF POLICY

The *Statement of Policy* is a compilation of the resolutions passed over the years by the Annual General Meeting. It complements the purposes and objectives of Quebec Federation of Home and School Associations. Following the AGM, it is up-dated each year as needed and copies distributed to the local associations. The 2009 *Statement of Policy* will reflect the resolutions passed in 2008 and 2009.

RIGHTS COMMITTEE

Report to the Annual General Meeting - April 25th, 2009 Submitted by Marion Daigle and Brian Rock, Chair

Mandate

QFHSA is concerned with the well-being of children and the cultural health of our community as a proper environment in which to raise them. Rights are not simply an abstraction. They define our obligations to and opportunities for our children. We, Home and Schoolers, have a history of pleading and defending the rights of all children and their parents. Parents should have the choice of the Official Language used in the education of their children.

Recommendation:

That the delegates to the 2009 AGM vote on Resolution 2009/2: English School Eligibility for Children of Parents with Serious Learning Disabilities

Activities

1. AGM 2008

> Resolution 2008/1 Wider Access to English Education was passed. In September, Brian Rock, Rickhey Margolese, Roch Gamache and Debi Brown met with Christos Kritsidimas, political attaché for MNA Yolande James, Minister of Immigration and Cultural Identity, in response to this resolution.

2. Bill 104 – Legal Defence Fund

> In December 2007 the Board of Directors set up a fund-raising campaign to give financial support to the 26 families who were seeking leave to appeal this law to the Supreme Court of Canada. The appeal was heard in December 2008. QFHSA received donations totaling \$1,345 which have been forwarded to Me Brent Tyler and his legal team, who are representing the families. QFHSA wishes to thank everyone who contributed to this fund.

- 3. June 13, 2008 - Special Meeting with Graham Fraser, Commissioner of Official Languages of Canada. There were four major topics under discussion:
 - Wider Access to English Education Rights Chairman Brian Rock presented the background to our Resolution 2008/1 and emphasized the conditions facing the Englishlanguage minority families related to schooling. Bill 104 - Mr. Fraser indicated he was studying a possible intervention.

- English Language High School Textbooks Rickhey Margolese, Education Committee, spoke about the difficulties facing both teachers and students who must wait for translations of curriculum materials, particularly at the Secondary 4 level – math, science and history.
- Funding for Minority Language Education and Second Languages Instruction Nick Zaferis, Rights Committee, gave a very descriptive over-view of the accountability measures, especially in the delay in the province's reporting to the federal government.
- Federal Court Challenges Program At the time of our meeting this program had been discontinued. It had allowed for
 Canadians of modest means to be given funding to bring meaningful cases to the
 Supreme Court of Canada. QFHSA had attempted to do this in 1983 related to Bill 101,
 but we were refused.
 - Mr. Fraser is very aware of the situation of Quebec's English population as a minority within a minority.

[Note: The Court Challenges Program has been re-instated, but with new terms.] This was a very productive meeting.

4. <u>Other</u>

Meetings held in October and November, 2008, dealt with research and study on the following:

- <u>Bill 88 The Law to Amend the Education Act</u> This refers mainly to school boards covering vast geographical areas. Of particular interest to Anglophones is the move to have school board chairmen elected directly by the general population, rather than by elected commissioners. This could be very costly.
- Quebec-Canada Agreements on Minority Language Education and Second Languages
 Instruction:

A sub-committee has been set up to study the upcoming protocols and agreements.

SAFETY/TRANSPORTATION

Report to the Annual General Meeting – April 25, 2009 Submitted by Don Smith, Resource

Mandate:To contribute information or articles for the "Safety Scene" in the Quebec
Home & School NEWS, and
To serve as a resource on current safety issues as they affect children and
students for the QFHSA Board of Directors.

Activities:

- Monitoring safety issues in transportation as well as safety programmes for children and schools.
- Regular contributions made to the Safety Scene page of our newspaper.
- On-going concerns with regard to gun control in Canada.

Topics covered this past year in our newspaper were:

Back to School – Safely – a reminder for parents and guardians. Summer Jobs – what you need to be a baby sitter. Pellet guns – potentially deadly, but not regulated.

Don also bid adieu to QFHSA at the end of December, saying that retirement had not brought more time to do things like *Safety Scene*, but had given him different responsibilities and that he did not feel he was on top of the topic as he had been. Don's career was as a policeman, usually involved with youth, and then he taught at the police academy in Nicolet for several years. We will miss his broad understanding of these important issues.
